PUBLIC COMMENT:

Mr. Ercolano from 19 Hillside Avenue, wanted to speak to Mr. Lott regarding the noise from his next door neighbor at 21 Hillside Avenue. Mr. Lott directed Mr. Ercolano to address the Board with comments/ concerns. Mr. Ercolano spoke about how the noise next door from the water heater has affected his life. Mrs. Avallone and Mr. Preston stated they have been in contact with Mr. Ercolano on an ongoing basis and are aware of the complaint. The initial noise complaint goes back many years, back to when the Madison Health Department's REHS had investigated.

Mr. Preston had listened to a recording of the trial on this matter; Mr. Lott was also aware of the previous trial which took place in November of 2013. The judge had dismissed the case because he felt the water heater was making normal noises, but Mr. Ercolano is still disturbed by it.

The Board and the Westfield Department of Health told Mr. Ercolano this is a matter that should be reconciled with the landlord/owner of the property.

Chatham Borough Board of Health Monthly Nursing Report December 2019

CHILD HEALTH CONFERENCE – There were three scheduled child health conferences in December; on 12/3/19, 12/16/19 & 12/17/19. No children from Chatham Borough were seen.

SAFE KIDS COMMITTEE - No meeting was held for the month of December.

SCHOOL GUIDANCE – Provided immunization guidance to the preschool director at the Chatham School House.

VACCINES FOR ADULTS (VFA) PROGRAM- The Vaccines for Adults Program continues to be offered. Vaccines currently available are: HPV, Tdap, Meningitis, Pneumonia, Shingles, Hepatitis A, Hepatitis B, MMR, Varicella & Influenza (in season). To be eligible, individuals must be uninsured. Interested persons should contact the Westfield Regional Health Department to determine whether the vaccine would be appropriate for them to receive.

For December 2019: 2 VFA vaccines were given for the month of December; none were residents of Chatham Borough.

VFA PROGRAM UPDATE - Contact continues to be made with local medical practices & organizations to educate physicians and staff regarding this program. Informational sheets with WRHD contact info are mailed out to different providers monthly. Practices & organizations are asked to please post &/or distribute this information which includes program criteria eligibility and immunizations available. LEAD EDUCATION – The Healthy Homes Community Outreach Worker presented family centered information at the December 3rd child health conference. A lead poisoning prevention display was set up for education. A community outreach worker discussed lead prevention information with the parents of clinic patients after their appointments. This included an interactive display featuring a cartoon dog having "dust" on him that is visible with the blue light attached above it. It shows how just a little exposure can cause lead.

AUDITS - An audit was conducted on the Chatham Middle School in Chatham Borough on 12/11/19. 327 6th grade & 33 transfer records were reviewed regarding immunization compliance. This audit revealed eight children were improperly vaccinated reflecting a compliance rate of 98%. Discussion with school nurse was done regarding benefits of all children needing to be vaccinated as well as exclusion practices. A re-audit will be conducted in January. Results of this re-audit will be forwarded to NJ State Vaccine Preventable Disease Program for follow-up investigation.

CHRONIC DISEASES - There were no chronic disease cases reported to the health department for Chatham Borough.

COMMUNICABLE DISEASES – There were three communicable disease cases reported to the health department for Chatham Borough.

- Lyme 11 year old male; presented with musculoskeletal symptoms, no known tick bite, WB IgG positive, treated with doxycycline antibiotic.
- Lyme 16 year old female; presented with musculoskeletal symptoms, no known tick bite, WB IgG positive, treated with doxycycline antibiotic.
- Influenza 91 year old female; presented with fever, headache, cough, chills, muscle ache; did not require hospitalization; received influenza vaccination in September.

12/5/19, 12:15pm, I received PD report that reads as follows:

On 12/5/19 ap approximately 1842 hours, patrol responded to N. Hillside Ave specifically near the baseball field at Memorial Park, for a reported dog bite.

Upon arrival, I made contact with the complainant, (AS), who was located in the batting cage area of the park with two of his leashed dogs. (AS) stated that while walking his dogs through the park two dogs, described as a boxer mix and a Shepard mix, ran up to his dogs and were acting rowdy. (AS) advised that he was concerned with the rowdiness and aggression therefore he separated his dogs from the other dogs by remaining in the enclosed batting cage area before calling the police. (AS) stated he is familiar with the dogs that ran up to him and advised they belong to his neighbor at 19 N. Hillside Ave.

While speaking with (AS), the two dogs running at large ran up to me and did appear rowdy and excited to be running through the field freely but did not appear vicious in nature. During my entire interaction, the dogs did not appear aggressive. At this time, I observed the owner of the unleashed dogs, Neal Collins, attempting to secure both dogs. the owner called the dogs by name of which neither dog reacted to at this time. shortly after, Neal was able to secure both dogs inside his residence.

While en route to speak with Neal, we made contact with an additional complainant, identified as Courtney Jent. Courtney stated that while walking her golden retriever in the direction of the park, (AS) advised for Courtney to stay back because there were two dogs running at large that appeared to be aggressive. Courtney then advised she began walking back in the direction of her residence and the and the loose dogs ran towards her. Courtney advised that she was concerned for her dog's safety therefore she ran to a nearby neighbor's porch and yelled for help. While on the porch, Courtney stated that one of the loose dogs, described as a boxer/mastiff mix, mauled her dog. Courtney stated the dog was aggressive and appeared to be viscous. Courtney also stated that she believed the dog may have bit her dog. It should be noted, her dog had a fabric covering on his body and she was unable to confirm if an actual bite took place.

Courtney informed me that while attempting to separate both dogs, she was unable to do so because of the dog's large size and aggressive behavior. At this time, Neal opened the front door of his residence and the dogs ran in his direction. Courtney then advised she was able to get back to her residence once the dogs left. Courtney stated that it did not appear that the boxer mix punctured her dogs skin but again stated that she was concerned for her and her sod's safety and the safety of other residents who have children residing on her street.

Patrol then spoke with Neal's wife, Maria Collins, who advised me that both dogs have been secured and that Neal had left for his son's basketball practice. Maria provided me with up to date vaccinations and dog licenses for both dogs. Maria was very apologetic and concerned about the incident that occurred. Maria stated that while checking her backyard to confirm a reason for the dogs escape, she found the gat in the backyard to be left slightly open. Maria advised that the opening of the gate may have been related to an ongoing civil case with her next door neighbor. Maria again advised that this has not happened before and the dogs are not aggressive or victious and remain enclosed inside the backyard while they are outside. There were no prior dog bite incidents connected to this address upon checking past cases on RMS for this case.

Neal was issued a Special Complaint Summons for borough ordinance 79-10.1, dogs in public places for having both of his dogs off leash, running at large in Memorial Park.

December 6th at 2:45pm I contacted the victim in a dog on dog, dog bite case (Case C05627384). The victim in this case was Courtney Jent 973-534-9192, 7 N Hillside Ave, Chatham. I spoke to her and she stated she would send in a statement and a copy of her dog's rabies vaccinations. I gave her the proper information to do so. I asked her if the dog was licensed and she stated she didn't think it was. I advised we would contact her if we needed any further information and advised she get her dog licensed as soon as she was able. Call ended. At 2:49pm I contacted the suspect dog owner Neal Collins 973-417-9475, 19 N Hillside Ave, Chatham. I spoke to him and his wife Mariah on speaker. I requested they send in a statement regarding the incident as well as a copy of their dog's rabies vaccinations. They stated they would after a very long conversation. I gave them the proper information to do so as well as the number for our office. They asked me about their dog being on a 10 day quarantine because the officer. They asked that as it was an incident had stated the dog needed to be quarantined. I advised that as it was an incident between 2 dogs that would not be necessary. They asked that I pass the information along so that they don't get in trouble for taking their dog for a walk despite what the officer told them. I advised I would have our office reach out to the health department to try to remedy this false information. They asked about waiting to send their statement until they get the police report. I asked about the dog's license and they stated the dog was licensed in Chatham. Call ended. I am requesting an email be sent to the health department regarding the owner that the dog needed to be quarantined. I am also requesting a letter be sent to Ms. Jent regarding licensing her dog. I double checked with her about any injuries to her dog and she stated that there were no bite marks so she didn't have any photos or medical records to send us. I thanked her. Call ended.
