Mayor Bruce A. Harris called the Regular Council Meeting of the Borough of Chatham to order on Monday, July 9, 2018 at 7:30 p.m. in the Council Chambers in Borough Hall, 54 Fairmount Avenue, Chatham, New Jersey.

SALUTE TO FLAG

Mayor Harris and the Borough Council led the assembled in the Pledge of Allegiance.

MOMENT OF SILENCE

Mayor Harris asked for a moment of silence for those who have given their lives for our country.

Council President Resto made a motion to approve Resolution #18-251. Council Member Collander seconded the motion. A vote was taken and Resolution #18-251 was approved unanimously.

RECUSALS

Mayor Harris asked if there are any recusals or abstentions to be submitted for the record with respect to any item listed on the agenda.

There were no recusals presented on the record.

DISCUSSION ITEMS

Shepard Kollock Park – Council Member Fife and Council Member Weber presented a proposal to designate an "off-leash" area at Shepard Kollock Park for dogs. The proposal includes installing a 400-foot long black-coated chain link fence to separate the "off-leash" dog area from the ballfields and the walking trail at Shepard Kollock Park. New signage posting the rules and regulations of use would also be installed.

Council Member Fife mentioned that the area proposed is not used for active recreation purposes and would be well-suited for this use since many dog-owners already use the area as an informal dog park. They both confirmed that the proposal has been endorsed by the Joint Recreation Committee, the Department of Public Works, the Police Department and the Borough Engineer. The cost of the fencing is estimated to be \$8,500.00, which includes installation. Funding for the project is available in the recreation budget, as well as the Historic Riverside Trail Grant.

Council Member Weber further stated that should the governing body approve the "off-leash" dog area, Ordinance #79-10 would need to be revised to permit this use. Since the area is already being used by residents as an informal "dog park," he said the ordinance permitting this use would also serve to limit the Borough's civil liability.

Mayor Harris questioned whether any consideration had been given to provide play areas for large and small dogs and mentioned that there may be differences in dog behavior between large and small breeds. He also inquired whether Parrot Mill Road residents have been notified of the proposal.

Council Member Weber responded that the area will not be a formal dog park but would be established to allow dogs to socialize, run around and exercise leash-free in a fenced-in area with other dogs. He and Council Member Fife said that many dog owners already use the area as an informal dog park and agreed that it would be in the best interest to provide a designated place to fulfill the needs of the dog owners and their dogs and the public. Ms. Fife also indicated that they had not discussed this proposal with residents of Parrott Mill Road.

Mr. Lott will confirm whether there are any Green Acres restrictions for the proposed use at Shepard Kollock Park and was asked to draft an appropriate ordinance.

Rozella Clyde, 33 Carmine Street, supported the proposal designating a leash-free dog area at Sheppard Kollock Park and encouraged the Council to consider making the area a formal dog park with benches, water, garbage cans and disposal bags for dog waste.

Seeing no one else wishing to comment, Mayor Harris closed the meeting to the public.

MyChathamNJ Advisory Committee - Council Member Fife reported the committee will be filing for not-for-profit incorporation and 501(c)(3) tax-exempt status.

Project Community Pride - Council Member Fife reported that she attended the presentation at the Madison Area YMCA.

Public Arts Council Advisory Committee - Council Member Fife reported that the Public Arts Council is pleased that the Borough gave preliminary approval on the proposed mural project for the Washington Avenue train underpass. The organization will be working on the mural design and will present the proposed mural design to the Mayor and Council for approval once finalized.

Senior Center of the Chathams - Council Member Fife had nothing new to report.

Environmental Commission - Council President Resto reported that he and Commissioner Van Wie attended the 2018 Sustainable Jersey[®] Summit on June 21st. He also reported that the next Environmental Commission meeting is scheduled for July 11th.

Historic Riverside Trail Advisory Committee - Council President Resto had nothing new to report.

Municipal Alliance of the Chathams - Council President Resto had nothing new to report.

Open Space & Historic Preservation Trust Advisory Committee - Council President Resto had nothing new to report.

Pilgrim Pipeline Advisory Committee - Council President Resto had nothing new to report.

Planning Board – Mayor Harris reported that the Stanley Congregation Church subdivision application will be before the Planning Board on July 18th.

Joint Municipal Court - Council Member Kobylarz had nothing new to report.

9/11 Memorial Advisory Committee - Council Member Weber had nothing new to report.

Board of Education - Council Member Weber reported that due to scheduling conflicts with the Borough's Council Meetings, he was not able to attend the June 11th nor the June 23rd Board of Education meetings but instead viewed the recorded videos of both meetings. He reported that at the June 23rd meeting the Board of Education discussed school security and Class III police officers.

Board of Health - Council Member Weber reported that the Board is in the process of reviewing and revising the Board of Health legislation in the Borough Code.

Joint Recreation Advisory Committee - Council Member Weber had nothing new to report.

Communications & Technology Advisory Committee - Council Member Kobylarz reported that the next meeting is scheduled for July 10th.

Historic Preservation Commission - Council Member Kobylarz reported that an intern project has been proposed to photograph the buildings in the historic district. He mentioned that the Commission is examining revisions to the Borough's Historic District Preservation ordinances and will be working more closely with the Chatham Historical Society. The next Historic Preservation Commission meeting is scheduled for July 19th.

Joint Community Gardens Advisory Committee - Council Member Kobylarz reported that the Committee will be repairing the garden fence in efforts to keep animals out of the garden plots.

Municipal Pool Advisory Committee- Council Member Kobylarz reported that 363 members have registered for the 2018 community pool season and that swimming lessons have begun.

MAYOR'S REPORT

Mayor Harris thanked the Chatham Fire Department Association for hosting the annual 4th of July parade, entertainment and fireworks display. He also mentioned that Congressman Frelinghuysen has informed him that the Chatham Post Office will be scheduling a Post Office Open House next month and mentioned that the event would be posted on the website once the date and time of the Open House has been confirmed.

Lastly, Mayor Harris reported that the Borough made 64 referrals to the Project Community Pride program in 2018. Forty-six referrals were made in 2017.

ADMINISTRATOR'S REPORT

Mr. Williams reported that the Municipal Alliance of the Chathams received a \$3,000.00 supplemental grant from the Morris County Board of Chosen Freeholders and further confirmed that the Borough's Letter of Intent has been submitted for the 2018 Morris County Trail Grant. Mr. Williams thanked the Chatham Fire Department Association for the 4th of July celebration. He then reported that JCP&L will be trimming trees in the Brooklake Road area and that JCP&L will be notifying property owners that may be impacted by the tree-trimming operations. Lastly, Mr. Williams mentioned that sections in the Borough experienced a brief power outage earlier in the day in the neighborhoods north of Main Street. The cause of the power outage was a tripped breaker at the Academy Street Substation near the Livingston Mall.

WHEREAS, in accordance with N.J.S.A 40A:11-12 of the Local Public Contracts Law, public bids are not required when the purchase of goods or services is made through a cooperative purchasing program; and

WHEREAS, bid specifications for the 2018 Road Micro-Surfacing Project were prepared by the City of Summit, acting as the lead agency in the Summit City Cooperative Pricing System #192SCCPS ("SCCPS"); and

WHEREAS, the Borough of Chatham is a member of SCCPS and realizes cost savings by purchasing services, equipment and materials through SCCPS; and

WHEREAS, the Director of Public Works recommends that the purchase of goods and services for the 2018 Road Micro-Surfacing Program be made through SCCPS to Asphalt Paving Systems, PO Box 530, Hammonton, NJ 08037 at the price of \$2.69 per square yard for a total cost in amount not to exceed \$65,000.00; and

WHEREAS, the Chief Financial Officer has certified that the maximum dollar amount of the contract shall not exceed \$65,000.00 and that funds are currently available for the purpose of awarding the contract and shall be encumbered from Capital Account #C-04-55-918-004.

WHEREAS, the Borough Engineer recommends that an award of the contract be made to M. Sky Construction Corporation, 830 Route 15 South, Lake Hopatcong, NJ 07849 in the amount of \$35,115.00; and

WHEREAS, the Chief Financial Officer has certified that the maximum dollar amount of the contract shall not exceed \$35,115.00 and that funds are currently available for the purpose of awarding this contract from General Capital Account #C-04-55-918-003.

BE IT FURTHER RESOLVED, the matter(s) discussed will be made known to the public at such time as appropriate action is taken on said matter(s), and when disclosure will not result in unwarranted invasion of individual privacy or prejudice to the best interests of the Borough of Chatham, provided such disclosures will not violate Federal, State or local statutes and does not fall within the attorney-client privilege. The Borough Council will not return to public session after this closed session.

Council Member Kobylarz made a motion to approve Resolution #18-261. Council President Resto seconded the motion. A vote was taken and the motion to approve Resolution #18-261 was approved unanimously.

ADJOURNMENT

Having no other business to be conducted in public session, Mayor Harris adjourned into Closed Session at 9:08 p.m.
