

REGULAR MEETING OF THE MAYOR AND BOROUGH COUNCIL

August 10, 2020 MINUTES

Mayor Thaddeus J. Kobylarz called the Regular Council Meeting of the Borough of Chatham to order on Monday, August 10, 2020 at 6:07 p.m. in the Council Chambers in Borough Hall, 54 Fairmount Avenue, Chatham, New Jersey.

Note: The start time of this meeting was moved from 7:30 p.m. to 6:00 p.m. to accommodate the emergency measures in place due to the coronavirus pandemic.

SALUTE TO FLAG

Mayor Kobylarz and the Borough Council led the assembled in the Pledge of Allegiance.

MOMENT OF SILENCE

Mayor Kobylarz asked for a moment of silence for those who have given their lives for our country. He also gave recognition to the following professionals during the existential health pandemic caused by the coronavirus, COVID-19: First Responders, EMS personnel, Police Officers, Fire Fighters, Office of Emergency Management (OEM), nurses, doctors, long-term care workers, home care workers, other medical personnel, local government professionals, employees and volunteers, and research scientists working diligently to develop a vaccine to combat the existing global health crisis and those afflicted by it. Finally, he acknowledged the passing of all nine (9) Chatham Borough residents who died during the current pandemic. May this community endure no more loss.

Mayor proceeded to read the following Proclamation:

Mayor's Proclamation

Honoring the 100th Anniversary of the 19th Amendment to the United States Constitution

WHEREAS, the bold, courageous, and powerful women who fought for ratification of the 19th Amendment to the United States Constitution on August 18, 1920, and its subsequent certification on August 26, 2020, deserve special celebration on the 100th anniversary of this noteworthy achievement; and

WHEREAS, New Jersey was the 29th state to ratify the 19th Amendment on February 9, 1920; and

WHEREAS, New Jersey holds a special place in women's suffrage history as thousands of New Jersey women advocated for the right to vote – in the streets, in the newspapers, in the state capital, and in numerous locations throughout the state; and

WHEREAS, the 19th Amendment did not actually guarantee suffrage for all women, including Native American women, who did not gain the right to vote until 1924; Asian and Pacific Islander American women, who did not do so until 1952; and both African-American and Latin-American women, who were frequently the victims of voter suppression until passage of the Voting Rights Acts of 1965 and 1975; and

WHEREAS, today, record numbers of women are now serving in local, state, and national government, and running for office in unprecedented numbers, as part of the legacy of these resolute American suffragists; and

WHEREAS, the 19th Amendment to the United States Constitution has played an important role in advancing the rights of all women; and

WHEREAS, we honor the role of ratification of the 19th Amendment in further promoting the core values of our democracy as established under the United States Constitution; reaffirm this opportunity to learn about, and commemorate, the efforts of the women's suffrage movement, and the role of women generally, in our democracy; and reaffirm our desire to continue to strengthen democratic participation, and to inspire future generations of Americans to cherish and preserve the historic precedent established under the 19th Amendment;

NOW, THEREFORE, I, Thaddeus J. Kobylarz, do hereby recognize, and ask all Chatham Borough residents to join me in recognizing, August 18, 2020, as the 100th anniversary of the passage and ratification of the 19th Amendment to the United States Constitution, thus providing for women's suffrage, and August 26, 2020, as the date of its official certification.

Council Member Resto moved to approve Resolution # 20-199, seconded by Council Member Weber. By a unanimous voice vote, Resolution # 20-199 was approved.

DISCUSSION ITEMS

Electric Vehicle Charging Stations:

Torri Van Wie, Joe Treloar and John Stuckey presented virtually on the implementation of an electric charging station within the Borough. Ms. Van Wie proposed the installation of electric charging stations at the Center Street West parking lot on the west side of the lot nearest Rotary Park. The lot area is desirable and unobtrusive. An electric charging station would be an enhancement to the amenities already offered in the Borough. It will further attract people to the downtown area to support local businesses.

Volta was the company proposed to offer electric charging stations in the Borough. The company provides free installation and free charging for both the Borough and the public's use.

Grant funding is available to support this purpose. A total of \$4,715,612.00 was allocated to help 213 projects. However, of the total amount allocated, only \$77,217.00 remains available. Ms. Van Wie encouraged the Borough to apply for funding as soon as possible.

The image of the charging station and the size that would fit appropriately within the Borough was explained by Mr. Treloar. The charging station offered by Volta is an elegant way to fuel an electric vehicle. It is built and operated free of cost and provides advertisement, stated Mr. Stuckey. Mr. Stuckey further explained how Volta works, from set-up to ongoing support.

MAYOR'S REPORT I:

Mayor Kobylarz delivered a portion of his Mayor's Report as follows:

Statistical Update on the Coronavirus:

Mayor Kobylarz reported five (5) new positives cases since July 20, 2020. The new infections were among teenagers, younger adults and older adults 17, 22, 24, 54 and 57 years-of-age. The viral reproduction rate is slightly above 1.0. Failure to wear proper facial coverings and practice social distancing and avoiding social gatherings will increase the spread of the virus. By adhering to these measures, it will facilitate in the fight against COVID-19.

Postponing Revaluation of Real Properties:

Mayor Kobylarz reported that the revaluation of all real properties in Chatham Borough has been postponed until 2021.

Hurricane Isaias:

Mayor Kobylarz expressed his discontent with how JCP&L handled the power outage in Chatham Borough. He further explained the challenging efforts to restore power. Governor Murphy and the Mayor of Madison, Robert Conley and Borough Administrator of Madison, Raymond Codey were acknowledged for their assistance in the process.

It was announced that the Borough may introduce an ordinance that requires newly constructed homes to bury electrical wires underground.

Mayor Kobylarz thanked each department for their tireless effort throughout the week and weekend since hurricane Isaias. He gave special acknowledgement to Police Chief Brian Gibbons, Lieutenant Ralph Colatrella, Sergeant Rick Jaremba, Fire Chief Jeffrey Fricke, OEM Coordinator Steven Davenport, OEM Deputy Coordinator Sam Francis, Director of D.P.W. Tony Torello and Borough Administrator Stephen Williams.

Mayor Kobylarz proceeded to open the meeting to public comment and read the Notice of Public Comment Time Limit.

Hearing of citizens during the Public Comment section of the Agenda is an opportunity for any member of the public to be heard about issues which are or are not matters scheduled for Public Hearing tonight. In light of the emergency, discussions and actions by the Chatham Borough Mayor and Council related to discretionary municipal actions and/or other non-emergent matters including redevelopment planning will be deferred until further notice. Accordingly, I would respectfully request that the public try to limit its comments to matters primarily related to the COVID-19 response and/or the continued operations of the Borough government during the emergency. While the Chatham Borough Mayor and Council welcome public participation and comment on any topic, to help facilitate an orderly meeting, and to permit all to be heard, speakers are asked to limit their comments to a reasonable length of time.

Rozella Clyde – 33 Carmine Street:

Ms. Clyde expressed her appreciation to the Mayor's ongoing support of the 19th Amendment and the women's suffrage movement. She further encouraged the Governing Body to consider purchasing electric vehicles for the use of certain departments in support of a sustainable environment.

Fran Drew – 32 Inwood Road:

Mrs. Drew commented that the 13 counties in New Jersey serviced by JCP&L were affected the worst from hurricane Isaias. Due to environmental changes resulting in more hurricanes, she recommended burying wires underground and discontinuing service with JCP&L.

Jack Drew – 32 Inwood Road:

Mr. Drew applauded the Mayor on how he handled his discontent with JCP&L and the unsatisfactory performance to restore power-outage during the aftermath of hurricane Isaias. He requested Mayor Kobylarz to communicate with Governor Murphy and urge the governor to create a state-wide program encouraging municipalities to bury their wires underground.

Seeing no one else wishing to be heard, Mayor Kobylarz closed the meeting to the public.

MAYOR'S REPORT II

Mayor Kobylarz had nothing further to report.

ADMINISTRATOR'S REPORT

Mr. Williams thanked the Governing Body for their assistance in the preparation of the 2020 Municipal Budget, adopted on July 13, 2020 and the adoption of tonight's capital budgets. He expressed gratitude to the Administrator in Madison Borough, Raymond Codey, the Borough's Mayor, Robert Conley and Assistant Administrator, Jim Burnet. He acknowledged two gentlemen from JCP&L whom he worked closely with to facilitate in the restoration of power in Chatham Borough. The men and women of JCP&L worked tirelessly during the aftermath of hurricane Isaias and their efforts are appreciated. Lastly, he thanked the Chatham Borough Police Department, Fire Department, Office of Emergency Management (OEM) and the Department of Public Works (DPW) for their assistance, as well as the residents of the Borough for their patience during the restoration process.

Mr. Williams warned residents to be cautious of down wires and urged them to treat downed wires as if they were live wires.

The D.P.W. began removing debris on Wednesday morning, and will continue to do so until all is gone. For residents wishing to drop off debris themselves, the Mulch Area is open from 8:00 a.m. to 4:00 p.m.

In concluding his report, Mr. Williams clarified the concerns of algae at Kelly's Pond. The pond is covered in duckweed, watermeal and cattail, not algae. The D.P.W. is currently working on this matter.

RESOLUTION OF THE MAYOR AND BOROUGH COUNCIL OF THE BOROUGH OF CHATHAM, COUNTY OF MORRIS, NEW JERSEY, APPOINTING AGAPITO GUZMAN AS A CLASS II SPECIAL LAW ENFORCEMENT OFFICER

WHEREAS, the temporary waiver for the SLEO II position will expire at the expiration of the Public Health Emergency and Agapito Guzman will automatically revert to his previous status as a Class III SLEO; and

WHEREAS, upon the recommendation of the Chief of Police, the Mayor and Borough Council desire to formally appoint Agapito Guzman as a SLEO II, subject to approval by the Police Training Commission, in order to increase available manpower in the Department during the Public Health Emergency and beyond; and

WHEREAS, the Department will continue to assign a SLEO to provide security to the School District of the Chathams in accordance with the agreement between the Borough and the School District of the Chathams Board of Education; and

WHEREAS, the statutory limitation on the number of hours a SLEO may work is not applicable during periods of emergency in accordance with N.J.S.A. 40A:14-146.16a(2); and

WHEREAS, in addition, in accordance with N.J.S.A. 40A:14-146.16c, the Borough may designate one SLEO to whom the limitation on hours a SLEO may work does not apply; and

WHEREAS, the Mayor and Borough Council wish to designate Agapito Guzman, in the position of SLEO II, as the SLEO to whom the limitation on hours does not apply in accordance with N.J.S.A. 40A:14-146.16c; and

WHEREAS, Agapito Guzman shall be paid a salary of \$35.00 per hour when assigned to work as a SLEO II by the Chief of Police or his/her designee.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Borough Council of the Borough of Chatham, in the County of Morris and the State of New Jersey that Agapito Guzman is hereby appointed as a Class II Special Law Enforcement Officer (SLEO II) without any limitation of hours in accordance

with N.J.S.A. 40A:14-146.16c, subject to approval by the Police Training Commission, and in accordance with terms and conditions of this Resolution.

BE IT FURTHER RESOLVED, that all Borough officials and employees are hereby authorized and directed to take all action necessary and appropriate to effectuate the terms of this Resolution.
