WHEREAS, last year the Susan G. Komen For The Cure[®] North Jersey Race for the Cure[®] brought together thousands of women, men and children from northern New Jersey and beyond, and raised over 1 million for the North Jersey service region to help fund breast cancer research and provide local community life-saving education, screening and treatment services; now

- **WHEREAS**, she was elected to the Morris County Board of Chosen Freeholders in 1972; and,
- **WHEREAS,** she was selected as Morris County Freeholder Director in 1976 and was President of the New Jersey Association of Counties in 1978, both "female firsts"; and
- **WHEREAS**, in 1980, she won a special election to an unexpired term in the New Jersey General Assembly and was re-elected the following year, serving until 1983; and
- **WHEREAS,** in 1983, she ran for the Republican nomination for State Senate in the 26th Legislative District and became the first Republican woman ever to serve in the upper house of the State Legislature; and
- **WHEREAS**, after 10 distinguished years as a New Jersey Senator, she was appointed in 1993 to the New Jersey Casino Control Commission in Atlantic City; and
- **WHEREAS,** throughout her career, Leanna Brown has worked tirelessly for improved transportation, fiscal responsibility, emergency preparedness, affordable housing, and international trade; and
- **WHEREAS**, she has been a champion of openness and opportunity for all, encouraging others to accomplish their "impossible dreams"; and
- **WHEREAS,** Leanna Brown has made it a priority throughout her career to mentor, champion, and bring into public service many talented people, including (but not limited to) over 100 interns, many of whom hold key leadership positions today; and
- **WHEREAS,** Leanna Brown was appointed to serve on the President's Commission on White House Fellows from 2007 to 2009; and

WHEREAS, she has chaired the New Jersey Advisory Committee of the U.S. Commission on Civil Rights; and

WHEREAS, Leanna Brown has served ably in the international arena, including participating in the U.N. Conference Against Racism in Durban, South Africa; serving as a delegate to the 2001 Forum of Non-Governmental Organizations; and serving as a US delegate to the 2008 Global Summit of Women in Hanoi, Vietnam; and

WHEREAS, Leanna Brown has shown tremendous business acumen by serving as a Director on the Board of Chatham Trust Company, serving on the National Advisory Committee of the U.S. Small Business Administration, and chairing Brown Global Enterprises; and

WHEREAS, Leanna Brown has hosted a Cable T.V. show (Upbeat NJ), where she interviewed hundreds of New Jersey's key players, and continues to write a syndicated column by the same name for Recorder Community Newspapers; and

WHEREAS, she serves on the State of New Jersey Council on Local Mandates; and

WHEREAS, Leanna Brown symbolizes the epitome of "family values" by having devoted her life to her beloved late husband, Stan, her children and her grandchildren, including taking them on worldwide trips and expeditions; and

WHEREAS, we are proud and fortunate that Leanna Brown has lived in Chatham Borough for over 50 years; and

WHEREAS, it is evident that Leanna Brown will continue to serve her community for many years to come; and

Chatham Downtown Alliance-Mr. Britt stated the Alliance began last fall. The purpose is to attract people to the downtown. There are approximately 87 retail establishments in town; 40 merchants are currently members. They have a website chathamdowntown.com and will soon have a Facebook page. The Alliance held several events last fall and plan to expand the events this year.

CAF Gala-Mr. Ivans reported their fundraiser was held at Reasoner Park last year and was a great success. CAF would like to hold the same event on September 28, 2013. There will be a resolution to approve the event at the next meeting.

Fishawack- Mr. Tomaino, President of Fishawack Inc. asked the Council's permission to hold the festival on June 8, 2013 from 10 a.m. to 6 p.m. The event last year raised approximately \$9, 000.00 which will be donated to the Fire Department, Police Department, Emergency Squad, Senior Center, Library, 9/11 Memorial and the Chamber of Commerce; they also award one \$1,000.00 scholarship to a high school senior for community service work.

2013 Goals & Objectives- Mr. Falzarano explained the purpose of having goals and objectives. Mr. Falzarano received information from the Council Members and Department Heads. Mr. Falzarano explained the goals and objectives for 2013.

Chatham Clean-Up-Mrs. Fife reported they would like to have a clean-up similar to what Madison does on May Day each year. It will be held on April 20th 8 a.m. to 1 p.m. The Town and Country Garden Club will organize the clean-up. They would like to get the scouts and schools

involved to clean up and put mulch down in the gardens and parks in the Borough. The Environmental Commission Trail Clean up is scheduled for the same day.

2014 Parking Fees- Mr. Lonergan explained the annual parking rate in the Borough is low compared to surrounding towns. The proposed 2014 rate would be \$425.00 a year a increase of \$5.00. At the next meeting the Committee will discuss fees for daily parking and the smaller parking lots.
