The Regular Council Meeting of the Borough of Chatham was held on Monday April 22, 2013 beginning at 7:30 p.m. in the Council Chambers, in the Municipal Building.

The meeting was called to order at 7:32 p.m.; Mayor Bruce A. Harris presiding.

The Borough Council saluted the flag.

Mayor Harris asked for a moment of silence for those people who have given their life for this country and for the victims of the Boston bombing.

Mayor Harris read the following Proclamation.

PROCLAMATION PARENTS WHO HOST LOSE THE MOST

WHEREAS, adults who provide alcohol to those below the legal drinking age of 21 are placing those youth at risk for health, safety and legal problems; and

WHEREAS, alcohol use by young people is dangerous, not only because of the risks associated with acute impairment, but also because of the threat to their long-term development and well-being; and

WHEREAS, it is illegal to give or allow your teen's friends to drink alcohol in your home, even with their parents' permission; and

WHEREAS, anyone found guilty of providing alcohol to youth can face up to a \$1,000 fine and six months in jail, in addition to any civil action that can be brought as a result of damages or injury related to the offense; and

WHEREAS, adults have the authority and responsibility to our youth to provide them with alternative opportunities by creating alcohol free activities; and

WHEREAS, Drug-Free Action Alliance, through the "Parents Who Host, Lose The Most: Don't be a party to teenage drinking" campaign provides the educational materials to raise community awareness regarding this illegal and unhealthy practice; and

WHEREAS, the Borough of Chatham encourages residents to refuse to provide alcoholic beverages to underage youth and to take the necessary steps to discourage the illegal and unhealthy practice, including the reporting of underage drinking by calling their local police.

BE IT RESOLVED, that the Borough of Chatham not only discourages the use of alcohol by those below the legal age of consumption but also exhorts all residents of Borough of Chatham to refuse to provide alcoholic beverages to those underage youth, and will continue to take the necessary steps to discourage this illegal and unhealthy activity; and

BE IT FURTHER RESOLVED, I, Bruce A. Harris, Mayor of the Borough of Chatham, State of New Jersey do hereby proclaim, the period of May 23 through the month of June 2013 to be: "Parents Who Host, Lose The Most: Don't be a party to teenage drinking" Month 2013.

RESOLUTION #13-180 RESOLUTION TO PROMOTE ERMINIO TORELLO TO THE POSITION OF DEPUTY PUBLIC WORKS DIRECTOR

WHEREAS, the position of Deputy Public Works Director is vacant; and

WHEREAS, the Mayor and Borough Council have decided to select and appoint a Deputy Public Works Director; and

WHEREAS, the Personnel Committee has conducted interviews with qualified candidates; and

WHEREAS, after the completion of the interviews the Personnel Committee has submitted a recommendation to promote Erminio Torello to the position of Deputy Public Works Director; and

WHEREAS, Erminio Torello was appointed in August 1989 by the Chatham Borough Council to the position of Roads and Parks Laborer; and

WHEREAS, Erminio Torello has held various positions including Water and Sewer Laborer; and

WHEREAS, Erminio Torello was promoted in August 1999 to serve as Lead Person/Water Operator; and

WHEREAS, Erminio Torello is a licensed Certified Public Works Manager, T-2 Water Treatment Operator, W-2 Water Distribution Operator, C-2 Sewer Operator and New Jersey Compost Operator; and

WHEREAS, Erminio Torello has demonstrated that he is qualified and possesses the experience that is necessary to fulfill the duties and responsibilities assigned to the Deputy Public Works Director.

BE IT RESOLVED, by the Mayor and Council of the Borough of Chatham in the County of Morris and State of New Jersey that Erminio Torello is promoted to the position of Deputy Public Works Director effective April 23, 2013, at an annual salary of \$101,490 to be prorated for the remainder of 2013.

RESOLUTION #13-181 RESOLUTION TO ADOPT COUNCIL MEETING MINUTES

BE IT RESOLVED, by the Mayor and Council of the Borough of Chatham that the minutes from the following meeting are approved as typed and filed in the Borough Clerk's office:

Council Meeting, April 8, 2013

Council Member Lonergan moved Resolution #13-181, seconded by Council Member Holman. A vote was taken and it was approved unanimously.

RESOLUTION #13-182 RESOLUTION SUPPORTING S-1896/A-1503 SHARING THE BURDEN OF PROPERTY ASSESSMENT APPRAISAL REFUNDS

WHEREAS, when County Tax Board appeals are successful, the municipality must reimburse the property taxpayer 100% of the appealed tax levy, which includes the municipal, school, county and any special districts tax; and

WHEREAS, the municipal tax collector must then adjust the taxpayer's fourth quarter tax bill, resulting in the municipality's fund balance for the preceding year being diminished, if not completely depleted; and

WHEREAS, in recent years, municipalities have experienced a large spike in tax appeals caused by the economic down-turn, which lowered property values and placed increased stress on the income of homeowners all around our Garden State; and

WHEREAS, successful tax appeals have a four-fold negative impact on municipal budgets; first by requiring the municipality, as the collector of taxes for the School district, county and special districts, to fund the full cost of the legal defense of the assessments; and

WHEREAS, the second negative impact on municipal budgets results from State law, which guarantees to the county and the school district 100% of their levies, hence forcing the municipality to bear the full cost of any reimbursements resulting from the appeal, as well as the full burden for any uncollected taxes; and

WHEREAS, the third negative impact on municipal budgets ensues because the refunds and credits negatively impact the municipality's tax collection rate, resulting in a State required increase in the appropriation for the Reserve for Uncollected Taxes (a non-exempt from cap budget expenditure); and

WHEREAS, fourth, the end result is a further decline in the property tax base used to support municipalities, county governments, school systems and any fire or other special purpose districts, which will necessitate tax rate increases to raise the same amount of revenue; and

WHEREAS, in light of the revenue limitations that have been placed on all levels of local government by the Legislature (2% cap), such declining values will compound and add additional stress to local public officials, as they grapple with the issues confronting the tax paying public.

WHEREAS, Senator Anthony R. Bucco, Assemblyman Michael Patrick Carroll and Assemblyman Anthony M. Bucco have recently introduced Senate Bill S-1896/Assembly Bill A-1503, which requires fire districts, school districts, and county governments to share in burden of property assessment appeal refunds;

BE IT RESOLVED, by the Mayor and Council of the Borough of Chatham hereby urge the swift passage and signing of S-1896/A-1503; and

BE IT FURTHER RESOLVED, that copies of this Resolution be forwarded to New Jersey Governor Christie, to Senate President Sweeney, to Assembly Speaker Oliver, to our State Senator, to our two Representatives in the General Assembly, and to the New Jersey League of Municipalities.

Council Member Fife moved Resolution #13-182, seconded by Council Member Collander. A vote was taken and it was approved unanimously.

DISCUSSION ITEM

Board of Education Budget- Dr. LaSusa thanked everyone for voting to pass the budget and for the support he receives from the Borough. Dr. LaSusa stated the district's enrollment from 2001 to the present has grown by 40%. Currently the High School has 1,156 students; in the next seven years they expect that to grow to 1,400 students. Last year they did not add staff at the High School. This year they will add staff. The district tries to keep class sizes to 25 or less students. This year they will invest in extracurricular activities. The Board of Education will add four classrooms to the High School; the approximate cost will be \$2.7 million.

Relay for Life- Tony Britt stated Relay for Life will have an event "Paint the Town Purple" on Wednesday May 1st from 3 p.m. to 7 p.m. They will be placing purple ribbons on trees and lamp posts around the Borough. On Saturday May 18th from 12 p.m. to 4 p.m. there will be an information table set up at the gazebo. There are a few businesses in town that will donate part of their sales to "Relay for Life". That information will be available at the gazebo.

Capital Projects Update- Mr. DeNave reported the DOT will install the crosswalks across main street; they were removed when they repaved Main Street. Kings Road paving will include: crosswalks, sidewalks and some traffic calming devices. Shepard Kollock Park drainage improvements will be done in the end of June. Watchung Avenue sidewalks; approval has been received from Verizon, the county has removed the trees that were in the way of the sidewalk. The freeholders have to pass a resolution approving the sidewalk. Mr. DeNave stated the project will be started in late May. The 2013 curb and sidewalk bid will be advertised May 13th and the work should begin by the end of June. The road resurfacing which is done through the Morris County cooperative will start as soon as school gets out; there will be seven roads done. The DOT flashing lights for Coleman and Main Street have been approved. The DOT Maintenance Division will install the lights. Drainage improvements will be done on Coleman Avenue and Center Street

Community Garden- Mr. DeNave gave an update on the locations being considered for the Community Garden. Mr. DeNave will update the Council at the next meeting.

Main Street No Passing Zone- Mr. DeNave stated a letter was sent to the Borough by the DOT requesting Borough approval to create a no passing zone on Main Street from the Madison border to Garden Avenue.

John O'Neil of 30 Red Road runs the boys lacrosse program which is a K-8 program 1,200 boys and girls participate. Mr. O'Neil stated the location of the lacrosse wall at Lum Field is a good location for the Borough children. It is centrally located.

Hilary Renna the High School lacrosse coach stated the lacrosse wall would be a great benefit to the high school lacrosse team; just 30 to 45 minutes of practice a day greatly improves a player's stick work and overall ball handling.

Tony Calandra, the boys head coach at the High School is in support of the lacrosse wall.

Paul Galavente, President of the Cougar Lacrosse Club is in support of the lacrosse wall.

Mary Kate O'Neil, captain of the High School girl's lacrosse team stated she is in support of the lacrosse wall.

Ed DiFiglia of 177 Hillside Avenue stated that allowing residents to park overnight on the street could create a problem when there is a snow storm. He suggested designating a parking lot that could be cleared of snow and park the cars there until the roads are cleared.

Mayor Harris closed the meeting to the public.
