REGULAR COUNCIL MEETING September 23, 2013 7:30 p.m.

The Regular Council Meeting of the Borough of Chatham was held on Monday September 23, 2013 beginning at 7:30 p.m. in the Council Chambers, in the Municipal Building.

The meeting was called to order at 7:30 p.m.; Mayor Bruce A. Harris presiding.

The Mayor and Borough Council saluted the flag.

Mayor Harris asked for a moment of silence for those people who have given their life for this country.

RESOLUTION #13-319 RESOLUTION TO ADOPT COUNCIL MEETING MINUTES

BE IT RESOLVED, by the Mayor and Council of the Borough of Chatham that the minutes from the following meeting are approved as typed and filed in the Borough Clerk's office:

Council Meeting, September 9, 2013

Council Member Helfrich moved to approve Resolution #13-319, seconded by Council Member Fife. A vote was taken and Resolution #13-319 was approved unanimously.

DISCUSSION ITEMS

Breast Cancer Awareness- Mrs. Gulla explained the "Pink Fridays Campaign". October is breast cancer awareness month. Mrs. Gulla stated the employees would wear pink every Friday in October. On Friday Oct. 25th if they donate \$5.00; which would be donated to a local organization that supports cancer research, they would be able to wear jeans that day. She asked the Council if the Chatham Borough employees could participate. The Council agreed.

Capital Project Update- Mr. DeNave updated the Council on the capital projects. The projects that have been completed include: 2013 curb and sidewalk, Shepard Kollock Park drainage project, Watchung Avenue sidewalks, all the road resurfacing projects except Center Street; which will be done on a day when school is not in session. The majority of the drainage improvements have been completed. The lacrosse wall is complete. The blinking light on the corner of Washington Avenue and Chatham Street should be operational by the end of this week. The Kings Road project and the replacement of the roof on Borough Hall will begin next Monday. DPW and private contractors have begun work, leveling and spreading leaf mulch at the Community Garden site. The fence will be moved from the former garden site to Woodland Park. An environmental study is being done at DPW. The DEP requested that an oil tank removal project done 20 years ago be closed; it was never closed out at the time. The Main Street lighting report is complete and will be given to the Council for their review. Mayor Harris will speak to someone at the State to try and expedite the installation of the pedestrian light at Coleman Avenue and Main Street.

Leak Detection Report- Mr. DeNave reported the leak detection company listened to each of the water valves in the Borough and they believe there are only two water leaks. One is in front of Borough Hall and the other across from Stanley Park on River Road.

The Council Members discussed the problem at Shepard Kollock Park with dogs running off leash; and where a dog park could be located.

Parking Fines/Time Limit Parking (Update)- Mr. Falzarano stated the Long Range Traffic and Pedestrian Safety Planning Committee (TAPS) will meet on October 1st to discuss time limit parking in neighborhoods, parking limits at Fire House Plaza and Post Office Plaza and options for permit holders when the lots are full. They will have recommendations for the Council and hope to introduce revisions to the currentordinance at the November 11th meeting.

Mr. Collander stated the TAPS Committee will focus on several issues including residents, contractors and guests parking in front of residents homes.

Mayor Harris opened the meeting to the public.

Tom Ercolono of 19 Hillside Avenue had complaints about a gasoline generator in his neighborhood that runs continuously. He would like the Council to pass an Ordinance restricting generator use only during emergencies. He would also like the Council to investigate direct vent furnaces and water heaters to restrict the venting to the back of the property.

Sally Myers of 31 Girard Avenue thanked everyone who helped get the sidewalk installed on Watchung Avenue.

Mayor Harris closed the meeting to the public.

SECOND READING ORDINANCE PROCEDURE

Mayor Harris asked the Clerk to give a summary of the legal notice.

The Clerk stated: That due to the error on the part of the Chatham Courier newspaper in publishing the required notice of introduction, this ordinance needs to be carried to the next Council Meeting which will be held on Tuesday, October 15, 2013.

Council Member Fife moved to carry Ordinance #13-18 to October 15, 2013. Seconded by Council Member Collander. A vote was taken and approved unanimously.
