# REGULAR MEETING OF THE MAYOR AND BOROUGH COUNCIL

## November 9, 2015 MINUTES

Council President Gerald Helfrich called the Regular Council Meeting of the Borough of Chatham to order on Monday, November 9, 2015 at 7:30 p.m. in the Council Chambers in the Municipal Building, 54 Fairmount Avenue, Chatham, New Jersey.

#### SALUTE TO FLAG

Council President Helfrich and the Borough Council led the assembled in the Pledge of Allegiance.

#### MOMENT OF SILENCE

Council President Helfrich asked for a moment of silence for those who have given their lives for our country. He noted that Wednesday is Veterans' Day and asked for a moment of silence to remember all veterans who have served our country.

Council Member Collander welcomed the new firefighters to the Chatham Borough Volunteer Fire Department and expressed his personal appreciation for their service to the community.

Council President Helfrich and all Members of the Borough Council applauded the three new firefighters and, on behalf of the Chatham Borough community, thanked each of them for their service.

Council President Helfrich proceeded with Resolution #15-333.

Council Member Lonergan made a motion to approve Resolution #15-333. The motion was seconded by Council Member Holman. A voice vote was taken and Resolution #15-333 was approved by three affirmative votes. Council Member James Lonergan and Council Member Alida Kass were absent at the October 13<sup>th</sup> Closed Session meeting and voiced their abstention on voting on the October 13, 2015 Closed Session minutes. Council Member Collander, Council Member Fife and Council Member Kass were absent at the October 26<sup>th</sup> meeting and voiced their abstention on voting on the October 26, 2015 minutes.

### **DISCUSSION ITEMS**

**2016 Leaf Collection** – Tony Torello reported that the Department of Public Works has begun the second round of leaf collection in zones 3 and 4 and would progress to zones 5 and 6 next week. He reported that the last round of leaf collection would take place the week of November 23<sup>rd</sup> and reminded everyone that leaves should not be placed at the curb after November 23<sup>rd</sup>.

Based upon resident feedback, Mr. Torello proposed some changes to next year's leaf collection program. He proposed that the leaf collection program begin two weeks later, commencing on the week of October 24<sup>th</sup> and ending the week after Thanksgiving, which would include final leaf collection in the first week of December. Mr. Torello further proposed to eliminate the leaf collection pick up schedules and instead use three DPW crews with equipment to collect leaves simultaneously throughout the Borough. Eliminating the leaf collection zone scheduling would allow the Department of Public Works to double the number of leaf collection pickups from three (3) to six (6) throughout the Borough. Mr.

Torello mentioned that crews would be able to prioritize equipment and personnel resources to better respond to those areas requiring immediate leaf collection instead of following a set schedule. He also noted that crews could move more quickly collecting smaller piles of leaves rather than collecting massive leaf piles that accumulate and pack down over the 2-3 week period of the next scheduled pick up. Mr. Torello commented that personnel from the department's Utility Division and Fleet Services Division would be utilized to assist in leaf collection operations when needed. Lastly, Mr. Torello proposed that in 2016 the Department of Public Works would conduct an end-of-season leaf bag collection during two Tuesday's in the month of December.

Members of the Council expressed their approval to the proposed changes to the 2016 Leaf Collection program and thanked Mr. Torello and the Department of Public Works for their efforts.

2016 Fees: Recreation, Water, Sewer, Solid Waste Collection and others — Council Member Lonergan reported that the recreation clubs have done a good job in controlling program fees and any proposed fee increase would be referred to the Joint Recreation Advisory Committee for its review and recommendation. Secondly, Council Member Lonergan reported that a two percent (2%) rate increase would be in effect next year for water and sewer. The rate increase would help generate surplus funds needed for future infrastructure improvements. Lastly, Council Member Lonergan reported that the Solid Waste Collection Services base bid came in at a higher rate than anticipated, requiring the need to increase the solid waste collection fee to cover the increase in costs over the 5-year contract period.

Mr. Falzarano further reported that certain ancillary user-based fees would be increased in 2016 and would be comparable to fees being charged in neighboring towns. He mentioned that many of these fees, such as liquor licensing, have not been increased in several years. Mr. Falzarano commented that he would circulate the draft fee resolution to the Mayor and Council in the next few weeks.

**Monuments and Memorials Policy Update** – Council Member Fife reported that two requests for memorial benches are on hold pending approval of the Borough's Monuments and Memorials Policy.

Council President Helfrich confirmed that the Monuments and Memorials Policy has been clarified to mandate that the Borough would be obligated to maintain, repair or replace a monument or memorial once approved by the Borough Council and expressed his support.

Council Member Collander and Council Member Lonergan agreed with Council President Helfrich and voiced their support contingent, however, that a provision be included in the policy that allows future governing bodies to amend the Monuments and Memorials Policy, and subject to the Borough Attorney's review, in the event the obligation for the Borough to maintain, repair or replace an approved monument or memorial becomes a financial burden to the municipality. The Members of the Council concurred and voiced their agreement.

Council President Helfrich asked that an authorizing resolution adopting the Monuments and Memorials Policy be placed on the November 23<sup>rd</sup> agenda for Council consideration.

Council President Helfrich closed the discussion and proceeded with Public Comments.

#### MEETING OPEN TO THE PUBLIC

## NOTICE OF PUBLIC COMMENT TIME LIMIT

Hearing of citizens during the Public Comment section of the Agenda is an opportunity for any member of the public to be heard about issues, which are/are not topics scheduled for Public Hearing tonight. To help facilitate an orderly meeting, and to permit all to be heard, speakers are asked to limit their comments to a reasonable length of time.

Council President Helfrich opened the meeting to the public. Seeing no one wishing to comment, Council President Helfrich closed the meeting to the public.

#### REPORTS

#### COUNCIL COMMITTEE REPORTS

**Budget and Finance** – Council Member James Lonergan reported that the Finance Committee is on schedule with the 2016 budget process.

**Long Range Traffic & Pedestrian Safety Planning -** Council Member James Collander requested Council input on the how the Borough could address scooter and motorcycle parking at the train station, which are utilizing bicycle slots and sidewalks for parking. He informed the Council that New Jersey Transit has begun parking enforcement on its property and has issued parking tickets to repeat offenders.

Council Member Collander suggested that the Borough might be able to create additional scooter and motorcycle parking in the south parking lot and the north parking lot without an impact on existing car spaces.

After brief discussion, the Council agreed that the Borough should investigate parking options at the train station to accommodate scooter and motorcycle parking. The Council also agreed that a modest annual fee for scooter and motorcycle parking could be charged. Council Member Collander and Mr. Falzarano would continue to investigate parking options for scooters and motorcycles and work with New Jersey Transit to address commuter parking concerns.

**Public Safety & Emergency Services -** Council Member James Collander reported that the committee has been reviewing the Police Department's organizational structure relative to the state's Attorney General Guidelines concerning internal affairs and investigative issues and has recommended adding the position of Police Captain. Superior officers in the police department would include Chief, Captain, Lieutenant, and four Sergeants.

**Personnel -** Council Member Victoria Fife reported that the committee has been busy reviewing the 2016 salary ordinance, employment contracts, and the police department restructuring. The committee had been also reviewing employee job descriptions and evaluating a request to add a new position to the Borough's administrative staff.

Public Works Planning - Council Member John Holman had nothing new to report.

**Shared Services & 3<sup>rd</sup> Party Agreements -** Council President Gerald Helfrich had nothing new to report.

#### MAYOR'S REPORT

Mayor Bruce Harris congratulated Mr. Resto and Mr. Hoffman on their election to the Borough Council. He further reported that he has begun working on the Reorganization Agenda and mentioned there would be several appointments to be made to the boards, commissions and advisory committees. Mayor Harris encouraged residents to submit their volunteer applications for consideration and asked the Borough Clerk to distribute the listing of appointments expiring at the end of the year for the Borough Council's review and information.

### ADMINISTRATOR'S REPORT

Mr. Falzarano reported that the Chatham Borough Police Department received the AAA Award for zero fatalities in 2014. He further reported that a letter was received from a Borough resident thanking the Department of Public Works for their excellent work and professionalism shown to concerned residents

regarding a drainage improvement project on Coleman Avenue East. Lastly, he advised that the 2016 budget would be ready for Finance Committee distribution in 2-3 weeks.

Council Member Lonergan added that the Chatham Jaycees would be holding its annual Christmas Tree Sale later this month through December and are looking for volunteers to help with tree sales. Anyone wishing to volunteer their time to help are encouraged to contact the Chatham Jaycees.

Council President Helfrich asked Council Member Holman to proceed with Resolution #15-334.

**WHEREAS**, bid proposals were received from B&B Disposal, LLC and Suburban Disposal, Inc. and were publicly opened by the Borough Clerk and Borough Attorney on October 20, 2015; and

**WHEREAS**, the bid proposals and accompanying documents were reviewed by the Borough Attorney to ensure compliance with all statutory, regulatory, and Bid Specification requirements; and

**WHEREAS**, the Mayor and Borough Council have determined that it is in the best interests of the Borough and its residents to award the base bid as set forth in the Bid Specifications; and

**WHEREAS**, it was determined that the bid submitted by Suburban Disposal, Inc., 54 Montesano Road, Fairfield, NJ, is the lowest responsive and responsible bidder with an aggregate base bid of \$1,498,000 and base bid for each contract year as follows:
