#### **DISCUSSION ITEMS**

Sunshine Striders Fun Run – Ms. Kelly Leach, a Borough resident, presented a proposal to host a children's 1-mile Sunshine Striders Fun Run, on Saturday, October 3<sup>rd</sup>. from 3:30 p.m. to 7:00 p.m. Proceeds from the fundraising event will be donated to Cycle for Survival, a 501c3 charity that supports pioneering research and clinical trials at Memorial Sloan Kettering Cancer Center. Ms. Leach, herself as a cancer survivor, reported the race course would be a 1-mile loop that includes Dellwood Avenue, Fairview Avenue, Washington Avenue, and Longwood Avenue. Participants would be kids of all ages and their parents. Following the event, there will be bounce houses, face painting and other activities for participants to enjoy. Ms. Leach sought permission to close a section of Dellwood Avenue following the Sunshine Striders Fun Run to accommodate the after race activities and was informed she should submit a Block Party Permit Application to close the street.

Mr. Falzarano reported that insurance, permitting and other logistical details would be handled by the Department of Community Services.

Mayor Harris thanked Ms. Leach for her presentation and told her that an authorizing resolution would be prepared for the September 14<sup>th</sup> meeting.

**Doing Business in Chatham** – Ms. Janice Piccolo, Director of Community Services, presented a draft informational piece entitled "*Doing Business in Chatham Borough*," which will help guide individuals and companies that are interested in Chatham through the process of opening a business in the Borough and navigating zoning and permitting requirements. The user-friendly format includes a brief history of the Borough, demographics, and transportation networks, as well as, land use zoning information, parking and Borough department contact information. Prior to publishing the handout and posting the information on the Borough's website, Ms. Piccolo requested input from Mayor Harris and the Borough Council. Council Member John Holman applauded Ms. Piccolo for creating the informational piece.

**Tree Windshield Survey** – Mr. Tony Torello, Department of Public Works Deputy Director and the Borough's Shade Tree Enforcement Officer, presented an overview of the Tree Windshield Survey prepared by the Borough's Certified Tree Expert, John Linson, on July 8, 2015. The report lists six tree maintenance categories and includes the number of Borough street trees classified in each category: Class II Pruning (52), Class III Pruning (63), Class IV Pruning (7), Stump Removal (9), Special Attention (5), and Tree Removal (78). Mr. Torello reported that the windshield survey did not include trees located in parks, fields or pathways. Tree maintenance will be performed in the order of importance. Of the 78 trees identified for removal, 33 trees have since been taken down.

Mr. Torello also reported that at the Borough's request, Mr. Linson was asked to evaluate the scarlet oak tree located in lower Lum Field. In his evaluation report dated July 15<sup>th</sup>, Mr. Linson reported the oak tree has an internal cavity approximately 24" in diameter and there is evidence of fungal decay at the roots and carpenter ant activity. Based on a 12-point risk rating scale, with 3 being the lowest risk and 12 being the highest risk, Mr. Linson rated the tree a "7." His report concluded that "Although the evidence of decay and carpenter ant activity is a concern, however, in my opinion, if these conditions are addressed and activity beneath the tree is restricted, the risk the tree poses can be maintained at an acceptable level for years to come."

Mr. Torello further reported that a second independent inspection and evaluation of the oak tree was performed by Certified Tree Expert Joe Kunkel at the request of the Shade Tree Commission on August 3<sup>rd</sup>. In his report, Mr. Kunkel concluded that "*Trees are living organisms that fail in ways we do not fully understand. Conditions are often hidden within trees and below ground. Arborists cannot guarantee that* 

a tree will be healthy or safe under all circumstances or for a specified period of time. Likewise, any mitigation cannot be guaranteed."

Lastly, Mr. Torello reported that lower Lum Field is used throughout the year by many youth recreation sports programs, community activities, and the Farmers' Market, and is also used as a pathway for commuters going to and from the train station. He stated it was his opinion, that it would be difficult for the Borough to stop or restrict these activities.

Mayor Harris mentioned that the Borough requested a third evaluation of the oak tree using resistograph technology and inquired as to the findings of that report. Mr. Falzarano responded that a formal report had not yet been received, but expected to receive the report in the next day or two.

Based on the reports prepared by the Certified Tree Experts, Mayor Harris expressed his concern that the Borough is faced with having a tree that is not in great shape in a popular area used by many children and adults. The risk to public safety is a real one that must be addressed. Mayor Harris further reported that he and Council Member Kass and Mr. Lott spoke with the Shade Tree Commission to express the Borough's public safety concerns. Mayor Harris informed the public that under state law a Shade Tree Commission has exclusive control over Borough trees. By transitioning the duties of the Shade Tree Commission to a Shade Tree Advisory Committee, the Council could take control of the public safety issue that exists. Mayor Harris reminded the public about the tree that suddenly fell in Summit, as well as, the tree that fell without warning in Millburn, killing a motorist. He stated that measures must be taken to ensure public safety at all times.

Council President Helfrich stated that until the third tree expert report is received and the results of the resistograph are fully known, he was hesitant to make any decision.

Council Member Holman agreed with Council President Helfrich and stated the Council needs more information and time to make a sound decision.

Council Member Fife stated she was concerned with children playing around the oak tree since the tree expert's recommendation was to restrict access beneath the tree. She agreed with Mayor Harris that proactive measures must be taken in the interest of public safety.

Council Member Kass stated two questions must be decided: (i) should the oak tree be removed or not; and (ii) who has the final decision on whether the oak tree is to be removed - the Council or the Shade Tree Commission. She stated that although the statute provides that the Shade Tree Commission has jurisdiction Borough trees, she noted that the Shade Tree Commission does not have the authority to restrict access or activities on Borough property.

Mayor Harris reiterated his concern that someone may be harmed and that the public safety risk posed by the oak tree is great.

#### MEETING OPEN TO THE PUBLIC

#### NOTICE OF PUBLIC COMMENT TIME LIMIT

Hearing of citizens during the Public Comment section of the Agenda is an opportunity for any member of the public to be heard about issues which are/are not topics scheduled for Public Hearing tonight. To help facilitate an orderly meeting, and to permit all to be heard, speakers are asked to limit their comments to a reasonable length of time.

Mayor Harris opened the meeting to the public.

Jack Drew, 32 Inwood Road, inquired whether the Mayor and Council would move the discussion of Ordinance #15-11 immediately after the Public Comment period.

Patrick Carroll, 163 Hillside Avenue, Chair of the Shade Tree Commission, voiced his opposition to Ordinance #15-11, which proposes to abolish the Shade Tree Commission of the Borough of Chatham and transfer the duties assigned to the Shade Tree Commission to a newly formed Shade Tree Advisory Committee, and questioned the need to have placed the proposed Ordinance on tonight's agenda. Mr. Carroll commented that the Shade Tree Commission follows the advice of its certified tree expert in the management and care of Borough trees. He further commented that Mr. Linson, the Shade Tree Commission's certified tree expert, advised the Commission that the scarlet oak tree located in Lum Field could be treated and pruned to extend the tree's longevity. Mr. Carroll informed the Mayor and Council that the Shade Tree Commission requested further clarification from Mr. Linson regarding his risk assessment of the tree and why it was his recommendation to restrict access under the tree. Mr. Carroll further informed the Mayor and Council that the Shade Tree Commission sought a second independent evaluation on the tree from Mr. Kunkel, a certified tree expert. Mr. Kunkel concluded that there was no reason to remove the tree if minor maintenance is performed. In closing his comments, Mr. Carroll assured the Mayor and Council that the Shade Tree Commission would never compromise the safety of the community in favor of saving a tree and welcomed a mutual dialogue with the Mayor and Council regarding their concerns about the maintenance and management of Borough trees.

Mayor Harris inquired whether Mr. Carroll would allow his children to play under the oak tree, especially after reviewing Mr. Linson's recommendation that benches should not be installed near the tree, trash receptacles should be relocated away from the tree, and activities where people might linger under the tree or seek refuge from a storm should be discouraged. Mr. Carroll responded that he had no reservation whatsoever.

Mayor Harris stated that Ordinance #15-11 had been placed on the agenda to allow for Council discussion on first reading.

Samuel Sealy, 23 Edgewood Road, commented that he is a life-long resident of the Borough and shared a story of playing under the tree when he was in the 4<sup>th</sup> grade and injuring himself on a brass memorial plaque that was installed on the east side of the tree. The memorial plaque is long gone but the tree continued to grow. He further commented that he learned that 1 in 30 oak trees in New Jersey are scarlet oaks. Further, knowing that the Borough's scarlet oak is approximately 175 years old, makes it a special tree. Mr. Sealy thanked the volunteers of the Shade Tree Commission for their service to the community and voiced his support for the continued pruning and maintenance of the tree.

Brendan Keating, 2 Garden Place, introduced himself as a Member of the Environmental Commission but clarified that his comments are made as a private citizen. He commented that the scarlet oak tree is a landmark tree and has a natural allure that attracts people to it. He voiced his support for the preservation of the scarlet oak tree and further expressed his support for the Shade Tree Commission.

Roseann Mariziti, 50 Inwood Road, inquired why the Mayor and Council did not invite Mr. Linson to attend tonight's meeting to address their questions and provide clarification regarding his report. Ms. Mariziti supported the preservation of the oak tree and supported the purpose and continued operation of the Shade Tree Commission.

Fran Drew, 32 Inwood Road, commented that during the July 21<sup>st</sup> meeting of the Shade Tree Commission, Mr. Linson reported that the scarlet oak could survive 20-30+ more years if treated and pruned. She commented that the Shade Tree Commission agreed to follow the tree expert's recommendation to treat the tree for ants and prune the limbs. Ms. Drew suggested that a decorative fence be installed to restrict access around the tree in the interest of guarding public safety if that is truly

a concern. Ms. Drew inquired why the Mayor and Council did not invite Mr. Linson to attend tonight's meeting to address any questions or concerns they may have regarding his report. Lastly, she expressed her disappointment that the Mayor and Council have threatened to abolish the Shade Tree Commission if it did not take down the tree.

Mayor Harris responded that the issue surrounding the tree is one of public safety, not liability. He again stated that he and Council Member Kass and Mr. Lott spoke with the Chairman of the Shade Tree Commission to express the Borough's public safety concern because of the potential risks associated with tree. By transitioning the duties of the Shade Tree Commission to a Shade Tree Advisory Committee, the Council could take control of public safety issues that may arise.

Ken Fekete, Lafayette Place, introduced himself as a member of the Shade Tree Commission and its former Chair. He commented that during the recent Shade Tree Commission meeting, Mr. Lott informed the Commissioners that the Mayor and Council were concerned about the risks the tree poses and immunity issues relative to the Shade Tree Commission and the Borough.

Kristy Chumra, 4 Meadow Road, commented that the benefits of trees far outweigh their risks and further commented that the world is full of all sorts of risks. She voiced her support for the preservation of the scarlet oak tree and further expressed her support for the Shade Tree Commission.

Colleen Truppo, 10 Overlook Road, introduced herself as a member of the Shade Tree Commission and stated she brought her family to attend tonight's meeting so that they may witness how government works. Ms. Truppo commented that at the last Shade Tree Commission meeting, Mr. Lott discussed concerns regarding immunity protections and the Tort Claims Act. She opined that abolishing the Shade Tree Commission would do nothing to address public safety. Ms. Truppo voiced her support that the Shade Tree Commission follow the recommendations provided by the two certified tree experts in caring for the tree.

Mr. Lott responded that during the recent Shade Tree Commission meeting he expressed his concern as Borough Attorney to liability issues arising from known risks posed by hazardous trees and advised that a municipality has an obligation to ensure public safety.

Julie Muller, 51 Broadview Terrace, voiced her support to save the scarlet oak tree and suggested that preserving the 175-year old tree presents an excellent opportunity for the Borough to educate children on the importance of environmental stewardship and conservation, as well as, teaching the importance of public safety. She urged the Council to reject Ordinance #15-11.

Susan Allan, 167 Fairmount Avenue, commented that trees beautify a community and require periodic maintenance and care. She expressed her support to save the scarlet oak tree and presented a photograph featured in a tree service company's calendar showing a 500-year old tree with an attractive fence installed around its circumference.

Denise Mortensen, 5 Penn Terrace, read Joyce Kilmer's short poem titled, "Trees."

Linda Howe, former Borough resident, introduced herself as Certified Master Tree Steward, a Rutgers Cooperative Extension program that trains citizens in the conservation of trees. She commented on the tangible and spiritual benefits of trees. Ms. Howe voiced her support for the Shade Tree Commission and urged the Council to reject Ordinance #15-11.

Madison Roos, 8 Garden Avenue, inquired how many trees in Chatham, if any, have fallen and injured people over the years and further inquired why the Mayor and Council question the work performed by

the Shade Tree Commission. She also questioned whether the Mayor and Council were willing to obtain the certification many of the Shade Tree Commissioners have obtained.

Sandy Roos, 8 Garden Avenue, commented that the New Jersey Shade Tree and Community Forestry Assistance Act provides tree-related liability protection to communities, ensuring that Shade Tree Commissions can remain in place to provide more livable communities through the care and management of trees. Ms. Roos voiced her support for the preservation of the scarlet oak tree and further expressed her support for the Shade Tree Commission.

Jeff Truppo, 10 Overlook Road, inquired why Mr. Linson was not invited to tonight's meeting to answer questions Borough official may have regarding the scarlet tree. He urged the Council to remove Ordinance #15-11 from the agenda until they have had an opportunity to review all the data from the tree evaluations.

Joe Mikulewicz, 9 Chatham Street, introduced himself as a member of the Planning Board and a former Council Member but clarified that his comments are made as a private citizen. He inquired why the Mayor and Council placed Ordinance #15-11 on the agenda instead of adding the discussion of the Shade Tree Commission as a Discussion item. He also commented that the Council liaison to the Shade Tree Commission should be an advocate for the Commission.

Mayor Harris responded that his administration embraces transparency and by adding Ordinance #15-11 to tonight's agenda allowed for full disclosure and Council discussion.

Andy Zagoren, 30 Lum Avenue, commented that it is regrettable that the Ordinance proposing to abolish the Shade Tree Commission was placed on the agenda because the Mayor and Council do not agree with the Shade Tree Commission's decision to treat and maintain the scarlet oak tree. Mr. Zagoren then commented that Lum Field is being overdeveloped and as a result of the continued improvements and use of Lum Field, Lum Avenue residents are burdened with more noise and congestion. He voiced his opposition to Resolution #15-272, which would approve the installation of artificial turf at Lum Field.

Emily Melander, 157 Washington Avenue, commented that the scarlet oak tree is a lovely landmark and should be saved. She further voiced her support for the Shade Tree Commission and opposed Ordinance #15-11.

Seeing no one else wishing to comment, Mayor Harris closed the meeting to the public and asked if the Council had any comments.

Council President Helfrich stated that he would like to remove Resolution #15-272 from the Consent Agenda for Council discussion.

Mayor Harris reminded the Council that a member of the public had asked if the Council would move Ordinance #15-11 for discussion after public comment and asked for a motion.

Council President Helfrich responded that before a motion is made to move Ordinance #15-11 on the agenda, he sought to clarify a few points relative to the scarlet oak tree. First, he assured that appropriating funds to treat and prune the tree never was a deciding factor relative to whether the tree should be preserved or taken down. Secondly, he stated that the Council had not made a decision to take down the tree or to abolish the Shade Tree Commission and stated the conference call among Mayor Harris, Council Member Kass, Mr. Lott and Shade Tree Commission Chairman Carroll had not been

fully-reported back to the Council because the Council did not have an opportunity to meet until tonight's meeting. He further commented that two Council Members are not present at tonight's meeting and should take part in the Council's discussion. He recommended that Ordinance #15-11 be removed from the tonight's agenda.

Council Member Fife, Council Member Holman and Council Member Kass agreed with Council President Helfrich that Ordinance #15-11 should be pulled from tonight's agenda.

Mayor Harris stated a motion would be needed to alter tonight's agenda to move Ordinance #15-11 for Council discussion at this time.

Council Member Fife made to alter the agenda to move Ordinance #15-11 for Council discussion at this time. The motion was seconded by Council President Helfrich. A voice vote was taken with all Council Members present voting in favor.

Ordinance #15-11 was moved for Council discussion at this time.

Council Member Kass and Council Member Holman requested that Resolution #2015-272 be removed from the Consent Agenda for discussion and vote.

#### **RESOLUTION #2015-272**

# RESOLUTION AUTHORIZING THE INSTALLATION OF ARTIFICAL TURF AND NETTING AT LUM FIELD

WHEREAS, the Joint Recreation Advisory Committee advised that there is a need to create designated recreation space for training and skill development for youth soccer, as well as, other youth recreational sport programs; and

**WHEREAS**, the Joint Recreation Advisory Committee presented a proposal to the Mayor and Council recommending the installation of a 40' by 70' artificial turf space enclosed with netting adjacent to the lacrosse wall on Lum Field to be used for coaching instruction and skills development, alleviating the need to schedule field use otherwise needed for games and practice meets; and

**WHEREAS**, the funds to install the artificial turf and netting will be paid for by funds received from the Chatham Athletic Fund, Chatham Youth Soccer, and the Recreation Trust Fund Account.

**BE IT RESOLVED,** by the Mayor and Borough Council of the Borough of Chatham that they hereby approve the installation of a 40' by 70' artificial turf space enclosed with netting adjacent to the lacrosse wall on Lum Field; and

**BE IT FURTHER RESOLVED,** that all other Borough officials and employees are hereby authorized and directed to take all action necessary and appropriate to effectuate the terms of this Resolution.

Mayor Harris opened Council discussion on Resolution #2015-272.

Council President Helfrich stated he is typically in favor of improvements that benefit Borough recreation programs, but not in instances when the proposed improvements present greater burdens on area residents. He stated that he has concerns about the proposed project, which have not been answered, and said he would not be in favor of the proposed improvements at Lum Field at this time.

Council Member Holman stated that the Borough has limited land and facilities and commented that field improvements should always be welcomed. He voiced his support for Resolution #2015-272.

Council Member Kass stated that any opportunity to improve the efficiency of the use of recreation

fields at no cost to taxpayers should be supported and voiced her support for Resolution #2015-272.

Mayor Harris reminded the Council that the youth soccer program has been using that portion of Lum Field.

Mayor Harris closed Council discussion on Resolution #2105-272.

# ORDINANCE FOR FIRST READING

Mayor Harris asked Council President Helfrich to introduce Ordinance #15-10.
