Council Member James Lonergan moved to approve Resolution #15-250. The motion was seconded by Council Member James Collander. A voice vote was taken and Resolution #15-250 was approved unanimously.

#### **DISCUSSION ITEMS**

**Scout Project** – Mr. Jack Dean, an Eagle Scout candidate from Troop #8, presented his Eagle Scout Service Project proposal, which will consist of building a 8' by 8' shed for the Chatham Community Beekeepers to store apiary equipment and installing a series of three rain barrels fitted to collect rain water from the gutters for watering of the bee gardens. The project would begin in the month of August. The project's beneficiary is the Chatham Community Beekeepers. Mayor Harris indicated that the project would require the approval of JCP&L and stated he would forward the Eagle Scout Service Project proposal to JCP&L's attention. An authorizing resolution will be included on the August 10<sup>th</sup> agenda.

**Scout Project** – Mr. Mark Castellano, an Eagle Scout candidate from Troop #8, presented his Eagle Scout Service Project proposal, which will consist of mapping the locations of storm basins, outflows and storm water manholes in the Borough using GPS technology. The project will address Tier A Municipal Storm Water General Permit requirements for storm water quality compliance. The Eagle Scout candidate will work with the Borough Engineer and Department of Public Works in completing the GIS mapping, which is scheduled to be completed in the month of August. An authorizing resolution will be included on the August 10<sup>th</sup> agenda.

**Lum Field Soccer Practice Area** – Mr. Jim LeMon, Chair of the Recreation Advisory Committee, and Mr. Wes Zeliff, President of the Chatham Athletic Foundation ("CAF"), presented a proposal to install a 40' by 70' artificial turf soccer field next to the lacrosse wall for soccer coaching clinics and skills and drills instruction. Field netting would be installed at the perimeter of the new field to prevent soccer balls from running into the parking lot. The project would be funded by CAF donations, Recreation Trust funds and soccer program funds.

**Municipal Pool Update** – Mr. Jim LeMon, Chair of the Memorial Pool Committee, and Ms. Julianne Muller, member of the Memorial Pool Committee, presented a membership and financial report update for the Memorial Pool. Mr. LeMon reported pool membership has decreased for the second consecutive year. Membership for the 2015 season decreased 19% from the previous year and pool revenues are down 27%. Mr. LeMon further reported that although pool revenues are projected to exceed expenses for the season, half of the \$20,249 debt allocation and the \$7,320 salary allocation for the Recreation Coordinator's salary would not be covered. A survey was conducted of past members to ascertain why they did not renew memberships for the municipal pool this year. Respondents cited their families joined other pools, moved out of town or had other summer plans as reasons for not renewing memberships.

Mr. LeMon recommended that the end of the season reduced membership rate plan initiated last year for the month of August should be reactivated again this year. Last year the end of the season reduced membership rate attracted 11 new members and added \$700 in additional revenue for the 2014 season.

Council Member James Lonergan suggested the Borough may need to market the municipal pool to residents. Council Member Victoria Fife agreed and further suggested that the Community Services Department could be tasked with initiating a marketing campaign to help increase pool membership for the 2016 season.

## MEETING OPEN TO THE PUBLIC

### NOTICE OF PUBLIC COMMENT TIME LIMIT

Hearing of citizens during the Public Comment section of the Agenda is an opportunity for any member of the public to be heard about issues which are/are not topics scheduled for Public Hearing tonight. Mayor Harris opened the meeting to the public.

Mike Cerick, 24 Lum Avenue, voiced his objections on the proposal to install an artificial turf field at Lum Field and opposed any increase use of Lum Field by the Borough's recreation programs. Mr. Cerick then inquired why the scarlet oak tree located at the eastern end of Lum Field will be taken down. Mayor Harris informed Mr. Cerick that the Borough's forester performed an evaluation of the tree and found the tree has a 24" hollow cavity and evidence of root decay. Mayor Harris commented that the trees that recently fell in Summit and Millburn give warning to Borough officials to ensure that Borough trees are sound and pose no known risk to the safety of residents.

Joe Marts, former Mayor of Chatham Borough, commented that the Mayor and Council are taking the right steps by having the forester evaluate the health and integrity of the oak tree in Lum Field to minimize the risk to residents. Mr. Marts also thanked the Borough workforce for their efforts in preparing for the July 4<sup>th</sup> parade and fireworks, which are sponsored each year by the Fire Department.

Seeing no one else wishing to speak, Mayor Harris closed the meeting to the public.

## ADMINISTRATOR'S REPORT

Mr. Robert Falzarano reported that the Solid Waste Collection Services Bid was advertised July 23<sup>rd</sup> with a returnable bid opening date of September 23<sup>rd</sup>. Mr. Falzarano further reported that his office sent a letter to New Jersey Department of Transportation Commissioner Jamie Fox, and to Morris County Administrator John Bonanni, seeking to meet with state and county representatives to discuss the feasibility of locating one or more interchanges on Route 24, as well as, widening Route 24 from exit 7 to the Columbia Turnpike interchange. Mr. Falzarano informed the Mayor and Council that tax bills will be mailed to out Tuesday, July 28<sup>th</sup>. He lastly reported that the county began the milling and paving of Watchung Avenue, which is scheduled to be completed this week.
