Council Member John Holman moved to approve Resolution #15-190. The motion was seconded by Council President Gerald Helfrich. A voice vote was taken and Resolution #15-190 was approved unanimously.

DISCUSSION ITEMS

Capital Projects Update – Mr. Vince DeNave provided a brief status report of capital projects. He reported the dugouts and sprinkler system at Shepard Kollock Park have been completed and in the coming week the fence contractor will install the fencing for the backstop and batting cage. Final landscaping is anticipated to be completed within the next two weeks. Mr. DeNave also reported that M. Sky Construction Corporation was the lowest bidder for the 2015 Curb and Sidewalk Program bid. A resolution awarding the contract is included on tonight's agenda for Council action. The Curb and Sidewalk Program will get underway immediately with new curbing being installed on Kimball Street later in the week. It is anticipated that all curb and sidewalk improvements will be completed before school opens in September.

Mr. DeNave further reported that the Borough's road resurfacing projects have been awarded to Tilcon under the Morris County Cooperative Pricing Council program and are scheduled to begin in the month of June. In addition to the road resurfacing projects, drainage improvement projects have begun on Talmadge. Mr. DeNave confirmed that drainage improvements are scheduled to be completed on Cornell and Yale this year.

The installation of the last gooseneck light fixture and the installation of furniture and landscaping will be completed at Post Office Plaza prior to the June 13th Fishawack Festival. Mr. Denave also reported that a resolution approving the award of a contract for engineering design services for the Lafayette Avenue and Front Street Improvement Projects is included on tonight's agenda for Council action. The project will include sidewalk replacement on Lafayette Avenue from Main Street to Watchung Avenue where needed. The county has scheduled road paving of Watchung Avenue/Shunpike in the month of August and the road repaving of Fairmount Avenue from Watchung Avenue to Chatham Township will be completed this summer as well. Lastly, Mr. DeNave reported he is awaiting a second quotation for window replacements in Borough Hall.

2016/2017 Water Rates – Council Member James Lonergan reported the Finance Committee will be recommending a 2% rate increase in 2016/2017. The modest rate increase will cover the cost of scheduled water infrastructure improvements over the next 1-3 years, eliminating the need for the Borough to bond for the improvements.

Expressions of Interest are due to NJ Transit by June 15th and will be followed with a Request for Proposal.

ADMINISTRATOR'S REPORT

Mr. Robert Falzarano reported job descriptions have been revised for administrative personnel, which have been reviewed by department heads. The job descriptions will be finalized this week. Mr. Falzarano further reported that the Monuments and Memorials Policy has been revised. An appendix identifying the locations of monuments throughout the Borough is being prepared and will be included with the policy. Mr. Falzarano also reported that the Frequently Asked Questions posted on the Borough website is being revised by department heads to conform to changes in the reorganization of Borough departments. He also mentioned that the Fee Resolution is being updated.

RESOLUTION OF THE MAYOR AND BOROUGH COUNCIL OF THE BOROUGH OF CHATHAM, COUNTY OF MORRIS, NEW JERSEY TO AUTHORIZE A CONTRACT WITH DR. ROBERT BURCHELL

WHEREAS, the New Jersey Supreme Court's recent decision in *In re Adoption of IV.J.A.C.* 5:96 & 5.97, (M-392-14) (067126) (March 10 2015), authorizes the Superior Court to hear and decide actions addressing municipal compliance with constitutional <u>Mount Laurel</u> obligations due to the Council on Affordable Housing's ("COAH") failure to adopt Third Round Rules; and

WHEREAS, the Supreme Court in its decision instructs municipalities which had either received Third Round Substantive Certification or been declared to have "participating" status by COAH to file a declaratory judgment action in Superior Court seeking approval of their housing element and fair share plan in order to receive judicial substantive certification and the accompanying protection as afforded under the Fair Housing Act; and

WHEREAS, the Borough was declared to have participating status by COAH; and

WHEREAS, the Mayor and Borough Council deem it to be in the best interest of the Borough and its residents to update the Borough's housing element and fair share plan and file a declaratory judgment action seeking judicial substantive certification in accordance with the Supreme Court's decision; and

WHEREAS, to accomplish this task, the Mayor and Borough Council wish to retain the services of a Dr. Robert Burchell as an expert in determining municipal fair share numbers; and

WHEREAS, this contract is exempt from public bidding as a professional service in accordance with the Local Public Contracts Law, N.J.S.A. 40A:11-1 et seq.; and

WHEREAS, it is anticipated that other municipalities will also retain Dr. Burchell's services and contribute their share of the contract cost;

WHEREAS, the maximum contract amount to the Borough shall not exceed \$3,000.00; and

WHEREAS, the Borough's Chief Financial Officer has certified that sufficient funds are available for this contract.

BE IT RESOLVED, by the Mayor and Council of the Borough of Chatham in the County of Morris and the State of New Jersey that the Mayor and Borough Clerk are hereby authorized to execute a contract with Dr. Burchell as an expert in determining municipal fair share numbers in connection with the Borough's declaratory judgment filing seeking judicial substantive certification in accordance with the Supreme Court's decision.

BE IT FURTHER RESOLVED, that the Mayor and Borough Clerk are further authorized to execute a Common Defense Agreement with the other municipalities retaining Dr. Burchell's services in a form acceptable to the Borough Attorney.

BE IT FURTHER RESOLVED, that the Borough Administrator or his designee, Borough Attorney and other Borough officials are hereby authorized and directed to take such actions and execute and deliver such other documents as may be necessary or desirable in furtherance of the purposes set forth herein.

Council Member John Holman moved to approve Resolution #15-205. The motion was seconded by Council Member James Collander. A voice vote was taken and Resolution #15-205 was approved unanimously.
