Mayor Bruce A. Harris opened the meeting by reading the following proclamation proclaiming the month of March as National Nutrition Month:

WHEREAS the type, quality, and amount of food that individuals consume each day plays a vital role in their overall health and physical fitness; and

WHEREAS, there is a need for continuing nutrition education and a wide-scale effort to enhance healthy eating practices.

In doing so, I encourage all citizens and employees to join the campaign and become concerned about their nutrition and the nutrition of others in the hope of achieving optimum health for both today and tomorrow.

Ms. Monica Hansen, a Registered Dietician with Chatham ShopRite, was present to accept the proclamation. Ms. Hansen briefly spoke of the food tasting programs available at the ShopRite promoting healthy food choices during National Nutrition Month in March and invited the public to take advantage of ShopRite's nutrition and wellness programs.

Mayor Bruce Harris proceeded with the Special Presentation.

SPECIAL PRESENTATION

Presentation of Guinness Record Certificate

Ms. Christine Grobert, of the Chatham Historical Society, informed the Mayor and Council that as part of the Borough's Train Station Centennial Celebration, the Chatham Historical Society reached out to Guinness World Records for approval to attempt to break the current world record of 396 wooden train whistles being blown simultaneously. Following strict Guinness World Record protocols, the Chatham Historical Society along with Borough volunteers planned and organized the train whistle blowing event, which took place on June 14, 2015. 1,269 participants were registered and Guinness verified 1,127 wooden train whistles were blown simultaneously in Chatham. Ms. Grobert stated that participants of all ages took part in the exciting whistle blowing event.

On behalf of the Chatham Historical Society, Ms. Grobert presented Mayor Harris and the Borough Council with the official Guinness World Record Certificate to proudly display in Borough Hall.

Mayor Harris accepted the official Guinness Book of World Record Certificate, which was framed and included a wooden train whistle from the event.

Council President Gerald Helfrich moved to approve Resolution #15-107. The motion was seconded by Council Member James Collander. A voice vote was taken and Resolution #15-107 was approved unanimously.

DISCUSSION ITEMS

JCP&L Area Manager Change – Mr. Rob Walton, Area Manager for JCP&L, was introduced as the new Area Manager, replacing Stan Prater. Mr. Walton stated he has 20 years in customer service and served as a Council Member and Mayor in his hometown. He currently serves as a Freeholder on the Hunterdon County Board of Chosen Freeholders. Mr. Walton expressed that as an elected official he values the commitment and partnership between JCP&L and elected officials, who want the best for their communities. Mr. Walton informed the Mayor and Council that there are no planned activities in the coming year in Chatham. Mr. Walton invited the Mayor and Council to take the JCP&L Dispatch Center tour, which are given every month to local elected officials and provide an overview of how JCP&L crews respond to emergency situations.

Mayor Harris informed the Council and public that most power outages in the Borough are caused by trees, tree limbs and animal contact. In closing the presentation, Mayor Harris thanked Mr. Walton for keeping him informed about electric power issues and for fostering a great relationship with the Borough.

Artisan Guild Fair – Mr. Bill Fagnant stated this year marks the 3rd Annual Chatham Area Fine Arts and Craft Festival, which has been well-received by the community with an estimated 2,000-3,000 people attending last year's arts festival. This year's event is scheduled to be held on Saturday, September 13th. Mr. Fagnant thanked the Borough for its support, especially the services provided by the Police Department, Department of Public Works and the Health Department in ensuring the event is safe and clean for visitors.

Council President Gerald Helfrich inquired whether the Artisan Guild Fair pays for police and DPW services and further questioned if the event could be planned in conjunction with the annual Fishawack Festival. Mr. Fagnant responded that the Artisan Guild Fair pays for needed police and DPW services, but depends on the Borough's support in helping to make those services available. He also supported the concept of combining the art festival with the Fishawack Festival, but stated doing so would present some challenges in organizing its artisan vendors to attend a June event.

Pilgrim Pipeline Signage – Ms. Dawn Ferguson was not present.

Baseball Club Request to Install Dugout at Shepard Kollock Park – Mr. Anthony Gruppuso presented a proposal on behalf of the Chatham Baseball Club to install two dugouts, a batting cage and fencing at Shepard Kollock Park's South Field. Mr. Gruppuso informed the Mayor and Council that the Chatham Baseball Club is affiliated with the Babe Ruth Baseball Organization, which requires 46/60 fields for K through 5th grade teams and 50/70 fields for 5th and 6th grade teams. Shunpike Field No. 2 is currently the only 50/70 field, creating difficulties in scheduling regulation field use for teams during the summer season.

Mr. Gruppuso stated the Baseball Club proposes to build, at its expense, two dugouts at the South Field and a batting cage for pre-game warm-ups. The Borough would install fencing for the dugouts and backstop.

Council Member James Lonergan commented that the fields at Shepard Kollock Park have historically been underutilized and voiced support in developing the South Field for baseball. He also confirmed that the Borough has bonded funds for ball field development.

The Council inquired about potential parking concerns, which may arise as a result of developing the South Field and agreed that on-street parking restrictions may need to be enforced with the additional field use. A request was also raised that the residential neighborhood should be given notice of the proposal and made aware of the proposed improvements to Shepard Kollock Park's South Field and subsequent increased use of the park as a result of park improvements. Council Member James Collander asserted that the club should inform the residential neighborhood of its planned improvements to South Field.

The Council then briefly discussed the need that it should begin to explore improvements to the North Field of Shepard Kollock Park in efforts to address the growing demand of field use by the 5th and 6th grade baseball program.

At the conclusion of the presentation, Mayor Harris inquired if there was Council consensus to approve the proposed installation of dugouts and batting cage to South Field in Shepard Kollock Park. The Borough Council consented that the Chatham Baseball Club can move forward with the proposed capital project to install dugouts, back stops, fencing and batting cage on the South Field. Mayor Harris requested an authorizing resolution be prepared.

Council Member James Lonergan left the meeting at 8:27 p.m.

MAYOR'S REPORT

Mayor Bruce Harris reported that he stopped by the Cub Scouts Blue and Gold Dinner on Saturday and attended the Eagle Court of Honor for Troop 8 Boy Scouts. He reported that Eagle Scout designations were earned by four Chatham scouts: Stephen Kamionek, who built flower beds of pollinator-friendly plants and an information kiosk next to the Chatham Community Bee Garden; Patrick McAuliffe created a prayer garden for St. Patrick Church; Griffin Kenny built and installed bat houses at Kelley's Pond and improved the walking path around the pond; and, Landon Paulson constructed and placed bat houses for three Morris County parks. Mayor Harris stated scouts set a good example for young people in the community and contribute great things to the community by way of their Eagle Scout projects.

Mayor Harris also reported he attended the Emergency Squad Annual Dinner on Saturday night and congratulated Connie Hartman in becoming the new Squad Captain. Mayor Harris reminded the public that the Emergency Squad is always looking for members and mentioned they have a Junior Cadet Program for younger members.

Lastly, Mayor Harris reported on the progress of the Community Bee Garden. Although one of the coop hives was lost, the remaining bees survived the cold spell and are doing well. The club has 20 members, who met for an end-of-year celebration at The Meadery, located in the Millburn Mall in Short Hills. He announced that several members, including him, will be establishing their own hives this year.

ADMINISTRATOR'S REPORT

Mr. Robert Falzarano reported on the following:

- 1. The draft Policy and Procedure for Planning Board and Zoning Board applications have been revised and recirculated for final review.
- 2. The Bank of America will be removing an underground storage tank that is located under the sidewalk sometime between March 2^{nd} and March 6^{th} . The Borough Engineer is coordinating the tank removal with the bank.
- 3. The online training module has been installed and harassment training for Borough employees is underway.
- 4. Employee notification of weather-related closures, or delayed openings, has been automated using the Everbridge Notification System.
- 5. The 2015 Budget discussion is scheduled for the March 9th meeting. Mr. Tim Day, the Borough's Chief Financial Officer, will present the budget at that meeting. Budget books will be distributed to the Mayor and Council in Friday's mail.
- 6. Mr. Falzarano informed the Mayor and Council that Police Chief Crosson has reported that motor vehicle crashes in the Borough decreased 11% in 2014 from 2013 and credited the Police Department's directive patrol assignments and enforcement in high-frequency accident locations in the Borough.

- 7. The MUA has offered to collect recyclables at the library at no added cost. The additional recycled material will be added to the Borough's tonnage reporting.
- 8. The Borough budgeted \$45,000.00 for road salt. To date the Borough ordered approximately 463.5 tons of road salt at the cost of \$28,238.00. In addition, the Borough has an order for 100 more tons of road salt for an additional cost of \$6,093.00. An additional \$10,000.00 will be appropriated in the 2015 budget.

CONSENT AGENDA

The following items are considered to be routine by the Chatham Borough Council and will be enacted by one motion. There will be no separate discussion of these items unless a Council Member so requests, in which event the item will be removed from the Consent Agenda and considered in its normal sequence on the Agenda. Resolution #15-123 through Resolution #15-132 have been placed on the Consent Agenda.

Council Member Victoria Fife sought clarification on Resolution #15-127, which states 38 parking permits are to be issued to the library for use by its employees. Mr. Falzarano confirmed that the Borough would issue 38 parking permits; however, only 14 parking permits, plus one parking for the van, can be used at any one time. The Parking Enforcement officers will monitor the use of the parking permits. Any discrepancy in the use of more than 14 parking permits at any one time would be addressed by the Administrator directly with the Library Director.

Council Member Alida Kass requested that Resolution #15-128 be removed from the Consent Agenda for discussion and vote.

RESOLUTION AUTHORIZING THE SHADE TREE COMMISSION TO DISPLAY BANNERS ON DECORATIVE STREET LIGHT STANCHIONS ALONG MAIN STREET TO PROMOTE TREE PLANTING AND RELATED ACTIVITIES

WHEREAS, the Shade Tree Commission seeks permission from the Mayor and Borough Council to display banners on the decorative street light stanchions along Main Street to promote tree planting and related activities; and

WHEREAS, banners promoting tree planting may be displayed by the Shade Tree Commission during the months of April and May to coincide with National Arbor Day, April 24, 2015, and at such other times throughout the year, as appropriate, and provided there are no existing conflicts with respect to other banners previously approved to be displayed on the decorative street light stanchions; and

WHEREAS, the Department of Community Services, together with the Borough Administrator, shall arbitrate any issues arising in connection with displaying of banners on the decorative street light stanchions along Main Street.

BE IT RESOLVED by the Mayor and Borough Council of the Borough of Chatham that they hereby approve the display of banners on the decorative street light stanchions along Main Street by the Shade Tree Commission to promote tree planting and related activities during the months of April and May to coincide with National Arbor Day, April 24, 2015, and at such other times throughout the

year, as appropriate, and provided there are no existing conflicts with respect to other banners previously approved to be displayed on the decorative street light stanchions; and

BE IT FURTHER RESOLVED, that all other Borough officials and employees are hereby authorized and directed to take all action necessary and appropriate to effectuate the terms of this Resolution.

Council President Gerald Helfrich moved to remove Resolution #15-128 from the Consent Agenda for discussion and vote. The motion was seconded by Council Member James Collander.

Mayor Bruce Harris opened Resolution #15-128 for discussion.

Council Member Alida Kass commented that she would like to reduce visual clutter and opined that banners should be used only for specific events, such as the Farmer's Market and Shop Chatham. Council Member Kass reiterated that a Borough policy is needed to establish guidelines with respect to the messaging and content of banners displayed in the Borough.

Council Member James Collander objected to the broad language used in the resolution, allowing banners to be displayed "at such other times throughout the year, as appropriate."

Council Member John Holman agreed, stating guidelines are needed to address the scope of timeframes when banners can be displayed, as well as, who can display banners.

Council President Gerald Helfrich noted that the Resolution states "the Department of Community Services, together with the Borough Administrator, shall arbitrate any issues arising in connection with displaying of banners" and voiced his consent with this provision.

Mr. Falzarano confirmed that he would not approve any banner without the Council's prior consent.

Mayor Bruce Harris closed discussion and asked for the Borough Clerk for a Roll Call Vote.

RESOLUTION AUTHORIZING THE AWARD OF A CONTRACT TO LTI, INC. FOR GRASS AND PROPERTY MAINTAINANCE SERVICES IN THE AMOUNT NOT TO EXCEED \$32,053.50

WHEREAS, the Director of Public Works solicited proposals from four (4) qualified contractors for grass and property maintenance services for the 2015 calendar year; and

WHEREAS, four (4) quotations were received as follows:

WHEREAS, the value of this contract will exceed 15% of the bid threshold, but will be less than the bid threshold of \$36,000.00, and therefore may be awarded by soliciting competitive quotes without advertising for bids under the Local Public Contracts Law, N.J.S.A. 40A:11-1 et seq.; and

WHEREAS, this contract is awarded as a non-fair and open contract pursuant to the provisions of N.J.S.A. 19:44A-20.4; and

WHEREAS, the Director of Public Works recommends that the award of the contract be made to LTI. Inc., 70-76 Passaic Avenue, Florham Park, NJ 07932 in the amount of \$32,053.50; and

WHEREAS, LTI. Inc. has submitted a Business Entity Disclosure Certification certifying that they have not made any reportable contributions to a political and/or candidate committee in the Borough of Chatham in the previous one year, and that the contract will prohibit the contractor from making any reportable contributions through the term of this contract; and

WHEREAS, the Chief Financial Officer has certified that sufficient funds are available in Current Fund Account #5-01-28-375-258 for the award of this contract.

BE IT RESOLVED, by the Mayor and Council of the Borough of Chatham that it concurs with the recommendation of the Director of Public Works and hereby authorizes the Mayor to execute the contract with LTI, Inc., in the amount of \$32,053.50, in accordance with the specifications upon which quotations were received and accepted; and

BE IT FURTHER RESOLVED, that all Borough officials are hereby authorized and directed to take all action necessary and appropriate to effectuate the terms of this resolution.

RESOLUTION #15-124

RESOLUTION ESTABLISHING A DEDICATION BY RIDER OF REVENUES FOR THE SHADE TREE COMMISSION TRUST FUND

WHEREAS, permission is required of the Director of the Division of Local Government Services for approval as a dedication by rider of revenues received by a municipality when the revenue is not subject to reasonably accurate estimates in advance; and

WHEREAS, N.J.S.A. 40A:5-29 permits the Borough to use dedicated revenues anticipated from donations in support of Shade Tree Commission activities for the purposes to which said donations are made; and
