February 9, 2015 MINUTES

Mayor Bruce A. Harris called the Regular Council Meeting of the Borough of Chatham to order on Monday, February 9, 2015 at 7:30 p.m. in the Council Chambers in the Municipal Building, 54 Fairmount Avenue, Chatham, New Jersey.

SALUTE TO FLAG

The Mayor and Borough Council led the assembled in the Pledge of Allegiance.

MOMENT OF SILENCE

Mayor Harris asked for a moment of silence for those who have given their lives for our country.

Mayor Bruce A. Harris opened the meeting by reading the following proclamation celebrating the 8th Annual Susan G. Komen North Jersey Race for the Cure to be held May 3, 2015:

PROCLAMATION

CELEBRATING THE 8TH ANNUAL SUSAN G. KOMEN NORTH JERSEY RACE FOR THE CURE $^{\odot}$ ON MAY 3, 2015

WHEREAS, breast cancer is the leading cause of death of women between the ages of 35 and 64 and increased public awareness of this disease, its risk factors and symptoms may save lives of women and men across New Jersey; and

WHEREAS, SUSAN G. KOMEN FOR THE CURE® is dedicated to education and research about causes, treatment, and the search for a cure; and

WHEREAS, the Komen National Race for the Cure Series, an event of the SUSAN G. KOMEN FOR THE CURE[®], is the largest series of 5 kilometer races in the world, raising public awareness and much needed funding for breast cancer research; and

WHEREAS, on Sunday, May 3, 2015, runners, walkers, survivors, co-survivors and volunteers will unite at a new race location to be held at the Essex County South Mountain Recreation Complex for the 8th Annual SUSAN G. KOMEN FOR THE CURE[®] NORTH JERSEY RACE FOR THE CURE[®] 5K Certified Run, 5K Walk, and 1.5K Fun Walk event; and

WHEREAS, last year the SUSAN G. KOMEN FOR THE CURE® NORTH JERSEY RACE FOR THE CURE® brought together thousands of women, men and children from northern New Jersey and beyond, and raised over \$1 million for the North Jersey service region to help fund breast cancer research and provide local community life-saving education, screening and treatment services.

BE IT PROCLAIMED, by the Mayor and Council of the Borough of Chatham that Sunday, May 3, 2015 is SUSAN G. KOMEN FOR THE CURE® NORTH JERSEY RACE FOR THE CURE® day in Chatham Borough; and

BE IT FURTHER PROCLAIMED, that all Chatham Borough residents are encouraged to participate in the SUSAN G. KOMEN FOR THE CURE[®] NORTH JERSEY RACE FOR THE CURE[®] to help raise funds and awareness for the fight against this life threatening disease, to join the celebration of survivorship, and to honor those who have dedicated their lives to researching, treating, curing, and caring for victims, and to those who have lost their battle with breast cancer.

Due to the inclement weather, Mayor Harris announced no one from the Susan G. Komen North Jersey organization was present to receive the Proclamation.

Mayor Bruce Harris proceeded with Resolution #15-107:

Council Member John Holman moved to approve Resolution #15-107. The motion was seconded by Council Member James Collander. A voice vote was taken and Resolution #15-107 was approved unanimously.

DISCUSSION ITEMS

Bridging the Gap – Cares and Shares Not for Profit – Ms. Mary Lonergan, Chair of the Cares & Shares Advisory Committee, announced the formation of Chatham Bridging the Gap, a new 501[c]3 charitable organization named. The new not for profit organization has been established to provide temporary assistance to local families in need in both Chatham Borough and Chatham Township. By

creating a not-for-profit organization in place of the Cares & Shares Advisory Committee, it is hopeful that the not-for-profit can increase the level of support by building a larger financial base primarily through tax-deductible donations. All funds raised in Chatham will be distributed in Chatham. Mrs. Lonergan stated that the organization has a trustee board and established bylaws and current Committee members are serving on the new Chatham Bridging the Gap organization. It is anticipated that liaisons from other local service organizations, churches, schools and the Borough would join Chatham Bridging the Gap in community outreach and assistance programs.

In closing, Mrs. Lonergan inquired whether the Borough would be able to transfer the balance of existing public assistance funds held by the Borough, which were previously administered by the Cares & Shares Advisory Committee, to Chatham Bridging the Gap. Mr. Lott advised that, by statute, all municipalities, including the Borough, must have a general public assistance program. Mr. Lott further advised that the Borough's program is administered by the county; however, the eligibility criterion is such that few people in Chatham would qualify for assistance.

Shade Tree Project Solicitation – Mr. Patrick Carroll, Chair of the Shade Tree Commission, sought approval from the Borough Council to allow the Commission to solicit private funds to help pay for educational materials and fund additional plantings and sought permission to place a series of banners on the decorative street lights in the downtown to promote tree planting and other activities sponsored by the Commission. Mr. Carroll informed the Mayor and Council that the Commissioners have voted in favor of the two initiatives and now sought authorization from the Borough Council. Ideally, Mr. Carroll stated, the Shade Tree Commission would like to hang the street light banners to coincide with Arbor Day.

Mr. Lott advised that the Shade Tree Commission has the authority to accept private donations and suggested that the Commission adopt a resolution setting forth the programs eligible to receive donations. The Borough Council, in turn, would need to adopt a Chapter 159 resolution to satisfy requirements under the Local Budget Law.

The Council briefly discussed whether a Borough policy is needed to establish guidelines with respect to the messaging and content of banners displayed in the Borough, particularly banners affixed to downtown decorative street lights. The Council concurred that a long-term policy should be further discussed and established; however, they consented to the Shade Tree Commission's request to display banners along Main Street to coincide with Arbor Day and directed that an authorizing resolution be presented on the next agenda.

Emerald Ash Borer – Mr. Tony Torello, Deputy Public Works Director, provided an update on the proliferation of the emerald ash borer (EAB). The EAB infestation has not spread beyond the two New Jersey counties, Warren and Somerset, where it was discovered in 2014. Funds have been budgeted to retain a forester to review the Borough's trees and prepare a report of findings and recommendations. The forester will begin his review in the month of May. Once the report is received, Mr. Torello and the Shade Tree Commission will present the report and recommendations to the Mayor and Council.

Mr. Torello advised that the largest population of ash trees in the Borough is located on the north side of Main Street. He also recommended that only healthy specimen trees that are able to survive should be treated for EAB. Trees on the decline from age or having other diseases would not be treated. He also informed the Mayor and Council that the forester, Mr. Linson, felt very strongly that the Borough would not have an EAB problem prior to beginning treatment, since the EAB has not been found outside the two counties where it was discovered in 2014.

Mr. Torello suggested that the best long-term course of action would be to work with the Shade Tree Commission in developing a program of succession planting incorporating a diversity of tree species throughout the Borough. Mr. Carroll, Chair of the Shade Tree Commission, agreed with Mr. Torello's suggestion and reiterated that property owners should be encouraged to take down diseased trees in efforts to allow healthier trees a better chance of surviving the EAB.

2015 Goals and Objectives – Before acknowledging Mr. Falzarano presentation of the Borough's 2015 Goals and Objections, Mayor Harris mentioned that only one or two towns other than Chatham Borough establish a written set of goals to help set up priorities to be accomplished for the coming year. Mr. Robert Falzarano further stated that establishing goals and objectives keeps everyone focused on what the needs are and what the Mayor and Council would like to accomplish. Mr. Falzarano reported that 34 goals have been established for the coming year with tentative completion time frames and provided a synopsis of each of the 34 goals. He noted that a couple of the goals have already been completed.

At the conclusion of Mr. Falzarano's presentation, Mayor Harris asked that a goal be added with respect to the newly created Special Events Advisory Committee. Mr. Falzarano will develop a written goal with objectives to be added to the 2015 Goals and Objectives.

Generators – Mr. James Lott, Esq. opened the discussion of this matter by providing a history of the Borough's current ordinance. The ordinance does not expressly provide for the location of mechanical equipment, including emergency generators. He advised that the proposed revised ordinance provides a flexible standard in permitting mechanical equipment to be located within 4 feet of the property line or 10 feet between adjacent structures in front, side or rear yards, and would permit the testing of emergency generators to be tested during certain times. The revised ordinance further provides for the replacement of existing mechanical equipment not to exceed 20% of the existing footprint. In the event the homeowner could not meet any of the standards, an application before the Board of Adjustment would be required for a variance.

Mr. Vince DeNave added that the 10 foot set back from adjacent structures is in place to ensure that carbon dioxide emitted from mechanical equipment is properly exhausted. He stated residential properties that are not large enough to accommodate the 10 foot set back would need to be evaluated on a case-by-case basis. Mr. DeNave stressed the importance that homeowners always maintain functional CO₂ detectors.

Members of the Council questioned why the revised ordinance contains the provision "Testing and operation during power failure shall be exempt from noise regulation under the Borough Code." Mr. Lott advised that the revised ordinance does not regulate portable generators, but only those permanently installed. He further advised that the proposed ordinance follows state regulations concerning emergency generators. Mr. DeNave confirmed that only gasoline-powered portable generators present noise and exhaust concerns within the prescribed set backs, not permanently installed units.

Mayor Harris asked that the Members of the Council forward their comments and concerns to Mr. Falzarano's and Mr. Lott's attention.

Chatham Athletic Fund (CAF) Gala – Mr. Wes Zeliff, Trustee of the Chatham Athletic Fund, requested permission to hold its annual Gala Fundraising Event at Reasoner Park on Saturday, September 26, 2015 from 2:00 p.m. until 12:30 a.m. (Sunday, September 27th). Mr. Zeliff thanked the

Mayor, Borough Council, Mr. Falzarano, Mr. DeNave and Mrs. Nauta for their support and assistance in last year's Gala, which attracted over 500 participants. He provided a brief summary of projects, large and small, in the Borough and Township that have been funded by CAF's fundraising events over the past years.

MEETING OPEN TO THE PUBLIC

NOTICE OF PUBLIC COMMENT TIME LIMIT

Hearing of citizens during the Public Comment section of the Agenda is an opportunity for any member of the public to be heard about issues which are/are not topics scheduled for Public Hearing tonight. To help facilitate an orderly meeting, and to permit all to be heard, speakers are asked to limit their comments to a reasonable length of time.

Mayor Harris opened the meeting to the public.

Eric Merse, 92 Washington Avenue, commented on the application he submitted to the Borough officials requesting that the Borough vacate a portion at the end Oliver Street and asked that Borough officials consider his request as soon as possible.

Susan Chumra, 6 Bartow Lane, commented, thanked the Department of Public Works for an excellent job in snow removal effects. Ms. Chumra expressed her support for the street light banners proposed by the Shade Tree Commission and informed the Mayor and Council that the ash trees on her property have been treated for the EAB. Lastly, she thanked the Shade Tree Commissioners for their service and efforts on behalf of the community.

Seeing no one else wishing to speak Mayor Harris closed the meeting to the public.

REPORTS

COUNCIL COMMITTEE REPORTS

Budget and Finance - Council Member James Lonergan reported that the 2014 budget came in as planned and the presentation of the 2015 budget is on schedule.

Long Range Traffic & Pedestrian Safety Planning - Council Member James J. Collander reported no parking signs have been installed on N. Hillside Avenue prohibiting street parking along 250 feet. A letter was sent to the New Jersey Department of Transportation, as well as, to Freeholder Douglas Cabana, informing that the Borough is not interested in the installation of a crosswalk along Rt. 124 at the Library. A crosswalk would eliminate on-street parking spaces and would not be in compliance with requirements of the state manual.

Public Safety & Emergency Services - Council Member James J. Collander provided a brief summary of mobilization protocols the Office of Emergency Management (OEM) would engage in anticipation of forecasted winter weather advisory.

Personnel - Council Member Victoria Fife reported the relocation of all Borough offices to the main floor in Borough Hall will be completed within the week. Collective bargaining negotiations are anticipated to begin between the Borough and the Police and DPW unions.

Public Works Planning - Council Member John Holman reported due to inclement weather, the Public Works Planning Committee rescheduled its meeting to Friday, February 13th and had no report.

Shared Services & 3rd Party Agreements - Council President Gerald Helfrich reported the Committee continues to explore shared service efforts.

MAYOR'S REPORT

Mayor Bruce A. Harris reported the stairway from the Center West Parking Lot to Elmwood Avenue has been closed due to a deteriorated condition of the concrete. The Department of Public Works will restore the stairs and walkway once the weather clears. Mayor Harris further reported that the date for the Town Hall style meeting with state legislatures concerning the proposed Pilgrim Pipeline project has been scheduled for February 25th at 7:30 p.m. at the Madison High School auditorium.

Lastly, Mayor Harris announced that at tonight's meeting the Borough is filling a vacancy on the Environmental Commission and a new volunteer will be appointed to serve on the Communication & Technology Advisory Committee.

ADMINISTRATOR'S REPORT

Mr. Robert Falzarano reported that as he reported earlier in the meeting, the 2015 Goals and Objectives are completed. He also reported that the 2015 budget will be finalized at the next finance meeting scheduled to take place on February 15th.

WHEREAS, the Mayor and of the Borough of Chatham supports the Chatham Area Artisan Guild and wishes to formally authorize the use of the Chatham train station parking lot for the CAAG Fine Arts and Crafts Fair to be held on Sunday, September 15, 2015.

BE IT RESOLVED, by the Mayor and Council of the Borough of Chatham that they hereby authorize the use of the south side of the Chatham train station parking lot for the CAAG Fine Arts and Crafts Fair on Sunday, September 15, 2015; and
