Mayor Bruce A. Harris opened the meeting by reading a proclamation of the Mayors' Wellness Campaign of the Chathams Celebrating American Heart Month and Supporting National Wear Red Day on Friday, February 6, 2015.

PROCLAMATION

THE MAYORS' WELLNESS CAMPAIGN OF THE CHATHAMS CELEBRATING AMERICAN HEART MONTH, FEBRUARY 2015, AND SUPPORTING NATIONAL WEAR RED DAY, FRIDAY, FEBRUARY 6, 2015

WHEREAS, maintaining a strong heart is key to a long and healthy life; and

WHEREAS, the number one killer of American men and women, cardiovascular disease, is responsible for one out of every four deaths in the United States; and

WHEREAS, while anyone can develop heart disease, those with high blood pressure or high cholesterol and those who smoke are at greater risk. Risk factors like diabetes, obesity, poor diet, physical inactivity, and excessive alcohol use can also increase the likelihood of developing heart disease; and

WHEREAS, by adopting a few healthy habits - getting regular exercise; not smoking; eating diets rich in fruits and vegetables and low in salt, saturated fat, and cholesterol - each of us can reduce our risk; and

WHEREAS, during AMERICAN HEART HEALTH MONTH, we renew our fight, both as a Nation and in each of our own lives, against the devastating epidemic of heart disease; and

WHEREAS, the Mayors' Wellness Campaign of the Chathams recognizes that more could be done in the Chathams to increase awareness of cardiovascular health and encourage people to adopt a few heart healthy habits to reduce their risk of developing heart disease; and

WHEREAS, cardiovascular health remains a priority for The Mayors' Wellness Campaign of the Chathams, and its commitment in helping to keep our citizens and community healthy and stronger than ever; and

WHEREAS, on Friday, February 6, 2015 everyone will have the chance to show their support for heart health by observing NATIONAL WEAR RED DAY® by wearing red in solidarity with those struggling with heart disease.

BE IT RESOLVED, that I, Bruce A. Harris, Mayor of the Borough of Chatham, together with the Council of the Borough of Chatham and the Mayors' Wellness Committee of the Chathams, encourage all citizens to celebrate the month of February as AMERICAN HEART HEALTH MONTH and invite all citizens to join us in recognizing and reaffirming our commitment to fighting cardiovascular disease by wearing red Friday February 6, 2015, on "NATIONAL WEAR RED DAY[®]."

Mr. Brian George, Chair of the Mayors' Wellness Campaign of the Chathams, and representative from St. Barnabas Medical Center, was in attendance to receive the proclamation from Mayor Harris. Mr. George thanked Mayor Harris and the Borough Council for the proclamation and helping to raise awareness of cardiovascular health by supporting American Heart Health Month and National Wear Red Day. Mr. George informed everyone that the Borough's gazebo will be illuminated with red light on Friday, February 6th to help raise awareness of National Wear Red Day.

Mayor Bruce Harris asked Council Member Victoria Fife to read the proclamation Celebrating the American Cancer Society's Relay for Life Event in Chatham Borough on May 30, 2015.

WHEREAS, RELAY FOR LIFE is the signature activity of the American Cancer Society, which celebrates cancer survivors, those who have ever been diagnosed with cancer, and remembers those lost to the disease and empowers individuals and communities to fight back against cancer; and

WHEREAS, at RELAY FOR LIFE events, communities across the globe come together to celebrate cancer survivors and remember loved ones who are no longer with us. The funds raised truly make a difference in the fight against cancer; and

WHEREAS, in its third year, Chatham Borough is joining more than 4 million people in over 20 countries raise much-needed funds and awareness to save lives from cancer through participating in the RELAY FOR LIFE movement; and

WHEREAS, money raised during THE AMERICAN CANCER SOCIETY'S RELAY FOR LIFE in the Borough of Chatham, Morris County, New Jersey, helps the Society save lives and create more birthdays by helping individuals stay well, get well, fight back and find cures; and

WHEREAS, RELAY FOR LIFE helps make possible programs such as rides to and from treatment, "Look Good...Feel Better" sessions for women undergoing treatment, support networks, and cancer care specialists who are there to answer questions 24/7 and funds more than \$100 million in cancer research each year; and

WHEREAS, over the past two years, Chatham Borough has raised over \$150,000.00 for the AMERICAN CANCER SOCIETY RELAY FOR LIFE fundraising program.

BE IT RESOLVED, that I, Bruce Harris Mayor of the Borough of Chatham, together with the Council of the Borough of Chatham, hereby proclaim May 30, 2015 as

"RELAY FOR LIFE DAY"

in the Borough of Chatham and in doing so, invite all residents to join us in participating in the Borough's 6-hour RELAY FOR LIFE event on May 30, 2015 at the Chatham Middle School from 6:00 p.m. to 12:00 midnight to help raise much-needed funds and awareness to save lives and fight against cancer and to celebrate cancer survivors and remember loved ones who are no longer with us. Together we will find a cure.

Council Member Victoria Fife made a motion to approve the proclamation. The motion was seconded by Council Member James Lonergan. A voice vote was taken and the proclamation was approved unanimously.

Council Member Fife announced Ms. Kori Willis, Chair of Chatham Borough's Relay for Life Event Committee, was not able to attend tonight's meeting to accept the proclamation from the Mayor and Council and offered to forward the proclamation to her attention.

BE IT RESOLVED by the Council of the Borough of Chatham that the minutes from the

January 5, 2015 Reorganization Meeting

Council Member John Holman moved to approve Resolution #15-93. The motion was seconded by Council Member James Collander. A voice vote was taken and Resolution #15-93 was approved unanimously.

[Council Member Alida Kass arrived at the meeting at 7:41 p.m.]

DISCUSSION ITEMS

2014 Memorial Pool Report – Mr. Jim LeMon, Chair of the Municipal Pool Advisory Committee, presented a 2014 Season Recap and 2015 Season Rate Structure Report for Memorial Pool. Mr. LeMon began his presentation by informing everyone of the committee's three central goals: 1. Continue to increase membership; 2. Continue to strengthen and improve the financials; and 3. Continue to increase enjoyment. Pool membership peaked in 2013 with 654 members and fell to 538 members in 2014. Pool revenues increased steadily each year since 2008 as a result of the capital improvements; however, due to the 17% reduction of members in 2014, revenues fell short last year. Overall, the 2014 profit & loss statement reflected a positive balance, not factoring in the salary allocation of the Recreation Director.

Mr. LeMon further reported that Chatham Recreation will continue to offer an early-bird registration rate program to residents in 2015 from March 15 through April 15. After April 15, regular rates will apply. Mr. LeMon presented the 2015 Season rates for both early-bird registration and regular rates. There will be modest increases over the 2014 season rates for Individuals, Seniors (65+), Family and Au Pair memberships for both Borough and Township residents. Guest fees will increase \$1.00 over the 2014 rate. Membership growth for the 2015 season is projected at 5% and anticipate revenue projections are expected to exceed anticipated costs. Swim lessons rates will be lowered and the tiered discount level will be eliminated. Private lessons will remain at \$40.00 per ½ hour. Anticipated pool hours for the 2015 season will be 11:00 a.m. to 7:00 p.m. Monday through Friday, 12:00 noon to 6:30 p.m Saturday, and 12 noon to 6:00 p.m. Sunday.

In closing his presentation, Mr. LeMon thanked the 23 Borough merchants for promoting the Memorial Pool by agreeing to hang posters in their businesses and gave a special thanks to Carol Nauta, Recreation Coordinator, for efficiently running the day-to-day pool operations.

Mayor Harris and the Borough Council thanked the Mr. LeMon and the Memorial Pool Advisory Committee for their work and informative presentation.

Mayor Harris further encouraged Borough residents to take advantage of a Memorial Pool membership.

Pilgrim Pipeline Update – Mr. Len Resto presented an update on the progress of the Borough's Pilgrim Pipeline Advisory Committee. Mr. Resto informed the Mayor and Council that the committee continues to gather facts and data from various experts, groups and coalitions. Once all facts and data have been analyzed and vetted, the committee will present its recommendation to the Mayor and Borough Council. Mr. Resto advised that to date, 28 New Jersey municipalities have passed a resolution opposing the pipeline project, along with Passaic County, two Boards of Education and the N.J. State Assembly. The N.J. Senate votes on the measure later this month. Mr. Resto reported

Chatham Concerned Citizens continue to assist other communities in their efforts to oppose the pipeline and get involved. He thanked committee member Kate Murphy for creating a Google doc site, a document sharing site to which 20+ municipalities have access in posting and sharing information.

Mr. Resto informed the Mayor and Council that the committee has not come across any organization supporting the pipeline project other than the Alliance for Action, which is a pro-business and pro-union organization and stated that the committee has made requests for information from Pilgrim Pipeline, which have gone unanswered. He reported that since New Jersey does not have any oil pipelines traversing the state, it is unclear whether Pilgrim will be recognized as a "public utility" by the Board of Public Utilities and/or a "pipeline company" under state statute and opined that legal action may commence at some point to challenge the ambiguity of the state statute. In his PowerPoint presentation, Mr. Resto presented a map of the proposed pipeline route through New Jersey together with a map showing the layout and extent of the Buried Valley Aquifer Systems of Northern New Jersey, which underlies much of the proposed pipeline route and poses a significant threat to the region's potable water supply.

Mr. Resto announced that a town hall style meeting is being coordinated by Senator Codey, which will be held in Madison sometime in February and the Chatham Concerned Citizens is planning an opposition rally on February 21st at 2:00 p.m. The location to be announced.

In closing his presentation, Mr. Resto announced the need to continue to recruit citizen volunteers to help the advisory committee with its research and outreach efforts. Volunteers are needed in the following areas: Information Technology, Finance, Public Relations, Event Planning, Engineering, Fundraising, Community Organizing, and Clerical & Administration functions.

Mayor Bruce Harris and the Borough Council thanked Mr. Resto for his informative presentation.

Pilgrim Pipeline Signs – Since Dawn Ferguson was unable to attend the meeting and provide details on the location and or time frame for the signs, the Mayor and Council agreed to discuss this at a later date

Bicentennial Park Sign – Ms. Janice Piccolo provided background information regarding the placement and installation of a sign, which was sponsored and paid for by a local business, in Bicentennial Park. Ms. Piccolo acknowledged that the sign was installed without an authorizing resolution by the Mayor and Council and sought direction from the Council with respect to the development of policies and procedures governing the placement and installation of signage on Borough property through public-private partnership initiatives. Ms. Piccolo suggested the establishment of an "Adopt a Space" program in conjunction with the MyChathamNJ Beautification Program initiatives. In her position as Director of Community Services, Ms. Piccolo was asked to draft a policy and procedure for presentation to the Mayor and Council for their consideration.

Fishawack Festival – Ms. Janice Piccolo, Mr. Chris Tomaino, organizer of the annual Fishawack Festival, and Council Member Victoria Fife presented a proposal for the Borough to make the Fishawack Festival a Borough-sponsored event due to the waning volunteerism and organizational structure over the past few years of the sponsoring non-profit organization. In addition, due to the overwhelming success of last year's festival held in conjunction with the Train Station Centennial celebration and events, it was proposed that the Borough incorporate celebrating the 300th year (Tricenntennial) anniversary of its settlement in conjunction with this year's Fishawack Festival.

Council Member Victoria Fife and Ms. Piccolo recommended that the Fishawack Festival become a Borough event in which the new Department of Community Services, together with a newly formed special events committee, could readily undertake. Revenue generated from the event would be dedicated for Borough beautification projects and Borough-sponsored events and activities. Mr. Tomaino stated the Fishawack Festival brings \$8,000-\$10,000 in net profits. Profits from the event are distributed to community organizations and fund an annual scholarship.

The Council presented questions concerning the commitment of time required to plan and organize the event and further inquired whether the Borough would have the resources necessary to commit to the planning and organization of this event. In addition, questions regarding complications that may arise concerning the purchase and procurement of needed supplies and materials would need to be vetted. Mr. Lott further advised that he would need to research whether the Borough could donate monies to community groups or continue to fund the scholarship program with profits received from the festival should the Borough decide to take over running the Fishawack Festival.

In closing discussion of this matter, Mayor Harris questioned whether there was Council consensus to further explore this matter, and, if so, recommended that an advisory committee be established to vet all issues and present its recommendation to the Mayor and Council. The Borough Council indicated its interest in further exploring this matter.

Library Employee Parking – Council Member James Collander reported that the Library Board of Trustees has requested 15 additional parking permits to accommodate Library employees. The Long Range Traffic and Pedestrian Safety Planning Committee recommended that the 15 parking permits be authorized and that the Library would apply, and pay for, 15 parking permits. The permits would be available for use in the Bowers Lane and Center Street East and West parking lots. The Long Range Traffic and Pedestrian Safety Planning Committee further recommended that the Borough Council amend the parking ordinance to authorize enforcement of the 3-hour parking limit that is posted in the Library parking lot to restrict commuter parking.

Crime Reports – Chief Crosson provided a brief overview of the FBI's Uniform Crime Report (UCR) and presented some of the pitfalls of UCR statistical data used to compile crime rankings. He cautioned that there are many variables that factor into a community's statistical crime ranking, some of which, while having significant impact on crime, are not readily measurable or applicable among all towns. Chief Crosson advised that variables, such as a town's proximity to state highway corridors and modes of transportation, having a downtown, population density, degree of urbanization, among other factors, impact UCR rankings. Chief Crosson confirmed that the Borough's clearance rates, those rates that identify the percentage of crimes cleared by the law enforcement agency, are on par with reported crimes, and again reiterated that it is unfair to use UCR as a sole gauge in comparing community's crime rankings.

Mayor Harris and the Council thanked Chief Crosson for his informative report.

Mayor Harris opened the meeting to the public. Seeing no one wishing to speak Mayor Harris closed the meeting to the public.

REPORTS

BOARD & COMMISSION MEMBERS & LIAISON REPORTS

Due to the late hour of the meeting, and having further business to be conducted on the agenda, Board and Commission Members and Liaison Reports were not given at tonight's meeting.

MAYOR'S REPORT

Mayor Bruce A. Harris thanked the Borough's DPW crews and Police Department for their response to the two recent storm storms. All Borough roads were cleared and made safe for motorists.

Mayor Harris announced that Morris County will be repaving Fairmount Avenue from Watchung Avenue to Southern Boulevard, and will repave Watchung Avenue from River Road to Lafayette Avenue. He also announced that the Board of Education meetings are now being broadcast on Cablevision channel 21 and on FIOS channel 32. The TV broadcast schedule is posted on the website.

Mayor Harris also announced that the Morris County Freeholders Budget meeting has been rescheduled to February 4th, in the Knox Room, 5th floor, Administration and Records Building in Morristown.

Lastly, Mayor Harris reported that a lawsuit has been filed against the Borough by David Hill regarding the re-zoning of the industrial districts. Mr. Hill is challenging the zoning.

ADMINISTRATOR'S REPORT

Mr. Robert Falzarano reported that Chatham Borough will receive \$30,000 for recycling tonnage generated in the year 2012 and is an increase of 71% over the \$17,000 Chatham received in 2011.

Green bags are once again available for sale at Kings Supermarket.

Lastly, Mr. Falzarano reported that a meeting was held with Planning Board representatives, professionals, and staff to review the draft Planning Board and Zoning Board application policies and procedures. Diane Hickey will be revising the draft policy and procedures to incorporate the suggested revisions.

RESOLUTION AUTHORIZING THE IMPLEMENTATION OF A SECTION 125 FLEXIBLE BENEFITS PLAN FOR THE PURPOSE OF OFFERING PRE-TAX EMPLOYEE PREMIUM CONTRIBUTIONS AND FLEXIBLE SPENDING ACCOUNTS AT NO FINAL COST TO THE BOROUGH OF CHATHAM

WHEREAS, the Borough of Chatham previously adopted a Code Section 125 plan, also known as a Flexible Spending Account, (the "Plan"), providing an opportunity for employees to have employer sponsored benefit plan premium contributions, as well as, voluntary plan premiums, deducted pre-tax through payroll and thereby saving immediate Federal and FICA taxes; and

WHEREAS, providing an opportunity for employees to elect to participate in Flexible Spending Accounts for Medical Expense Reimbursement and Dependent Care Expense Reimbursement and have their contributions deducted pre-tax through payroll thereby saving immediate Federal and FICA taxes; and

WHEREAS, Aflac Benefit Services provides a discounted fee schedule for Section 125 Premium Only Plan and Flexible Spending Account services at no final employer cost after employer matching FICA payroll tax savings with sufficient employee participation as a value added benefit to offering Aflac supplemental insurance benefits and education services to employees on a voluntary basis at no employer cost; and

WHEREAS, providing an opportunity for the Borough of Chatham to save matching FICA payroll taxes on all employee elective pre-tax plan contributions, premiums and premium contributions which are payroll deducted on a pre-tax basis through the Section 125 Flexible Benefits Plan hereby saving the Borough of Chatham 7.65% of all pre-taxed plan contributions, premiums and premium contributions for F.I.C.A. eligible employees.

- **BE IT RESOLVED,** that the Borough of Chatham hereby recognizes and authorizes Aflac to provide a Section 125 Flexible Benefits Plan for its employees with employee voluntary contributory Flexible Spending Accounts with the following specifications:
 - Medical Expense Reimbursement: \$2,500.00 Annual Maximum.
 - Dependent Care Expense Reimbursement: \$5,000.00 Annual Maximum; and

- **BE IT FURTHER RESOLVED**, that all other Borough officials and employees are hereby authorized and directed to take all action necessary and appropriate to effectuate the terms of this Resolution.

RESOLUTION CONCURRING WITH THE SPEED LIMITS ESTABLISHED BY THE NEW JERSEY DEPARTMENT OF TRANSPORTATION FOR THE NEW ROUTE NJ 124 WITHIN THE CORPORATE LIMITS OF THE BOROUGH OF CHATHAM

WHEREAS, the New Jersey Department of Transportation ("NJDOT") recently conducted an investigation of speed limit zones along Route NJ 124, formerly part of Route NJ 24; and

WHEREAS, based upon the results of the investigation, the NJDOT has determined that the existing speed limits are realistic and reasonable for existing conditions and should be maintained as follows:

WHEREAS, since the current speed limit approvals reference Route NJ 24 within the corporate limits of the Borough of Chatham, they must be revised to reflect the new Route NJ 124; and

WHEREAS, the NJDOT is required to promulgate a Traffic Regulation Order in order to legally establish the speed limits for the new Route NJ 124 and therefore has requested that the Borough submit a certified, adopted resolution of concurrence to the NJDOT.

WHEREAS, the NJDOT has determined that at least six (6) parking stalls along Route 124, three (3) on each side of the State highway, will need to be removed in connection with the installation of the crosswalk in order to comply with the statutory parking restrictions as they related to crosswalks pursuant to N.J.S.A. 39:4-138e; and

WHEREAS, the Borough's Long Range Traffic and Pedestrian Safety Planning Committee (the "Committee") considered the feasibility of installing the crosswalk; and

WHEREAS, after consulting with the Borough Traffic Safety Officer and the Library Director, the Committee recommends against the installation of the crosswalk because the crosswalk would not meet the requirements set forth by the Manual on Uniform Traffic Control Devices related to the placement of mid-block crosswalks and would result in the loss of parking along both sides of Route 124; and

WHEREAS, based upon the Committee's recommendation, the Mayor and Borough Council do not support the installation of the crosswalk.

BE IT RESOLVED, by the Mayor and Chatham Borough Council that the Mayor and Borough Council do not support the installation of a mid-block crosswalk on Route 124 between Bowers Lane and South Passaic Avenue in front of the Library of the Chathams; and

BASEBALL, SOFTBALL, FOOTBALL, FIELD HOCKEY, SOCCER, LACROSSE AND BASKETBALL CLUBS, TO INCLUDE THE CHATHAM YOUTH WRESTLING CLUB

WHEREAS, on January 5, 2015, the Mayor and Council of the Borough of Chatham adopted Resolution #15-87 authorizing agreements for the Joint Chatham Recreation Program for Chatham Baseball, Softball, Football, Field Hockey, Soccer, Lacrosse and Basketball Clubs; and

WHEREAS, it is necessary to amend Resolution #15-87 to include the Chatham Youth Wrestling Club program; and

WHEREAS, Chatham Borough (the "Borough") and Chatham Township (the "Township") have sponsored joint sports programs through the Joint Recreation Advisory Committee (the "Joint Chatham Recreation Program") for over twenty years; and

WHEREAS, the not-for profit sports clubs for Chatham baseball, softball, football, field hockey, soccer, lacrosse, basketball and wrestling (collectively, the "Clubs") manage various sports programs for the Joint Chatham Recreation Program; and

WHEREAS, the Borough and the Township recognize that they will from time to time provide support and assistance to the Clubs through the Borough and Township's respective designees; and

WHEREAS, the Borough and Township recognize that municipal and/or the School District of the Chathams facilities are needed to support participation; and

WHEREAS, the Clubs shall pay the facility maintenance trust fee that is recommended annually by the Joint Recreation Advisory Committee and established by the Chatham Township Committee and Chatham Borough Council that is considered ordinary and commensurate with the fee charged to other sports for same. The fee shall be paid within thirty (30) days from the activity registration closing date. All monies shall be deposited in a dedicated recreation trust account to be held and maintained by the Borough; and

WHEREAS, the Clubs agree to and shall obtain and pay for insurance policy premiums that cover players, coaches and staff to include general liability, basic accident medical, catastrophic accident, directors' and officers' liability and excess liability in amounts satisfactory to the Borough and Township Administrators (limits not less than \$1,000,000 (one million dollars) and naming the Borough of Chatham and the Township of Chatham as additional insured parties); and

WHEREAS, the Clubs agree to indemnify, hold harmless and defend the Joint Recreation Advisory Committee, as well as the Borough, Township and School District of the Chathams, and their respective officials, employees, volunteers and agents, from any and all liabilities, claims, injuries (including death), losses or damages of whatever nature, arising out of or resulting from Club activities; and

WHEREAS, the Clubs shall be responsible for the collection of fees, purchase and issue of uniforms and equipment for all participants as well as the payment of officials and trainers; and

WHEREAS, the Clubs recognize that the Joint Recreation Advisory Committee, in consultation with the Borough, the Township and/or the School District of the Chatham, reserve the exclusive right to change the current facility use model in regards to access, time and/or location as needed; and

WHEREAS, the Clubs agree to maintain communication with the Joint Recreation Advisory Committee regarding program philosophy, annual fees and any changes/additions to the current program content; and

- **WHEREAS**, the Clubs agree to adopt and follow the grievance procedure and Code of Conduct approved by the Joint Chatham Recreation Advisory Committee; and
- **WHEREAS,** the Clubs agree to comply with the Joint Chatham Recreation Program's facility use policy, background check policy and procedures, and training certification (Rutgers S.A.F.E.T.Y. Clinic or evidence that of equivalent training); and
- **WHEREAS,** the Clubs agree to provide the Borough and the Township, upon request, with the participants name and grade, parent names, addresses and e-mail addresses of all the seasonal participants to be used for Joint Chatham Recreation Program's purposes only; and
- **WHEREAS,** non-resident participants will not be added to programs without first obtaining the approval of the Joint Recreation Advisory Committee; and
- **WHEREAS**, the Clubs agree that the Joint Recreation Advisory Committee's designee(s) and liaison(s) shall be invited to attend the Clubs' board meetings; and
- **WHEREAS,** when requested by the Joint Recreation Advisory Committee, a representative of the Clubs' board shall attend and participate in meetings of the Joint Chatham Recreation Advisory Committee as a non-voting member.
- **BE IT RESOLVED,** by the Mayor and Chatham Borough Council that the above recitals are incorporated herein as though fully set forth; and
