Council President Lonergan made a motion to approve Resolution #16-104. Council Member Collander seconded the motion. A voice vote was taken and Resolution #16-104 was approved unanimously.

#### MEETING OPEN TO THE PUBLIC

#### NOTICE OF PUBLIC COMMENT TIME LIMIT

Hearing of citizens during the Public Comment section of the Agenda is an opportunity for any member of the public to be heard about issues, which are/are not topics scheduled for Public Hearing tonight. To help facilitate an orderly meeting, and to permit all to be heard, speakers are asked to limit their comments to a reasonable length of time.

Mayor Harris opened the meeting to the public.

Graeme Dewar, 95 Fairmount Avenue, commented that the residents of Fairmount Avenue, Oliver Street and Orchard Street oppose the proposed development of twelve condominium units on the Stanley Congregational Church property and appealed to the Mayor and Council to reject the applicant's development plan, which he said is not keeping with the zoning regulations of the Borough.

Mayor Harris responded that the developer would be required to go before the Zoning Board of Adjustment and deferred to Mr. Lott to comment on the Zoning Board process. Mr. Lott further responded that a use variance would be required of the applicant, which would go before the Zoning Board of Adjustment. He stated that use variances require certain statutory proofs that the applicant would be required to provide, such as that the site is particularly suitable for the use. He further commented that a hearing would be required to allow opportunity for public comment and that use variances require an affirmative supermajority of votes for approval. The Council will only become involved if there is an appeal of a Zoning Board decision. Property owners who are within 200 feet would receive the required notice of the scheduled hearing date.

Council Member Hoffman, former chair of the Zoning Board of Adjustment, also commented that the public would have opportunities to cross-examine the applicant and the applicant's witnesses and experts and would have opportunities to provide their own testimony why the variance should not be granted.

Mayor Harris reminded everyone that members of the Stanley Congregational Church gave a presentation at a Mayor and Council meeting last July or August [the actual date was July 13, 2015] regarding the church's intention to sell a parcel of its land for a residential sub-development and suggested that individuals could watch that meeting video, which is posted on the Borough website.

Dan McCarthy, 91 Fairmount Avenue, commented that the application to build a twelve-unit condominium building in a single-family neighborhood has generated a lot of controversy in the neighborhood and voiced his opposition to the proposed development.

Caroline McCarthy, 91 Fairmount Avenue, commented that the website preservefairmount.org provides background information and key issues on why the proposed development of twelve condominiums must be opposed. Mrs. McCarthy voiced her opposition to the proposed development and encouraged Borough officials to embrace historic preservation throughout the town.

Mayor Harris responded that the Planning Board establishes land use zoning rules based upon the Borough's Master Plan and reported that the Borough's Master Plan will be re-examined this year to establish new land use goals. He further reported that the first of several Community Forums on the Master Plan update has been scheduled for Thursday, February 18<sup>th</sup> at 7:30 p.m. at the library to allow residents to share their ideas and provide input into the Master Plan and encouraged everyone to attend.

John Kaiser, 10 Oliver Street, voiced his opposition to the proposed development of twelve condominiums and confirmed that the Community Forum for the Master Plan re-examination provides an opportunity for residents and Borough officials to reaffirm what makes Chatham a unique and historic community.

Seeing no one else wishing to comment, Mayor Harris closed the meeting to the public.

#### **DISCUSSION ITEMS**

**2016 Goals and Objectives** – Mr. Falzarano reported that thirty-seven goals have been identified for calendar year 2016. He reported that goals not completed in 2015 have been carried forward to this year. Mr. Falzarano then proceeded with a presentation summarizing goals established for the year. A copy of the 2016 Goals and Objectives will be available on the Borough website.

Mayor Harris provided an update on the Route 124 traffic issue, which has been identified as Goal #37, "Continue to explore solutions for the traffic issues on Main Street (Route 124)." He reported that he spoke with Morris County Freeholder Director DeFillippo on this matter and requested that the county take the lead in addressing traffic congestion problems with the state. Freeholder Director DeFillippo indicated that she would be working on this matter and would keep Mayor Harris informed of the county's efforts.

#### REPORTS

#### **BOARD & COMMISSION MEMBERS & LIAISON REPORTS**

Affordable Housing Advisory Committee - Mayor Harris had nothing new to report.

**Open Space & Historic Preservation Trust Advisory Committee -** Mayor Harris reported that the Assistant Administrator is nearing completion of the Borough's open space inventory.

**Traffic & Pedestrian Safety Advisory Committee -** Council Member Collander reported the Borough is working with Chatham Township regarding traffic issues along Dellwood Avenue.

**Shade Tree Commission -** Council Member Collander reported that the Shade Tree Commission will be focusing on the emerald ash borer and the installation of fencing around the Lum Field scarlet oak tree beginning in early spring.

Communications & Technology Advisory Committee Council President Lonergan reported the committee met last Wednesday, which he could not attend due to business travel, and would provide an update at the next meeting.

**Joint Recreation Advisory Committee -** Council President Lonergan had nothing new to report. He said the committee will be meeting on Tuesday, February 9<sup>th</sup>.

**Municipal Pool Advisory Committee -** Council President Lonergan reported that the committee is looking for volunteers.

**Farmers' Market Advisory Committee** -Council Member Fife reported that the Chatham Farmers' Market Advisory Committee will open its 10<sup>th</sup> season on Saturday, June 11<sup>th</sup>.

**Mayors' Wellness Advisory Committee -** Council Member Fife reported the committee is organizing an Open House event that will include local fitness, wellness, and health-related businesses. This will be a new initiative of the Mayors' Wellness Advisory Committee.

**MyChathamNJ** Advisory Committee - Council Member Fife reported that the committee met on January 29<sup>th</sup> to begin planning this year's Fishawack, which is scheduled to take place on Saturday, June 11<sup>th</sup>. The committee will be meeting again on Tuesday, February 9<sup>th</sup> to begin planning this year's Spring Clean, which is scheduled for Saturday, May 7<sup>th</sup>. This year's focus project will be the beautification of Liberty Park, a small park located at the corner of Lafayette Avenue and Main Street.

**Planning Board -** Council Member Fife reported that a Community Forum for the Master Plan Reexamination is scheduled for Thursday, February 18<sup>th</sup> at the library and encouraged all residents to attend.

**Project Community Pride -** Council Member Fife reported that Chatham Township might become a participant in the Project Community Pride program this year.

**Senior Center of the Chathams** - Council Member Fife reported that the Senior Center of the Chathams has requested an increase in the Borough's annual donation to the Senior Center from \$16,000 in 2015 to \$20,000 for its 2016 budget.

**9/11 Memorial Advisory Committee -** Council Member Helfrich reported that the committee will be planning its 15<sup>th</sup> 9/11 Memorial Service this year.

**Board of Education -** Council Member Helfrich reported that Dr. LaSusa, Superintendent for the School District of the Chathams, will be presenting the school district's budget at the March 28<sup>th</sup> Council meeting.

Joint Municipal Court - Council Member Helfrich had nothing new report.

Municipal Alliance of the Chathams - Council Member Helfrich had nothing new to report.

**Environmental Commission -** Council Member Resto reported that the Environmental Commission is organizing an "Eco-Friendly House of the Year" award program. He further reported that the Environmental Commission will partner with the City of Summit for a trail grant application for a river front trails project. Council Member Resto also reported that the Environmental Commission is developing a recycling pamphlet to encourage recycling and educate the public on the importance of making sure containers are clean for recycling purposes, otherwise they are not recyclable.

**Joint Community Gardens Advisory Committee -** Council Member Resto indicated he would give a more substantive report at the March 14<sup>th</sup> Council meeting when he is scheduled to present a report as a Discussion Item. In the meantime, all farmers will be meeting at the Library on Monday, February 22<sup>nd</sup> at 7:30 p.m. to go over the "do's and don'ts with "Farmer Paul." Council Member Resto further reported there will be 70 farmers with plots and there are still half-plots and quarter-plots available.

**Madison-Chatham Joint Meeting -** Council Member Restoreported there was nothing new to report aside from the ongoing issue of the flow numbers which will hopefully be resolved at the 2/16/15 meeting.

**Pilgrim Pipeline Advisory Committee -** Council Member Resto reported Mayor Harris and the committee have been working with other towns on developing pro-active measures to protect the interests of each of their communities in the event Pilgrim Pipeline files for regulatory permits with the DEP in New Jersey. He reported that Pilgrim has filed regulatory permits in the state of New York.

**Public Arts Council Advisory Committee -** Council Member Resto reported the committee is exploring the idea to paint utility boxes located throughout the Borough.

**Board of Health -** Council Member Hoffman had nothing new to report.

**Historic Preservation Commission -** Council Member Hoffman reported that he attended the Historic Preservation Commission reorganization meeting on January 19<sup>th</sup> and further reported that the commission has selected the annual Preservation Flag Award winner. Collen Foley, chair of the Historic Preservation Commission, will announce the winner of the Preservation Flag Award at a future meeting of the Mayor and Council. Lastly, he mentioned that the Historic Preservation Commission does not have jurisdiction on the proposed development of the Stanley Congregational Church property since the parcel is not within the historic district. However, the commissioners are requesting that the Historic Preservation Commission be given the opportunity to review any application before the Zoning Board of Adjustment.
