WHEREAS, Relay for Life is the signature activity of the American Cancer Society, whose mission is to raise funds to improve cancer survival, decrease the incidence of cancer, and improve the quality of life for cancer patients and their caretakers; and

WHEREAS, at Relay for Life events, communities in the United States and across the globe come together and to raise funds to help make a difference in the fight against cancer; and

Kyra Miller, American Cancer Society Staff Partner, thanked Mayor Harris and the Borough Council for the Proclamation and their support of the 4th Annual American Cancer Society Relay for Life. She stated that last year Chatham Borough raised \$156,000.00 and the goal for this year is \$175,000.00. Ms. Miller invited all Chatham residents to attend this year's Relay for Life event.

Mayor Harris proceeded with Resolution #17-086.

RESOLUTION TO ADOPT COUNCIL MEETING MINUTES

BE IT RESOLVED, by the Council of the Borough of Chatham that the minutes from the following meeting are approved as prepared and shall be filed as a permanent record in the Borough Clerk's office:

January 3, 2017 Reorganization Meeting

Council Member Helfrich made a motion to approve Resolution #17-086. Council Member Lonergan seconded the motion. A vote was taken and Resolution #17-086 was approved unanimously.

DISCUSSION ITEMS

2017 Capital Budget – Mr. Timothy Day, the Borough's Chief Financial Officer, began the 2017 Capital Budget presentation by first setting forth the following Capital Ordinance.

Mr. Day reported that the Finance Committee would like to include the Water and General Capital borrowings for future improvements into the Bond Sale, which is the reason for the Capital Ordinances being done earlier than usual this year.

Mr. Day reported that the \$5,200,000 in short term notes and the two bond ordinances, on for first reading tonight, will be financed into a long term bond, for a total amount of \$6,279,200. He stated that capital spending was down in 2016. He stated that the total capital spending for 2017 is \$1,195,000 but the debt borrowed will be \$935,750 due to the inclusion of two grants received from the State. Additionally, he stated that the total debt for 2016 was less than anticipated.

General Capital Budget

Mr. Day reported that \$935,750 would be funded through the 2017 General Capital Ordinance and presented a list of projects and items that will be funded. The 2017 Road Resurfacing Program, 2017 Drainage Improvement Program and the 2017 Curb and Sidewalk Program are among other programs and items that will be funded through the 2017 General Capital Ordinance.

Water Capital Budget

Mr. Day provided a list of improvements to be funded for the Water Utility. Mr. Day reported that \$151,000 would be funded through the Water Capital Bond Ordinance for those improvements. He reported that the Water Utility had done a great job growing the fund balance using surplus funds. He stated that in a year or two the Borough will be able to utilize pay-as-you-go for capital improvements, which will save on costs.

Present Debt & Future Debt

Lastly, Mr. Day reported on the Borough's total current debt with the addition of the 2017 Borough Capital and possible future projects that include Library of the Chathams improvements, ECLC heating and cooling improvements and sewer plant improvements. He stated that the total amount of debt would be \$21,755,080.

Mr. Falzarano and Mr. Day answered questions from the Council upon conclusion of the 2017 Capital Budget presentation.

MEETING OPEN TO THE PUBLIC

NOTICE OF PUBLIC COMMENT TIME LIMIT

Hearing of citizens during the Public Comment section of the Agenda is an opportunity for any member of the public to be heard about issues, which are/are not topics scheduled for Public Hearing tonight. To help facilitate an orderly meeting, and to permit all to be heard, speakers are asked to limit their comments to a reasonable length of time.

Mayor Harris opened the meeting to the public. Seeing no one wishing to comment, Mayor Harris closed the meeting to the public and proceeded with the Ordinances scheduled for second reading.

REPORTS

COUNCIL COMMITTEE REPORTS

Budget and Finance – Council Member Lonergan reported that the 2017 budget is on track.

Long Range Traffic & Pedestrian Safety Planning - Council Member Collander reported that the Committee is working on upgrading the traffic signal installation at the intersection of Watchung Avenue and Washington Avenue. He reported that the New Jersey Department of Transportation corrected the timing of the traffic signals at North Passaic Avenue and Fairmount Avenue. He also reported that the Committee has met with members of Safe Routes to Schools to discuss safety issues at the Van Doren Middle School entrance. A striped box has been painted in front of Van Doren Middle School and the school will look at changing the interior traffic patterns.

Chief Crosson stated that the plastic pedestrian signs are required to be 25 feet from the crosswalk and requested that residents not move the signs into the intersections. Mr. Collander further reported that residents continue to park under the "No Parking" signs on Dellwood Avenue and warnings have been issued. Tickets will be issued if the warnings do not work. Lastly, Mr. Collander reported that the Police Department will be creating a database of speed monitoring records.

Public Safety & Emergency Services - Council Member Collander reported that the next committee meeting is scheduled for Tuesday, January 24th.

Personnel - Council Member Resto reported that the Police Lieutenant position interviews were conducted on Friday, January 13th. He also reported that the next committee meeting is scheduled for Wednesday, January 25th.

Public Works Planning/Community Services - Council President Fife reported that the Community Services Department is re-creating the Liberty Park landscaping proposal. She reported that the Shade Tree Commission has dedicated funds towards the project. She also reported that the Community Services Department is researching various other grants for the Borough to capitalize on. Lastly, Council President Fife reported that the Department of Public Works has been able to complete additional drainage projects thanks to the mild winter weather.

Shared Services & 3rd Party Agreements - Council Member Helfrich reported that the committee is continuing to evaluate active Shared Services and 3rd Party Agreements. He reported that the Joint Court costs have gone down for the coming year.

MAYOR'S REPORT

Mayor Harris reported that there is nothing new to report regarding Pilgrim Pipeline, but mentioned that the Municipal Pipeline Group will be meeting in a few weeks to follow up on future planning.

ADMINISTRATOR'S REPORT

Mr. Falzarano reported that the Borough received a letter from the Freeholder Director on December 19, 2016 stating that the grant for the Historic Riverside Trail around Shepard Kollock Park was approved, by the Freeholders, in the amount of \$93,710.00. Mr. Falzarano stated that the Department of Public Works plans to begin work on the walking path around Shepard Kollock Pond in the spring. Mr. Falzarano also reported that time is being spent prepping the 2017 Budget, Annual Report and 2017 Goals and Objectives. He thanked the Mayor and Council for taking the time to review the 2017 Goals & Objectives.

Mayor Harris stated that the Borough has hired a special planner, Phil Abramson, to conduct the study and select the parcels that will be reviewed.

AN ORDINANCE OF THE MAYOR AND COUNCIL OF THE BOROUGH OF CHATHAM, COUNTY OF MORRIS, STATE OF NEW JERSEY AMENDING CHAPTER 75 OF THE BOROUGH CODE TO REGULATE THE SALE OF ALCOHOLIC BEVERAGES

Mayor Harris explained that the purpose of this Ordinance is to change the hours of sale for alcoholic beverages. Mayor Harris stated that he had started to create a chart to show the hours of sale and asked Mr. Lott to explain the chart and changes made to the existing ordinance.

Mr. Lott advised that the existing ordinance is outdated and stated that the new ordinance distinguishes hours of sale for on-premises consumption sales, as well as, off-premises distribution sales. The updated ordinance establishes hours of sale for Saturdays and clarifies hours of sales for Christmas and New Year's Day. Section C allows establishments with liquor licenses to remain open provided that they provide other business services, such as hotels and drug stores.

Council Member Helfrich inquired if there is a need to distinguish separate hours for Christmas and New Year's Day. He suggested that the hours of sale should be for Monday through Friday and Saturday through Sunday. Mayor Harris agreed that the distinction for holiday hours was unnecessary. Mr. Lott advised that he would prepare an amendment that removes special holiday hours from the proposed Ordinance.

Mayor Harris asked Council President Fife to proceed with Ordinance #17-03, as amended to remove special holiday hours, and move for introduction on First Reading.
