PROCLAMATION

RESOLUTION #19-200

RESOLUTION DECLARING NATIONAL GUN VIOLENCE AWARENESS DAY JUNE 7, 2019

WHEREAS, according to the latest CDC data, there were 39,773 gun-related deaths in the United States in 2017, the highest rate in more than twenty years and one that amounts to a daily average of in excess of 108 fatalities; and

WHEREAS, this same CDC data shows that 14,542 of these victims were killed in gunrelated homicides and 23,854 in gun-related suicides; and

WHEREAS, a recent study from the Jama Network found that just six nations were responsible for more than half of the estimated 251,000 gun-related fatalities worldwide in 2016, namely the United States, Brazil, Mexico, Colombia, Venezuela, and Guatemala; and

WHEREAS, a joint Organization for Economic Co-operation and Development (OECD) and World Health Organization (WHO) study conducted in 2010, found that gun-related homicide rates in the United States for the year 2010 were at least 25.2 times higher than in any other high-income (OECD) nation; and

WHEREAS, support for the Second Amendment rights of law-abiding citizens is consistent with keeping guns away from people deemed to be either a societal or personal threat due to a violent criminal record, extreme moral turpitude, or serious behavioral infirmity; and

WHEREAS, in January 2013, Hadiya Pendleton, a teenager who marched in former President Barack Obama's second inaugural parade, and who was tragically shot and killed just weeks later, would now be celebrating her 22nd birthday; and

WHEREAS, to remember and honor Hadiya, along with the 108 Americans on average whose lives are cut short every day (not to mention the countless survivors injured every day) due to gun-related violence, a national coalition of organizations has designated June 7, 2019 as the 5th National Gun Violence Awareness Day; and

WHEREAS, the idea of proclaiming a National Gun Violence Awareness Day was originally inspired by a group of Hadiya's friends who requested their classmates commemorate her life by wearing the color orange on a suitably selected day, a color so chosen due to the propensity of hunters in the woods to don this hue for personal protection and its universal symbolism of the value of human life; and

WHEREAS, anyone can join this campaign of remembrance and commemoration by pledging to wear the color orange on June 7, 2019, and in so doing, help raise awareness of the tragic numbers of Americans currently dying each and every year due to gun-related injuries; and

WHEREAS, through participation in this campaign, Americans everywhere will be registering their horror over the shocking prevalence of gun violence in this country, and equally, honoring the lives of its many victims and survivors; and

WHEREAS, by wearing the color orange on June 7, 2019, citizens everywhere will be expressing their commitment to the reduction of gun violence and pledging to do all they can to keep firearms out of the wrong hands, encourage responsible gun ownership, and protect our children.

BE IT RESOLVED, by the Mayor and the Council of the Borough of Chatham, that June 7, 2019 shall be declared National Gun Violence Awareness Day and all residents are encouraged to join together to support all efforts to prevent the tragic effects of gun violence and to honor and value human lives everywhere.

RESOLUTION REQUIRING SEPARATE ACTION

RESOLUTION #19-202

RESOLUTION OF THE BOROUGH COUNCIL OF THE BOROUGH OF CHATHAM, IN THE COUNTY OF MORRIS, NEW JERSEY, COVENANTING TO COMPLY WITH THE PROVISIONS OF THE INTERNAL REVENUE CODE OF 1986, AS AMENDED, APPLICABLE TO THE EXCLUSION FROM GROSS INCOME FOR FEDERAL INCOME TAX PURPOSES OF INTEREST ON OBLIGATIONS ISSUED BY THE BOROUGH OF CHATHAM AND AUTHORIZING THE MAYOR, ACTING BOROUGH CLERK, CHIEF FINANCIAL OFFICER AND OTHER BOROUGH OFFICIALS TO TAKE SUCH ACTION AS THEY MAY DEEM NECESSARY OR ADVISABLE TO EFFECT SUCH COMPLIANCE AND DESIGNATING A \$1,423,750 BOND ANTICIPATION NOTE, DATED MAY 24, 2019, PAYABLE MAY 22, 2020, AS A "QUALIFIED TAX-EXEMPT OBLIGATION" PURSUANT TO SECTION 265(b)(3) OF THE INTERNAL REVENUE CODE OF 1986, AS AMENDED.

WHEREAS, the Borough of Chatham, in the County of Morris, New Jersey (the "Borough") from time to time issues bonds, notes and other obligations, the interest on which is excluded from gross income for Federal income tax purposes, and desires to take such action as may be necessary or advisable to establish and maintain such exclusion; and

WHEREAS, the Internal Revenue Code of 1986, as amended (the "Code"), contains provisions with respect to the exclusion from gross income for Federal income tax purposes of interest on obligations, including provisions, among others, which require issuers of tax-exempt obligations, such as the Borough to account for and rebate certain arbitrage earnings to the United States Treasury and to take other action to establish and maintain such Federal tax exclusion; and

WHEREAS, the Borough has issued a \$1,423,750 bond anticipation note, dated May 24, 2019, payable May 22, 2020 (the "Note"); and

- **WHEREAS**, the Borough desires to designate the Note as a "qualified tax-exempt obligation" pursuant to Section 265(b)(3) of the Code;
- **NOW, THEREFORE, BE IT RESOLVED** by the Borough Council of the Borough of Chatham, in the County of Morris, New Jersey, as follows:
- **SECTION 1**. The Borough Council hereby covenants on behalf of the Borough, to the extent permitted by the Constitution and the laws of the State of New Jersey, to do and perform all acts and things permitted by law and necessary to assure that interest paid on the Note be and remain excluded from gross income of the owners thereof for Federal income tax purposes pursuant to Section 103 of the Code.
- **SECTION 2**. The Mayor, Acting Borough Clerk, Chief Financial Officer and the other officials of the Borough are hereby authorized and directed to take such action, make such representations and give such assurances as they may deem necessary or advisable to effect compliance with the Code.
- **SECTION 3**. The Note is hereby designated as a "qualified tax-exempt obligation" for the purpose of Section 265(b)(3) of the Code.
- **SECTION 4**. It is hereby determined and stated that (1) said Note is not a "private activity bond" as defined in the Code and (2) the Borough and its subordinate entities, if any, do not reasonably anticipate issuing in excess of \$10 million of new money tax-exempt obligations (other than private activity bonds) during the calendar year 2019.
- **SECTION 5**. It is further determined and stated that the Borough has not, as of the date hereof, issued any tax-exempt obligations (other than the Note) during the calendar year 2019.
- **SECTION** 6. The Borough will, to the best of its ability, attempt to comply with respect to the limitations on issuance of tax-exempt obligations pursuant to Section 265(b)(3) of the Code; however, said Borough does not covenant to do so, and hereby expressly states that a covenant is not made hereby.
- **SECTION 7**. The issuing officers of the Borough are hereby authorized to deliver a certified copy of this resolution to the original purchaser of the Note and to further provide such original purchaser with a certificate of obligations issued during the calendar year 2019 dated as of the date of delivery of the Note.
- **SECTION 8**. This resolution shall take effect immediately upon its adoption and shall ratify all prior actions of Borough officials in connection with the issuance of Bond Anticipation Notes as set forth herein.

WHEREAS, on January 17, 2018, the Planning Board, having accepted the findings of the "Preliminary Investigation of Post Office Plaza, Chatham, New Jersey" report (the "Redevelopment Investigation Report") and having conducted a hearing thereon, adopted a Memorializing Resolution accepting the findings of the Redevelopment Investigation Report concluding that Block 121, Lots 11 and 17 and Block 122, Lots 13 through 18 (Bowers Lane), Block 121, Lots 10, 12 and 13 (South Passaic Avenue) and Block 122, Lots 1 and 2 (Main Street) (but not including Block 121, Lot 14) (collectively, "Post Office Plaza Study Area"), met the criteria for designation as a non-condemnation area in need of redevelopment under the Local Redevelopment and Housing Law, N.J.S.A.40A:12A-1, et seq. (the "Redevelopment Law") and recommended that the Council designate the Post Office Plaza Study Area as a non-condemnation Redevelopment Area in need of redevelopment pursuant to the Redevelopment Law, and

WHEREAS, on February 12, 2018, the Council adopted Resolution #18-101 designating the Post Office Plaza Study Area as a non-condemnation Redevelopment Area, and

WHEREAS, the Council of the Borough of Chatham wishes to act as the Redevelopment Entity for the Post Office Plaza Study Area.

WHEREAS, the matter was settled, and the Court granted the Borough Substantive Certification and Judgment of Compliance and Repose by Order dated September 9, 2016; and

WHEREAS, the Council on Affordable Housing (COAH), when it was operational, set income limits for each of the COAH housing regions, which were then used to determine eligibility for affordable housing and setting rent increase for existing affordable housing; and

WHEREAS, COAH is no longer operational and has not published income limits or rent increases since 2014; and

WHEREAS, the Court has found it necessary to establish income limits and rent increases based on COAH's methodology for setting such income limits and rent increases; and

WHEREAS, the Borough Attorney has negotiated a form of consent order with Fair Share Housing Center to establish income limits and rent increases and proposes to file same with the Court.

BE IT RESOLVED, by the Mayor and Council of the Borough of Chatham in the County of Morris and the State of New Jersey, that the Borough hereby authorizes the Borough Attorney to file a consent order with the Court to establish income limits and rent increases. The form of consent order shall be satisfactory to the Borough Attorney.

BE IT FURTHER RESOLVED, the matter(s) discussed will be made known to the public at such time as appropriate action is taken on said matter(s), and when disclosure will not result in unwarranted invasion of individual privacy or prejudice to the best interests of the Borough of Chatham, provided such disclosures will not violate Federal, State or local statutes and does not fall within the attorney-client privilege. The Borough Council will not return to public session after this closed session.
