Council member Mathiasen made a motion to approve Resolution #19-130. Council Member Kobylarz seconded the motion. A vote was taken and Resolution #19-130 was approved unanimously.

DISCUSSION ITEMS

Future City – Chatham Middle School 7th grade students Aiden Bernstein, Sophia Melgarejo, Natalie Yen, and Tanya Mouline presented their "Future City" project to the Mayor and Council. The students' "Future City" entry won First Place in the New Jersey competition held at Rutgers University and won Third Place in the 2019 National competition finals, which included competitors from 47 states. "Future City" is a Science, Technology, Engineering, and Math (STEM) project-based learning program where middle school students research, design, and build cities of the future.

The students' project featured a model that was made with all recyclable materials representing a future island city located in Japan in the East China Sea. In their presentation, they explained all of the components featured in their "Future City." Electrical power and energy needs are provided by sustainable geothermal, tidal, wind and solar energy generation. Power not used is stored in batteries. To help protect the residents from a natural disaster, an advanced tsunami protection system was designed that includes coral reefs, mangrove forests, a tsunami protection gate and buildings that allow flood

waters to pass through. A micropower grid distribution system using magnetic induction can withstand and quickly recover from the impacts of a tsunami. Elevated buildings and an elevated superhighway were engineered to help prevent loss of life in the event a tsunami should occur.

Mayor Harris and the Borough Council applauded the students for their achievement and encouraged their continued studies in the science, technology, engineering, and math fields.

Acceptable Sewer Materials – Mr. Williams reported that paper towels, wipes and other hygiene products should never be disposed of in the sanitary sewer system, but rather these items should be disposed of with household garbage. In his presentation, he showed photographs of how these products can clog and damage sanitary sewer lines and pumps, causing costly repairs. Mr. Williams cautioned that although these products are advertised as flushable, they do not degrade in the sanitary sewer system and must be physically removed.

Mayor Harris proceeded with opening the meeting for public comment on other matters.

MEETING OPEN TO THE PUBLIC

NOTICE OF PUBLIC COMMENT TIME LIMIT

Hearing of citizens during the Public Comment section of the Agenda is an opportunity for any member of the public to be heard about issues which are/are not topics scheduled for Public Hearing tonight. To help facilitate an orderly meeting, and to permit all to be heard, speakers are asked to limit their comments to a reasonable length of time.

Richard Driscoll, 74 South Gate Road, New Providence, voiced his objections to Resolution #19-136. He commented that a pending Division of Alcoholic Beverage Control investigation has charged the business with several violations that could lead to suspension or revocation of the liquor license and commented that he did not believe the liquor license is in good standing.

Peter Schwab, 30 Edgewood Road, Madison, introduced himself as one of the owners of Chatham Towne Tavern, the liquor licensee that is the subject of Resolution #19-136. He commented that Mr. Driscoll had been involved in a fight at his establishment and has not been allowed to return. Mr. Schwab further commented that his business is a family-oriented one and mentioned that he is cooperating with the Division of Alcoholic Beverage Control in its investigation.

Mr. Lott advised the Mayor and Council that the pending Division of Alcoholic Beverage Control has no bearing on the action to be taken concerning Resolution #19-136.

Bill Heap, Hillside Avenue, questioned whether school students would be statistically safer with police officers carrying guns in the schools. He voiced his opposition to the hiring and placement of special law enforcement officers in the schools and encouraged more public discussion on this issue.

Rozella Clyde, 33 Carmine Street, voiced her objection to Ordinance #19-03 and commented that law enforcement officers with guns do not belong in schools. She further suggested that students should be heard on this subject before Borough officials proceed further with the Ordinance.

Duncan Carmichael, 59 Chatham Street, a student at Seton Hall Preparatory School in West Orange, commented that guns have an intimidating presence and do not belong in schools and voiced his objection to law enforcement officers having guns in the schools.

Seeing no one else wishing to comment, Mayor Harris closed the meeting to the public and proceeded with the Council Committee Reports.

ORDINANCES FOR SECOND READING

Mayor Harris asked Council President Collander to proceed with Ordinance #19-03.

Council President Collander read Ordinance #19-03 entitled:

AN ORDINANCE OF THE MAYOR AND COUNCIL OF THE BOROUGH OF CHATHAM, COUNTY OF MORRIS, STATE OF NEW JERSEY AMENDING CHAPTER 48 OF THE BOROUGH CODE TO AUTHORIZE THE APPOINTMENT OF CLASS THREE SPECIAL LAW ENFORCEMENT OFFICERS

Which Ordinance was introduced and passed on first reading at a regular Council meeting held on February 11, 2019.

Council President Collander mentioned that this Ordinance creates the Class III Special Law Enforcement Officer position in the Police Ordinance.

Mayor Harris asked the Borough Clerk to give a summary of the legal notice.

The Borough Clerk stated that a legal notice was published indicating that Ordinance #19-03 was introduced and passed on first reading at the February 11, 2019 meeting and indicated the second reading and public hearing would be held at 7:30 p.m. on February 25, 2019 for consideration of final adoption. Copies of this Ordinance were made available to the general public and posted in accordance with the law.

Mayor Harris opened the public hearing on the Ordinance and invited any member of the public to be heard.

Rozella Clyde, 33 Carmine Street, questioned how many Class III Police Officers would be designated.

Mayor Harris responded that the Ordinance specifies that no more than one person shall be designated as a Class III special law enforcement officer.

Seeing no one else wishing to be heard, Mayor Harris closed the public hearing.

Council Member Weber reminded those present that the Governing Body had begun discussing the matter of Special Law Enforcement Officers (SLEOs) in March 2018 at the time when the Board of Education began its discussion. He reported that Borough officials received a letter from the Superintendent of the School District of the Chathams in April 2018, which sought a SLEO in each school. Council Member Weber further mentioned that the Board of Education is the policy-making body for the school district and encouraged residents to make their objections known to the Board of Education. He also mentioned that the school district would be paying the cost of the SLEOs, whose primary role in addition to providing additional security and safety in the schools would be to develop a trust with students so that they would be comfortable reporting something heard or seen on social media.

Council Member Weber, Council Member Kobylarz, Council President Collander, Council Member Fife and Council Member Dempsey each expressed their support for the Ordinance, citing, among other things, that the core mission of a SLEO is preventing school shooting incidents from happening. They also agreed that public safety in schools is of paramount importance to ensure the protection, security and safety of the faculty and students.

Council Member Mathiasen commented that because the SLEO would be a member of the Chatham Borough Police Department and would report to the Chief of Police, the Governing Body becomes part of the decision-making process and mentioned there has not been enough public dialogue on the issue. She reported statistical data concerning school shootings and gun crimes in the country mentioned that New

Jersey's strict gun laws have proven to be effective when compared nationally. She further commented that the SLEO would have no role in discipline, dealing with fights, drugs, or other routine security or behavioral issues in the school and voiced her opposition to the Ordinance.

Mayor Harris clarified that the Ordinance simply creates the Class III special law enforcement position on the police force and mentioned that this issue will come before the Governing Body again at the time the shared services agreement with the Board of Education will be acted on.

Council President Collander offered the following Ordinance and moved its adoption:

REPORTS

BOARD & COMMISSION MEMBERS & LIAISON REPORTS

Shade Tree Commission - Council President Collander reported that JCP&L has notified the Borough that crews will be performing tree-trimming activities and will be removing 54 ash trees due to the emerald ash borer and yellow ash blight disease. Borough officials will be meeting with JCP&L representatives to further discuss this matter.

Affordable Housing Advisory Committee - Council President Collander had nothing new to report.

Traffic & Pedestrian Safety Advisory Committee - Council President Collander had nothing new to report.

Farmers' Market Advisory Committee - Council Member Fife had nothing new to report.

Historic Riverside Trail Advisory Committee - Council Member Fife had nothing new to report.

Mayor's Wellness Advisory Committee - Council Member Fife reported that the committee is waiting to hear the results on its Healthy Town application that was submitted last month.

MyChathamNJ Advisory Committee - Council Member Fife reported that the committee has begun its planning for this year's Spring Clean and Fishawack Festival.

Municipal Pool Advisory Committee - Council Member Fife reported that a meeting is being scheduled.

Project Community Pride - Council Member Fife had nothing new to report.

Public Arts Council Advisory Committee - Council Member Fife had nothing new to report.

Senior Center of the Chathams - Council Member Fife reported that she and other Borough officials attended a luncheon at the senior center that was sponsored by Jim Connelly and Julie Reich, the new Executive Director.

Board of Health - Council Member Weber reported that the board held its rescheduled 2019 Reorganization Meeting on February 14th and welcomed its newest member, Andrew Zoltan.

Joint Recreation Advisory Committee - Council Member Weber reported that the February 12th meeting was cancelled due to the weather.

9/11 Memorial Advisory Committee - Council Member Weber had nothing new to report.

Madison Chatham Joint Meeting - Council Member Weber reported that the 2019 budget is being prepared. Budget expenditures will be allocated based on a 62% split to Madison Borough and a 38% split to Chatham Borough.

Undergrounding Advisory Committee - Council Member Kobylarz reported that the committee's inaugural meeting was held on February 15th. Len Resto was appointed as Chair.

Planning Board - Council Member Kobylarz reported that the Planning Board approved the application of a French bakery and café on Main Street at the February 20th meeting.

Joint Community Gardens Advisory Committee - Council Member Kobylarz reported that garden plots are still available and that there is one Borough vacancy on the committee's executive board that should be filled. A gardeners meeting will be held at the Library of the Chathams on March 26th.

Joint Municipal Court - Council Member Kobylarz had nothing new to report.

Historic Preservation Commission - Council Member Dempsey reported that the Commission met with Topology to discuss the Post Office Plaza redevelopment planning project. She further reported that the Commission is considering designating additional historic landmarks in town and mentioned that Shepard Kollock Park will be explored.

Board of Education - Council Member Dempsey reported that the school district is discussing the creation of a full-time Kindergarten pilot program.

Municipal Alliance of the Chathams - Council Member Dempsey reported that the Municipal Alliance of the Chathams participated in a "Keep it Legal" alcohol prevention program at local liquor stores before Superbowl Sunday.

Open Space & Historic Preservation Trust Advisory Committee - Council Member Carolyn Dempsey had nothing new to report.

Environmental Commission - Council Member Jocelyn Mathiasen reported that the Commission met on February 13th and will be working on an RFP with Chatham Township for chemical-free maintenance of sports fields. She further reminded residents that only those plastic items marked as PET "1", "2", and "5" can be recycled. Other plastics and plastic bags cannot be recycled and should be disposed of in the garbage.

Communications & Technology Advisory Committee - Council Member Jocelyn Mathiasen reported that the committee met on February 13th and discussed ways to improve public engagement through communication, automated practices and TV programming initiatives.

MAYOR'S REPORT

ADMINISTRATOR'S REPORT

Mr. Williams reported that two trees fell during the high wind event on Sunday. He also reported that PSE&G's Low-Income Home Energy Assistance Program (LIHEAP) provides assistance to its customers with heating costs. Information about the program is posted on the Borough website. Mr. Williams thanked the Public Works Department crews for their good work in clearing the roads during the recent snow and ice events.

Council Member Weber requested to remove Resolution #19-136 from the Consent Agenda for discussion and vote.

RESOLUTION #19-136

RESOLUTION APPROVING THE PLACE-TO-PLACE (EXPANSION OF PREMISES) TRANSFER FOR CHATHAM TOWNE TAVERN, INC., LICENSE NO. 1404-33-002-005

WHEREAS, Chatham Towne Tavern, Inc., doing business as The River Grille, (the "Applicant") filed a 12-page application with the Borough of Chatham seeking a Place-to-Place (Expansion of Premises) Transfer for Plenary Retail Consumption License #1404-33-002-005 for the purpose of expanding the premises located at 34 River Road, Chatham, New Jersey for the authorized sale, service and storage of alcoholic beverages; and

WHEREAS, the Borough Clerk has verified that the subject license is in good standing for the current 2018-2019 licensing term and has confirmed that the Applicant's 12-page application has been deemed complete in all respects, that all applicable fees have been paid, and that the New Jersey Division of Taxation has issued the required Tax Clearance Certificate; and

WHEREAS, the Borough Clerk has confirmed that the Applicant had published the required public notice in the Daily Record, a newspaper with a daily general circulation in the County of Morris, on August 30, 2018 and on September 6, 2018, stating that the Applicant applied to the Borough of Chatham for a Place-to-Place (expansion of premises) transfer and that objections to the application, if any, should be made in writing and addressed to the Borough Clerk as required by law; and

WHEREAS, the Borough Clerk has further confirmed that no objections were filed, either written or in person, with respect to the Place-to-Place (Expansion of Premises) Transfer of the herein referenced liquor license; and

WHEREAS, the Detective Bureau of the Chatham Borough Police Department has completed fingerprinting and background investigations for all parties having an ownership interest in the liquor license and has confirmed that all parties having an ownership interest in the liquor license have been fully qualified; and

WHEREAS, a public health inspection was duly conducted at the Applicant's premises in accordance with N.J.S.A. 33:1-24 and the Borough of Chatham Board of Health regulations; and

WHEREAS, the Place-to-Place (Expansion of Premises) Transfer of the subject license will include the entire basement area of the premises for the storage of alcoholic beverages and the first floor and front outdoor dining patio of the premises for the storage, sales and service of alcoholic beverages as the licensed premises, which is contingent upon the approval of the Mayor and Council.
