She introduced Chatham's volunteer event coordinator, Ella, who reported that 472 participants attended last year's event and raised approximately \$89,000.00. RESOLUTION #19-92

RESOLUTION SUPPORTING THE MAYOR'S WELLNESS ADVISORY COMMITTEE IN CELEBRATING THE MONTH OF FEBRUARY AS AMERICAN HEART MONTH AND OBSERVING FRIDAY, FEBRUARY 1, 2019 AS NATIONAL WEAR RED DAY®

WHEREAS, maintaining a strong heart is key to a long and healthy life; and

WHEREAS, cardiovascular disease is the number one killer of men and women in the United States and is responsible for one out of every four deaths; and

WHEREAS, while anyone can develop heart disease, those with high blood pressure or high cholesterol, as well as those who smoke, are at greater risk. Risk factors like diabetes, obesity, poor diet, physical inactivity, and excessive alcohol use can also increase the likelihood of developing heart disease; and

WHEREAS, the volunteers of the Mayor's Wellness Advisory Committee remain committed in their efforts to increase awareness in our community of the importance of cardiovascular health by promoting healthy habits, such as getting regular exercise, eating diets rich in fruits and vegetables and low in salt, saturated fat, and cholesterol, and not smoking to help reduce one's risk of developing cardiovascular disease; and

WHEREAS, the month of February is American Heart Month; and

WHEREAS, the first Friday in February is National Wear Red Day®, a day when many people wear red to show their support for the awareness of heart disease.

BE IT RESOLVED, by the Mayor and Council of the Borough of Chatham, that they hereby support and join the Mayors' Wellness Advisory Committee in their efforts to increase awareness of cardiovascular health in the Borough by celebrating the month of February as American Heart Month and encourage all citizens to show their support and solidarity for those struggling with heart disease by wearing red on National Wear Red Day[®].

Council Member Fife made a motion to approve Resolution #19-92. Council Member Kobylarz seconded the motion. A vote was taken and Resolution #19-92 was approved unanimously.

Council Member Fife presented the National Wear Red Day[®] Resolution to Brian George, Chair of the Mayors' Wellness Advisory Committee. Mr. George thanked Mayor Harris and the Council for the Borough's efforts in bringing awareness to cardiovascular health and for helping to promote American Heart Month. He further thanked Janice Piccolo for submitting a Heathy Town Application on behalf of the Mayors' Wellness Advisory Committee.

PRESENTATIONS

Chatham Borough Police Department Accreditation

Mayor Harris introduced Mr. Harry Delgado, Accreditation Program Manager with the New Jersey Association of Chiefs of Police.

Mr. Delgado opened his presentation by stating that the Chatham Borough Police Department is recognized as being one of the best in the state, and in the nation. He stated that there are over 560 police agencies in the state of New Jersey eligible for accreditation under the New Jersey Association of Police Chiefs standards; however, approximately only 35 percent make it through the accreditation process. Of that number, only 12 percent of those police departments will achieve a second reaccreditation.

He advised that accreditation is a rigorous process, requiring support from elected officials, strong leadership from the Chief of Police, and the engagement from all rank and file officers in the police force. Mr. Delgado emphasized that accreditation provides evidence of a police agency's commitment to excellence in meeting the community's needs. He specifically recognized the Chatham Borough Police Department for achieving its third reaccreditation without any flaws in their adherence to best practices. He mentioned that less than one percent of police departments make it through a second accreditation without any deviations to best practices.

Mr. Delgado proceeded to present Chief Gibbons with the Police Accreditation Certification to the Chatham Borough Police Department. He congratulated Chief Gibbons, the Chatham Borough Police Department, Mayor Harris and the Borough Council for their accomplishment and stated that the Chatham Borough Police Department joins a very exclusive group of law enforcement agencies. Chief Gibbons accepted the Certificate of Accreditation on behalf of the Chatham Borough Police Department.

Mayor Harris and the Borough Council congratulated Chief Gibbons and the men and women of the Police Department in achieving reaccreditation and expressed their thanks and appreciation for the department's excellence in policing.

Woman's Club Donation to the Police Department and Fire Department

Ms. Terry Kandalaft, President of the Woman's Club of Chatham announced that the Woman's Club of Chatham will be dissolving its charter this coming May after serving the community for over 100 years. As the organization winds up its operations, she said it has been dispersing its reserve funds to several local organizations. She mentioned that the Woman's Club of Chatham recently donated \$50,000 to the Chatham Emergency Squad and donated \$30,000 to the Chatham Township Police Department. Donations have also been made to the Library of the Chathams as part of a commitment to build a "Teen Room" in the library and she said that funds have also been earmarked for annual scholarships for Chatham High School students.

President Kandalaft then presented a \$30,000 check to Police Chief Gibbons for the Chatham Borough Police Department's use and presented a \$20,000 to Fire Chief Fricke for the Chatham Borough Volunteer Fire Department's use, with a request that the amounts be used to continue their excellent job of protecting the well-being and safety of the citizens of Chatham.

Mayor Harris and the Borough Council thanked President Kandalaft and the Woman's Club of Chathams for their generous donations.

BE IT RESOLVED, by the Mayor and Council of the Borough of Chatham that Tyler Kidd is hereby appointed as a member of the Junior Firemen's Auxiliary Company of the Chatham Borough Volunteer Fire Department.

Council President Collander made a motion to approve Resolution #19-93. Council Member Weber seconded the motion. A vote was taken and Resolution #19-93 was approved unanimously.

Mayor Harris and the Borough Council congratulated Tyler Kidd on his appointment and thanked him for his service as a member of the Junior Firemen's Auxiliary Company of the Chatham Borough Volunteer Fire Department.

RESOLUTION TO ADOPT COUNCIL MEETING MINUTES

BE IT RESOLVED, by the Council of the Borough of Chatham that the minutes from the following meeting are approved as prepared and shall be filed as a permanent record in the Borough Clerk's office:

January 7, 2019 Reorganization Meeting

Council President Collander made a motion to approve Resolution #19-94. Council Member Kobylarz seconded the motion. A vote was taken and Resolution #19-94 was approved unanimously.

RECUSALS

Mayor Harris asked if there are any recusals or abstentions to be submitted for the record with respect to any item listed on the agenda.

There were no recusals.

DISCUSSION ITEMS

Eagle Scout Project – Matt Castellano, a scout with Troop #8, sought permission from the Mayor and Council to create bird sanctuaries, consisting of the construction of three birdhouses at Kelley's Pond and three birdhouses in Shepard Kollock Park. He said that each birdhouse would have different size holes to attract different bird species and would be mounted on a ten-foot high pole that is anchored in the ground and supported in place by concrete footings. The birdhouses can be unscrewed from the poles for maintenance or replacement if necessary. In addition, he said that the kiosk at Kelley's Pond would be updated to include details about local birds and their habitat.

Mayor Harris and the Borough Council thanked Matt Castellano for his presentation and provided consent for him to move forward with his Eagle Scout project. An authorizing resolution will be placed on the February 11th Mayor and Council Agenda.

Incubator – Council Member Kobylarz introduced a plan for a High Tech/Innovative Hub initiative in Chatham Borough. He reported that the Borough is partnering with the Morris County Economic Development Corporation ("MCEDC") to lead a county-wide campaign to brand Morris County as a region focusing on high-tech and innovative entrepreneurial activity.

Council Member Kobylarz mentioned that the Borough would be central for this initiative and that working space will be developed in the Garibaldi Building on Fairmount Avenue in April. The working space will be called the Chatham Innovation Center and will serve as the focal point to attract high-tech innovative businesses.

He further mentioned that the purpose of the High Tech/innovation Hub initiative is to revitalize Chatham Borough's downtown economy and close its fiscal gap by attracting more e-commerce workers to the Borough to occupy approximately 15,000 square feet of vacant office space. The initiative will also help spawn smart redevelopment that will encourage the development of a secondary supporting economy and enterprises such as internet cafes, daytime eateries, bookstores, specialty food shops, clothier and novelty boutiques.

Best Practices – Timothy Day, Chief Financial Officer, provided a summary of the Borough's completed 2018 Best Practices Inventory worksheet. The Best Practices Inventory contains 61 scored questions, which he reported every municipality must file with the state. In addition to allowing "Yes" or "No" answers, certain questions allow the option of answering "Not Applicable" or that compliance will be "Prospective." The spreadsheet automatically computes the score with "Prospective" and "Not Applicable" counted as positive answers for purposes of scoring.

New for the calendar year 2018, Mr. Day reported that all questions have been condensed into two categories: Core Competencies and Additional Best Practices. Municipalities would need to answer a minimum of 46 of the 61 scored questions as either "Yes," "Prospective" or "Not Applicable" to receive 100% funding of the Consolidated Municipal Property Tax Relief (CMPTRA) and Energy Tax Receipts (ETR) from the state. Mr. Day confirmed that the Borough answered 54 of the scored questions as "Yes," "Prospective" or "N/A".

Mayor Harris recommended that the Council should review the questions on the Best Practices Inventory worksheet where a response of "No" was provided for future consideration.

Mayor Harris proceeded with opening the meeting for public comment on other matters.

MEETING OPEN TO THE PUBLIC

NOTICE OF PUBLIC COMMENT TIME LIMIT

Hearing of citizens during the Public Comment section of the Agenda is an opportunity for any member of the public to be heard about issues which are/are not topics scheduled for Public Hearing tonight. To help facilitate an orderly meeting, and to permit all to be heard, speakers are asked to limit their comments to a reasonable length of time.

Rozella Clyde, 33 Carmine Street, thanked Council Member Kobylarz for his earlier presentation on the Borough's High Tech/Innovation Hub initiative and expressed her full support. She also voiced some concerns with the recent Planet Civic survey, which she said only presented a narrow selection of building styles and images for respondents to consider. Further, the way the survey questions were posed, she said, limited the number of comments that may have otherwise been given by respondents.

Mayor Harris reported that the Planet Civic surveys have not been the only tool used by the Borough for public outreach with respect to the Post Office Plaza Redevelopment planning project. He mentioned that several public presentations have been scheduled as well and that public participation has always been encouraged throughout the process.

Seeing no one else wishing to comment, Mayor Harris closed the meeting to the public and proceeded with the Council Committee Reports.

Communications & Technology Advisory Committee - Council Member Jocelyn Mathiasen reported that a planning meeting was held with Borough officials to discuss and prioritize the Borough's technology needs. She also mentioned that the committee is looking for interested volunteers.

MAYOR'S REPORT

Mayor Harris announced that a Volunteer Leadership Training Workshop pertaining to the Open Public Meetings Act and the Open Public Records Act is scheduled for Thursday, January 31st at 7:00 p.m. in Borough Hall. He mentioned that the workshop presentation will be given by the Municipal Clerks' working for Madison Borough, Chatham Borough and Chatham Township and that all volunteers, as well as Council Members are encouraged to attend the training workshop.

ADMINISTRATOR'S REPORT

Mr. Williams reported that the installation of fencing for the designated off-leash area at Shepard Kollock Park has been completed. He reminded dog owners to ensure that their dogs are always kept on a leash when walking their dogs in the park outside of the off-leash area and mentioned that the Police Department will be ending its courtesy warnings and will begin to issue citations. Mr. Williams reported that the Planet Civic survey ends on January 30th. He also reminded residents that they should report any concerns they may have with garbage collection, or any other any concern, by submitting a request using the Borough's "Report a Concern" button on the website.

Mayor Harris further mentioned that residents can download the SeeClickFix app on their smartphones to easily report concerns in the Borough. He further mentioned that the SeeClickFix platform allows Borough officials to keep track of reported issues and that all submitted requests are acknowledged and answers are provided to keep everyone informed of the status.

RESOLUTION REQUIRING SEPARATE ACTION

RESOLUTION #19-95

RESOLUTION OF THE BOROUGH OF CHATHAM, IN THE COUNTY OF MORRIS, NEW JERSEY, DETERMINING THE FORM AND OTHER DETAILS OF ITS "NOTE RELATING TO THE CONSTRUCTION FINANCING LOAN PROGRAM OF THE NEW JERSEY INFRASTRUCTURE BANK", TO BE ISSUED IN THE PRINCIPAL AMOUNT OF UP TO \$2,730,000, AND PROVIDING FOR THE ISSUANCE AND SALE OF SUCH NOTE TO THE NEW JERSEY INFRASTRUCTURE BANK, AND AUTHORIZING THE EXECUTION AND DELIVERY OF SUCH NOTE BY THE BOROUGH OF CHATHAM IN FAVOR OF THE NEW JERSEY INFRASTRUCTURE BANK, ALL PURSUANT TO THE NEW JERSEY INFRASTRUCTURE BANK CONSTRUCTION FINANCING LOAN PROGRAM.

WHEREAS, the Borough of Chatham, in the County of Morris, New Jersey (the "Local Unit"), jointly operates a sanitary sewerage treatment system with the Borough of Madison, in the County of Morris, New Jersey, as members of the Madison-Chatham Joint Meeting and has determined that there exists a need within the Local Unit to acquire, construct, renovate or install a certain project which consists of the improvement of the Madison-Chatham Joint Meeting's Molitor Water Pollution Control Facility (the "Project"), and it is the desire of the Local Unit to obtain financing for such Project through participation in the environmental infrastructure financing program (the "Environmental Infrastructure Financing Program") of the New Jersey Infrastructure Bank (the "I-Bank");

WHEREAS, the Local Unit has determined to temporarily finance the acquisition, construction, renovation or installation of the Project prior to the closing with respect to the Environmental Infrastructure Financing Program, and to undertake such temporary financing with the proceeds of a short-term loan to be made by the I-Bank (the "Construction Loan") to the Local Unit, pursuant to the Construction Financing Loan Program of the I-Bank (the "Construction Financing Loan Program");

WHEREAS, in order to (i) evidence and secure the repayment obligation of the Local Unit to the I-Bank with respect to the Construction Loan and (ii) satisfy the requirements of the Construction Financing Loan Program, it is the desire of the Local Unit to issue and sell to the I-Bank its "Note Relating to the Construction Financing Loan Program of the New Jersey Infrastructure Bank" in an aggregate principal amount of up to \$2,730,000 (the "Note");

WHEREAS, it is the desire of the Local Unit to authorize, execute, attest and deliver the Note to the I-Bank pursuant to the terms of the Local Bond Law of the State of New Jersey, constituting Chapter 2 of Title 40A of the Revised Statutes of the State of New Jersey (the "Local Bond Law"), and other applicable law; and

WHEREAS, Section 28 of the Local Bond Law and N.J.S.A. 58:11B-9 allow for the sale of the Note to the I-Bank, without any public offering, all under the terms and conditions set forth herein.

BE IT RESOLVED by the governing body of the Local Unit as follows:

Section 1. In accordance with Section 28 of the Local Bond Law and N.J.S.A. 58:11B-9, the Local Unit hereby authorizes the issuance, sale and award of the Note (and any renewals thereof) in accordance with the provisions hereof. The obligation represented by the Note has been appropriated and authorized by a bond ordinance of the Local Unit, finally adopted on December 10, 2018, and entitled: "BOND ORDINANCE TO AUTHORIZE THE FUNDING OF A PORTION OF THE COST OF THE IMPROVEMENT OF THE MADISON-CHATHAM JOINT MEETING'S MOLITOR WATER POLLUTION CONTROL FACILITY IN, BY AND FOR THE BOROUGH OF CHATHAM, IN THE COUNTY OF MORRIS, STATE OF NEW JERSEY, TO APPROPRIATE THE SUM OF \$2,730,000 TO PAY THE COST THEREOF, TO AUTHORIZE THE ISSUANCE OF BONDS TO

- **Section 2.** The Chief Financial Officer of the Local Unit (the "Chief Financial Officer") is hereby authorized to determine, in accordance with the Local Bond Law and pursuant to the terms and conditions hereof, (i) the final principal amount of the Note (subject to the maximum limitation set forth in Section 4(a) hereof), and (ii) the dated date of the Note.
- **Section 3.** Any determination made by the Chief Financial Officer pursuant to the terms hereof shall be conclusively evidenced by the execution and attestation of the Note by the parties authorized pursuant to Section 4(h) hereof.
- **Section 4.** The Local Unit hereby determines that certain terms of the Note shall be as follows:
 - (a) the aggregate principal amount of the Note to be issued shall be an amount up to \$2,730,000;
 - (b) the maturity of the Note shall be as determined by the I-Bank, and the Note may be renewed from time to time as may be determined by the I-Bank;
 - (c) the interest rate of the Note shall be as determined by the I-Bank;
 - (d) the purchase price for the Note shall be par;
 - (e) the Note shall be subject to prepayment prior to its stated maturity in accordance with the terms and conditions of the Note;
 - (f) the Note shall be issued in a single denomination and shall be numbered "CFP-19-1";
 - (g) the Note shall be issued in fully registered form and shall be payable to the registered owner thereof as to both principal and interest in lawful money of the United States of America; and
 - (h) the Note shall be executed by the manual or facsimile signatures of the Mayor and the Chief Financial Officer under official seal or facsimile thereof affixed, printed, engraved or reproduced thereon and attested by the manual signature of the Local Unit Clerk.
 - **Section 5.** The Note shall be substantially in the form attached hereto as Exhibit A.
- **Section 6.** The law firm of Rogut McCarthy LLC is hereby authorized to arrange for the printing of the Note, which law firm may authorize McCarter & English, LLP, bond counsel to the I-Bank for the Construction Financing Loan Program, to arrange for same.
- Section 7. The Authorized Officers of the Local Unit are hereby further severally authorized to (i) execute and deliver, and the Local Unit Clerk is hereby further authorized to attest to such execution and to affix the corporate seal of the Local Unit to, any document, instrument or closing certificate deemed necessary, desirable or convenient by the Authorized Officers or the Local Unit Clerk, as applicable, in their respective sole discretion, after consultation with counsel and any advisors to the Local Unit and after further consultation with the I-Bank and its representatives, agents, counsel and advisors, to be executed in connection the issuance and sale of the Note and the participation of the Local Unit in the Construction Financing Loan Program, which determination shall be conclusively evidenced by the execution of each such certificate or other document by the party authorized hereunder to execute such certificate or other document, and (ii) perform such other actions as the Authorized Officers deem necessary, desirable or convenient in relation to the execution and delivery of the Note and the participation of the Local Unit in the Construction Financing Loan Program.
 - **Section 8.** This resolution shall take effect immediately.

Section 9. Upon the adoption hereof, the Local Unit Clerk shall forward certified copies of this resolution to Rogut McCarthy LLC, bond counsel to the Local Unit, David Zimmer, Executive Director of the I-Bank, and Richard T. Nolan, Esq., McCarter & English, LLP, bond counsel to the I-Bank.
