PROCLAMATION

RESOLUTION #19-185

PARENTS WHO HOST LOSE THE MOST DON'T BE A PARTY TO TEENAGE DRINKING CAMPAIGN

WHEREAS, alcohol use by young people is dangerous, not only because of the risks associated with acute impairment, but also because of the threat to their long-term development and well-being; and

WHEREAS, adults who provide alcohol to those below the legal drinking age of 21 are placing those youth at risk for health, safety and legal problems; and

WHEREAS, it is illegal to give or allow your teen's friends under 21 to drink alcohol in your home, even with their parents' permission, and anyone found guilty of providing alcohol to a youth can face up to a \$1,000 fine and six months in jail in addition to any civil action that can be brought as a result of damages or injury related to the offense; and

WHEREAS, adults have the authority and responsibility to provide our youth with alternative opportunities by creating alcohol free activities; and

WHEREAS, the Drug-Free Action Alliance, through the "Parents Who Host, Lose the Most: Don't be a Party to Teenage Drinking" campaign provides the educational materials to raise community awareness regarding this illegal and unhealthy practice; and

BE IT RESOLVED, by the Mayor and Council of the Borough of Chatham that they hereby proclaim the month of June 2019 to be the "Parents Who Host, Lose the Most: Don't be a Party to Teenage Drinking" month in the Borough of Chatham; and

BE IT FURTHER RESOLVED, that Borough officials not only discourage the use of alcohol by those below the legal age of consumption, but also urge all Borough citizens to refuse to provide alcoholic beverages to underage youths and to continue to take the necessary steps to discourage this illegal and unhealthy activity.

WHEREAS, Emergency Medical Services are a vital public service, providing lifesaving care to those in need 24 hours a day, seven days a week; and

- **WHEREAS**, the all-volunteer Chatham Emergency Squad has primary responsibility for responding to medical emergencies in the Chathams and provides CPR training and First Aid training to residents of the Chathams to improve preparedness for medical emergencies; and
- **WHEREAS**, our community is fortunate to be served by such dedicated volunteers who give their time in service of the Chatham Emergency Squad and engage in hundreds of hours of specialized training to enhance lifesaving knowledge and skills; and
- **WHEREAS**, National Emergency Medical Services Week unites local communities and medical personnel to publicize safety and honor the dedication of those who provide the day-to-day lifesaving services of medicine's "front line."
- **BE IT RESOLVED**, by the Mayor and Council of the Borough of Chatham that they do hereby proclaim the week of May 19-25, 2019 as Emergency Medical Services Week in the Borough of Chatham and give a heartfelt thanks to the dedicated volunteers of the Chatham Emergency Squad; and

RESOLUTION RECOGNIZING MAY 2019 AS MENTAL HEALTH AWARENESS MONTH

WHEREAS, mental health is essential to everyone's overall health and well-being; and

- **WHEREAS**, behavioral health disorders, including major depression, bi-polar disorder, schizophrenia, panic disorders, post-traumatic stress disorder and obsessive-compulsive disorders affect children and youth every year, regardless of age, gender, race, ethnicity, religion or economic status; and
- **WHEREAS**, a focus on prevention and early intervention could greatly reduce the number of children and adults experiencing serious mental health conditions; and
- **WHEREAS**, children, and adults can recover from mental illness and lead full, productive lives in the community; and

- **WHEREAS**, the Borough of Chatham, as a Stigma Free community aims to eradicate the stigma associated with mental illness and substance abuse disorders, and is dedicated to raising awareness of these illnesses by creating an environment where affected individuals are supported in their efforts to achieve wellness and recovery; and

WHEREAS, each elected official, business, government agency, health-care provider, organization and citizen share the burden of mental health issues and has a responsibility to promote mental health wellness and support prevention efforts.

BE IT RESOLVED, that the Mayor and Borough Council of the Borough of Chatham, hereby declares May 2019 as Mental Health Month and thereby requests that each resident, citizen and business recommit our community to increasing awareness and understanding of mental health issues and the need for appropriate and accessible services for all people, especially children and youth with mental health conditions. There are steps our children, youth and adults can take to protect their mental health.

DISCUSSION ITEMS

Washington Avenue Mural – Public Arts Council

Mrs. Kaplan of the Public Arts Council gave an overview of the Washington Avenue mural project and referenced the hand out she had sent to the Borough Mayor and Council previously. The mural will be on both the east and west side of Washington Avenue.

Mrs. Paruta discussed the actual mounting of the mural to the NJ Transit bridge.

Mr. Hasegawa described his impression of the mural and what went in to the selection of his renderings.

Senior Advisory Committee

John Crouthamel thanked the Mayor and Council for the honor of being designated Volunteer of the Year for Morris County.

John Crouthamel and Thomas Honohan discussed the concept of implementing a Senior Advisory Committee in the Chathams. Mr. Honohan, President of the Madison Senior Citizens Advisory Committee gave an overview of the Madison Senior Citizen Advisory Board. Their goal in Madison is to engage as many seniors as possible. He also gave an overview of the structure and composition of the committee in Madison. He also answered questions from the Mayor and Borough Council.

Mayor Harris indicated that there needs to be direct contact to engage seniors. Mayor Harris inquired of Mr. Crouthamel how the committee would be formed? Would the Mayors of each town appoint members to the committee? Mr. Crouthamel indicated that they would do whatever the Mayors wanted. Council Member Fife agreed to work with Mr. Crouthamel on development of this committee.

Food Truck Festival

Mrs. O'Connell of the Cultural Committee of the Chathams gave an overview of the first Food Truck Festival on June 22, 2019 at the Chatham Middle School. Mrs. O'Connell described how to purchase tickets for this event. She indicated that there would be lawn signs posted around town.

Review of River Road Redevelopment Plan Edits

Ms. Hindenlang of Topology gave an overview of the edits that have been made to the River Road Redevelopment Plan since the Joint Meeting with the Planning Board on May 1, 2019. There were a few edits that included; updating maps, building height methodology, maximum heights, allowance of open space and allowance for safety and traffic were taken into consideration and adjusted. Also, typographical errors were and will be corrected.

Mayor Harris indicated that the public hearing would be on June 10, 2019

Mayor Harris proceeded with opening the meeting for public comment.

Mayor Harris and Council Kobylarz indicated that the roof of Borough Hall is consumed with an array of communications equipment on the roof and would not be suitable for the installation of solar panels.

Rozella Clyde – 33 Carmine Street – Requested that the same handouts be provided to the public as that are provided to the Mayor and Council.

Seeing no one else wishing to comment, Mayor Harris closed the meeting to the public.

Budget and Finance

Council Member Robert A. Weber, Sr. reported there was a meeting a couple of weeks ago and the discussion centered around filling the Clerk's position. The Borough is currently soliciting resumes for the position.

Public Works Planning/Community Services

Council Member Victoria Fife reported on Spring Clean and thanked each department for the hard work they both do in conjunction with the special projects. Both Departments are currently working on the Memorial Day Service and Fishawack.

Shared Service & 3rd Party Agreements

Council Member Jocelyn Mathiasen had nothing new to report.

MAYOR'S REPORT

Mayor Harris reported that he had attended the Arbor Day concert and indicated that Shade Tree Commission member Kristi Chmura did a wonderful job at the concert and it was a nice way to recognize Arbor Day.

Mayor Harris also indicated that he had participated in a regional planning meeting in Madison that Congresswoman Sherrill had chaired. This meeting was looking at traffic that impacts most towns on the Route 24 and Route 124 corridor. Morris County has invited towns that attended that meeting to participate in a regional traffic planning program and that the Borough will participate in.

ADMINISTRATOR'S REPORT

Mr. Williams reported that the Borough had received notice from the NJSP that the Emergency Operating Plan had been approved. The Morris County Inter-local Agreement had been signed by the County and reminded residents not to flush hazardous materials into storm drains. He also reported that summonses had been sent to those residents that have not yet registered their pets.

WHEREAS, the School District of the Chathams Board of Education (the "Board") has requested that the Borough of Chatham provide one (1) SLEO Class III Officer for the 2019/2020 School Year in accordance with N.J.S.A. 40A:14-146.8 et seq. and pursuant to the attached shared services agreement and (2) the Borough of Chatham has agreed to do so; and

WHEREAS, the Mayor and Borough Council of the Borough of Chatham have adopted an ordinance authorizing the appointment of one (1) Class III Special Law Enforcement Officer (SLEO III) in accordance with N.J.S.A. 40A:14-146.8 et seq;

NOW, THEREFORE, BE IT RESOLVED, by the Borough Council of the Borough of Chatham, County of Morris, State of New Jersey that the Mayor and Acting Borough Clerk of the Borough of Chatham are hereby authorized to execute a shared service agreement between the Borough and the Board to provide one (1) SLEO III to the School District. The form of agreement shall be approved by the

Borough Attorney and substantially similar to the shared services agreement attached hereto and made a part hereof this Resolution.

BE IF FURTHER RESOLVED, that the Borough Administrator and Borough Attorney be and hereby are authorized and directed to further negotiate non-substantive revisions to the shared services agreement with the Board as appropriate.

BE IF FURTHER RESOLVED, that all Borough officials and employees are hereby authorized and directed to take all action necessary and appropriate to effectuate the terms of this Resolution.
