### REGULAR MEETING OF THE MAYOR AND BOROUGH COUNCIL

#### September 23, 2019 MINUTES

Mayor Harris called the Regular Council Meeting of the Borough of Chatham to order on Monday, September 23, 2019 at 7:30 p.m. in the Council Chambers in Borough Hall, 54 Fairmount Avenue, Chatham, New Jersey.

#### SALUTE TO FLAG

Mayor Harris and the Borough Council led those assembled in the Pledge of Allegiance.

#### MOMENT OF SILENCE

Mayor Harris asked for a moment of silence for those who have given their lives for our country.

#### STATEMENT OF ADEQUATE NOTICE

Stephen W. Williams, Acting Borough Clerk, read the following statement of adequate notice:

Pursuant to the requirements of the Open Public Meetings Act, adequate notice of this meeting has been provided by including same in the Annual Notice, copies of which were posted on the official bulletin board on the main floor of Borough Hall, emailed to the Daily Record, the Star Ledger, the Chatham Courier, the Chatham Patch, and TAP into Chatham and was filed with the Borough Clerk, all on January 17, 2019.

Mayor Harris announced that there will be a Class III Special Law Enforcement Officer in the School District, Officer Agapito Guzman.

Council President Collander mentioned the career and merits of Officer Guzman. Chief Gibbons gave a brief speech of Mr. Guzman, acknowledging his decades of work and experience in law enforcement. Chief Gibbons personally thanked and welcomed Mr. Guzman to the Chatham Police Department. Council President Collander read the following Resolution:

# RESOLUTION TO EMPLOY AGAPITO GUZMAN AS A PROBATIONARY CLASS III SPECIAL LAW ENFORCEMENT OFFICER (SLEO) FOR THE BOROUGH OF CHATHAM POLICE DEPARTMENT

**WHEREAS**, on November 30, 2016, Governor Chris Christie signed into law P.L. 2016, c. 68 which established Class III Special Law Enforcement Officers for retired law enforcement officers under 65 years of age to provide security in public and nonpublic schools and county colleges; and

**WHEREAS**, the School District of the Chatham's and Borough of Chatham wishes to hire Agapito Guzman as a Class III SLEO for the 2019/2020 school year; and

**WHEREAS**, the Chief of Police has recommended that Agapito Guzman be employed as Probationary Class III SLEO for the Borough of Chatham Police Department, at a salary of \$35.00 per hour effective September 24, 2019.

**BE IT RESOLVED**, by the Mayor and Council of the Borough of Chatham that Agapito Guzman be appointed as a Probationary Class III SLEO at a salary of \$35.00 per hour effective September 24, 2019; and

**BE IT FURTHER RESOLVED**, that the Chief of Police is authorized to undertake and execute such employment documents as are necessary to implement this resolution.

A motion was made by Council President Collander and seconded by Council Member Weber to APPROVE the resolution. A vote taken on Resolution 19-275 was unanimously approved.

Mr. Guzman was sworn in as a Special Law Enforcement Officer, by Acting Municipal Clerk Stephen Williams. Mayor Harris congratulated Mr. Guzman and welcomed him to the Chatham Police Department.

#### **DISCUSSION ITEMS**

Mayor Harris introduced Council Member Kobylarz to make a presentation on the Economic Development Advisory Committee initiative.

### ECONOMIC DEVELOPMENT ADVISORY COMMITTEE (EDAC) PRESENTATION BY: COUNCIL MEMBER KOBYLARZ

Council Member Kobylarz provided a quick overview from his March report and an update on the developments with respect to the Economic Development Advisory Committee. He stated that the initiative is to make Chatham Borough a destination for commercial businesses, primarily attracting technology and innovation start-up firms.

The branding campaign for the County is called, "Start-Up Move-Up Morris,"; whereas the Borough of Chatham slogan is, "Start-Up Move-Up Chatham." The MDEC has spent over \$10,000 towards

"Start-Up Move-Up Chatham," stated Councilman Kobylarz. The web pages for the County and the Borough are being worked on and business outreach is in the planning stage.

In August of 2019, Governor Phil Murphy signed into law a Bill that will allow municipalities to designate certain areas as innovation districts. Assemblyman Kennedy who conceived of the bill, toured the Borough of Chatham and was excited by its potential for technology and innovative firms (especially, in the River Road development area).

Council Member Kobylarz explained the responsibilities of the Committee. He stated that residents are invited to serve as volunteers on the Economic Development Advisory Committee. He reported that seven (7) residents have responded; however, the Committee would like to have nine (9) members. Applications for membership were sent out on September 17, 2019. A resolution may be introduced by the next scheduled meeting [October 15, 2019], stated Council Kobylarz.

Any interested volunteers should complete the standard Volunteer Application, which is accessible on the Borough's website, stated Mayor Harris.

Council Member Fife inquired about volunteers. Council Member Kobylarz explained that the Committee is looking for volunteers with expertise in technology, finance, economics, marketing, and seeking entrepreneurs and small business owners.

Mayor Harris thanked Council Member Kobylarz for his presentation.

#### **FISHAWACK**

#### PRESENTATION BY: JANICE PICCOLO

Mayor Harris introduced Janice Piccolo, Director of Community Services, who gave an update on the Fishawack Festival, held on June 8, 2019.

Ms. Piccolo reported that the event had 10,000 attendees and the greatest number of vendors and businesses participating this year. She reported on the budget and stated the event brought in \$2,500 more in revenue than in 2018. The Department has focused on curtailing expenses, stated Ms. Piccolo.

Mayor Harris thanked Ms. Piccolo for her comprehensive presentation and work on the event.

Council Member Weber reiterated the support for the event and commended Ms. Piccolo and her staff. Council Member Fife also reported safety concerns from last year, and stated the event was more cohesive. Council Member Fife thanked Police Officer George for making the necessary changes to address the safety concerns.

Mayor Harris mentioned that the car show was very popular this year. He proposed adopting a resolution to approve moving forward with Fishawack in 2020.

## MEETING OPEN TO THE PUBLIC NOTICE OF PUBLIC COMMENT TIME LIMIT

Hearing of citizens during the Public Comment section of the Agenda is an opportunity for any member of the public to be heard about issues which are/are not topics scheduled for Public Hearing tonight. To help facilitate an orderly meeting, and to permit all to be heard, speakers are asked to limit their comments to a reasonable length of time.

#### Rosella Clyde – 33 Carmine Street

Ms. Clyde thanked Ms. Piccolo for the successful Fishawack event and Sustainability Fair. Ms. Clyde is a member of the Green Team, so she mentioned that the Plastic Bag Ordinance is timely, especially since the United Nation (UN) was discussing climate change. She praised the Ordinance on the agenda and stated that the initiative is a positive move for the community.

Ms. Clyde discussed Council Member Kobylarz's Economic Development Presentation and the forthcoming Committee. The Committee needs an idea for a master plan, and an end goal, stated Ms. Clyde. She further stated that the research conducted should be incorporated into the proposal. Ms. Clyde expressed concerns about the effects on existing businesses.

#### Nyla Ismael - Senior at Chatham High School

Ms. Ismael read a report from her Girl Scout Gold Award on Plastic Bag pollution and its impact. She spent six months collecting over 80,000 plastic bags. Ms. Ismael's project focuses on limiting plastic usage and its proper disposal in Chatham Borough.

#### Deborah Smith - 166 N. Passaic Avenue

Ms. Smith wanted to memorialize her objection to the sidewalk installed in front of her house. Mr. Williams informed Ms. Smith to contact the Borough Engineer, Mr. DeNave. Ms. Smith recommends the Borough build a parking deck to ensure adequate parking within the area.

Mayor Harris said that there is a long vetting process for sidewalks and safety is paramount.

#### **Stuart Carr - 3 Crestwood Drive, Chatham Township**

Mr. Carr wanted to follow-up on two questions from the previous Council Meeting:

- 1. Will there be public questions with respect to the Post Office Plaza redevelopment?
- 2. Secondly, would the Council Members recuse themselves from financially benefitting from the Post-Office Plaza initiative?

Mr. Williams stated that Mr. Carr's questions were submitted verbatim to Mr. Goldsmith and Mr. Hague.

Mayor Harris stated that it is not feasible to add a referendum on the Ballot this year. However, there will be opportunities for public input.

Mr. Carr stated that Council Member Kobylarz's Economic Development initiative is a good idea.

#### ORDINANCE FOR SECOND READING

The Ordinance was introduced and passed on first reading at a regular Council meeting held on September 9, 2019.

Mayor Harris asks the Acting Borough Clerk to give a summary of the legal notice.

The Acting Borough Clerk states: A legal notice was published indicating that Ordinance #19-13 was introduced and passed on first reading at the September 9, 2019 meeting and indicated the second reading and public hearing would be held at 7:30 p.m. on September 23, 2019 for consideration of final adoption. Copies of this Ordinance were made available to the general public and posted in accordance with the law.

Mayor Harris: The meeting is now open for a public hearing on the Ordinance and any member of the public may be heard.

Mayor Harris: Seeing no one else wishing to be heard, I will now close the public hearing.

Council President Collander: I offer the following Ordinance and move its adoption:

### REPORTS COUNCIL COMMITTEES

**Budget and Finance -** Council Member Kobylarz reported that the last committee meeting was held in August. The Committee intends to meet monthly until April 2020. Mr. Williams and Mr. Hollberg are working on the Budget schedule.

**Long Range Traffic and Pedestrian Safety Planning -** Council President Collander reported that the curbing project on N. Passaic Avenue is almost complete. The sidewalks are 80% complete, whereas the drainage is 90% complete. Milling and paving will be complete within two weeks. Council President Collander commended Mr. DeNave and the County for their work.

**Public Safety and Emergency Services -** Council President Collander reported that he met with Chief Gibbons regarding his request to purchase and replace outdated firearms. A resolution is scheduled for adoption at tonight's meeting to replace the department's firearms, stated Council President Collander.

**Personnel -** Council Member Weber reported that the Borough has filled the vacant positions for a Municipal Clerk, Deputy Clerk and a Confidential Administrative Assistant to the Borough Administrator. All three employees are scheduled to start in October, stated Councilman Weber.

**Public Works Planning/Community Services** - The next meeting will be scheduled for October, reported Council Member Fife.

**Shared Service & 3<sup>rd</sup> Party Agreements -** Council Member Mathiasen reported that the Borough has an agreement with a software company that the Borough of Madison uses, which will allow pet licensing and permits to be accessible and processed online.

#### **MAYOR'S REPORT**

Mayor Harris stated that a joint meeting with the Planning Board is scheduled for this Thursday with the Council and the redeveloper for the River Road project, who will give a presentation and demonstrate the preliminary design of the proposed structure. The public is invited to attend, stated Mayor Harris.

#### ADMINISTRATOR'S REPORT

- o Mr. Williams introduced the newly appointed Borough Clerk, Tamar Lawful.
- o The Pingry Agreement was signed, and the parents are pleased, stated Mr. Williams.
- Last Wednesday, September 18, 2019, the Borough Hall was open for Voter Registration.
   The Clerk's Office has voter registration applications and absentee ballots.
- O Last Thursday night into Friday morning, there was a substantial water main break on Watchung Avenue that closed the westbound lanes. The DPW was able to fix the issue while the Fire Department handled other emergency matters. Mr. Williams stated that both departments did a wonderful job on these projects that evening.

#### **DISCUSSION**

Council Member Weber expressed concerns about the department designated to handle the enforcement of the Ordinance # 19-14. Mr. Lott stated that the Borough has the burden of proof, and the Police Officer can make the determination.

Council Member Mathiasen stated that clarification and training should take place. Mayor Harris stated the Ordinance will take effect in March of 2020. The Borough has until then to sort out any concerns.

Council Member Weber stated that the Ordinance does not specify that the Police Department is required to issue a Summons [in the event there is a violation of Ordinance # 19-14]. Council Member Weber expressed concerns with the Police Department being tasked with writing Summons.

Council Member Weber made a motion, seconded by Council President Collander to amend the ordinance to remove the Police Department from being the enforcing authority for this ordinance and to task the responsibility to the Recycling Enforcement Officer. After a brief discussion, a vote was taken. The motion failed to carry.

Council Member Collander then recommended adding another designated entity to enforce the ordinance. Mr. Lott suggested adding the language that the recipient of the summons has the right to contest before the Municipal Court.

Mayor Harris stated that the ordinance will be scheduled for a Public Hearing on October 15, 2019.
