December 28, 2020 MINUTES

Mayor Thaddeus J. Kobylarz called the Regular Council Meeting of the Borough of Chatham to order on Monday, December 28, 2020, at 6:03 p.m. in the Council Chambers in Borough Hall, 54 Fairmount Avenue, Chatham, New Jersey.

Note: The start time of this meeting was moved from 7:30 p.m. to 6:00 p.m. to accommodate the emergency measures in place due to the coronavirus pandemic.

SALUTE TO FLAG

Mayor Kobylarz and the Borough Council led the assembled in the Pledge of Allegiance.

MOMENT OF SILENCE

Mayor Kobylarz asked for a moment of silence for those who have given their lives for our country. He also gave recognition to those protecting our lives during the current health pandemic caused by coronavirus, COVID-19. He further acknowledged the 19.3 million Americans who contracted COVID-19, and the nearly 334,000 people who have died from the insidious disease. He acknowledged the nine (9) Chatham Borough residents who died during the pandemic. Deputy Chief Don Almgren's nephew, Robert Eric Almgren III, tragically passed away on December 27, 2020. Finally, he acknowledged a mother and child who were hit by a vehicle on December 22, 2020 and sustained serious injuries.

Council Member Resto moved to approve Resolution # 20-283 seconded by Council Member Koronkiewicz. By a unanimous voice vote, Resolution # 20-283 was approved.

Mayor Kobylarz presented a Mayor's Proclamation in honor of Decker Li Ferry, a 5-year-old Borough resident who preserved the Christmas tradition in Chatham Borough in a modified form during the pandemic which allowed residents to see Santa Claus drive around town accompanied by members of the Chatham Borough Fire Department and Police Department.

Mayor Kobylarz proceeded to read the Mayor's Proclamation:

COMMENDING AND THANKING DECKER LI FERRY FOR HIS INVALUABLE EFFORT TO PRESERVE THE TRADITION OF SANTA'S VISIT TO CHATHAM BOROUGH DURING THIS PANDEMIC YEAR

WHEREAS, each year since time immemorial, Santa Claus has made an annual early stop at Reasoner Park in downtown Chatham Borough, arriving via the North Pole Express on Christmas Eve, to hand out candy to children eagerly awaiting him at the Gazebo, and to entertain their petitions for the presents they hope to find under the Christmas tree the following morning; and

WHEREAS, this annual visit by Saint Nick has become an integral part of the Borough's yearly social calendar, typically resulting in long lines of thrilled and delighted children stretching all the way to Fairmount Avenue and beyond; and

WHEREAS, for the children of Chatham, the magic of the holiday season is made all the more wondrous and meaningful by the stirring spectacle of these regular visits by Santa Claus on Christmas Eve; and

WHEREAS, due to this year's coronavirus pandemic, out of an abundance of caution, and to keep the community safe, Chatham Borough reasonably and responsibly had expected to cancel Santa's 2020 visit to Reasoner Park; and

WHEREAS, in October of this year, Decker Li Ferry, a five-year-old Chatham Borough resident, emailed the Mayor with an ingenious plan to have Santa ride through the Borough's streets as a substitute for his Reasoner Park visit so that Chatham's children could still catch a glimpse of jolly ol' Saint Nick, which, in Decker's fitting words, would "make their day"; and

WHEREAS, Santa Claus, detecting the wisdom in Decker's proposal, responded with enthusiasm to the Mayor's inquiry by declaring "what a magnificent idea!" and "of course I will do it!"; and

WHEREAS, the Chatham Borough Volunteer Fire Department, which ordinarily plays host to Santa's Christmas Eve visit, graciously offered to convey the beloved Christmas figure around town via a procession of fire engines otherwise known as the "North Pole Express"; and

WHEREAS, the Chatham Borough Police Department kindly agreed to assist by providing the motorcade with a suitable police escort; and

WHEREAS, with his clever and imaginative idea, Decker managed to not just help preserve a greatly cherished Chatham tradition, but also to add a much-needed spark to this year's holiday season, one that undoubtedly brought a smile to the faces, and warmed the hearts, of so many children – and adults – all across this wonderful town; and

WHEREAS, Santa Claus himself requested that the Mayor thank Decker on his behalf for "all that this young man has done to preserve the spirit of Christmas in this difficult year";

NOW, THEREFORE, I, Thaddeus J. Kobylarz, Mayor of the Borough of Chatham, do hereby proclaim that Decker Li Ferry be commended for his extraordinary service to this grateful community, and that he be officially recognized for his heart-warming effort to show us the great importance of maintaining our most cherished traditions, especially during a challenging time such as we presently face.

Once again, Mayor Kobylarz thanked Decker and his family for allowing Santa to visit the Borough of Chatham during this challenging year.

RESOLUTION RECOGNIZING COUNCIL MEMBER ROBERT A. WEBER, SR. FOR HIS EXEMPLARY SERVICE TO CHATHAM BOROUGH

WHEREAS, on November 7, 2017, Robert A. Weber, Sr. was elected by the voters of the Borough of Chatham to serve a 3-year term on the Borough Council; and

WHEREAS, during his three (3) years in elected office, Council Member Robert "Bob" Weber, Sr. continually sought to improve the quality of life for Borough residents and expertly demonstrated foresight, leadership, and fiscal responsibility in policy decisions and operations of Borough government; and

WHEREAS, during his tenure on the Borough Council, Bob devoted innumerable hours, working enthusiastically with integrity and dedication on the Board of Health since 2018; and

WHEREAS, he petitioned the Council to create a barrier whereby residents can have their pets enjoy an off-leash open space at Shepard Kollock Park; and

He further facilitated in the Borough retaining its AAA bond rating by adhering to a strategic financial plan, he further expanded the shared services agreements to save on cost and lobbied the State and County officials to mitigate traffic on Main Street and Watchung Avenue; and

WHEREAS, Council Member Weber further served in the role as Council liaison to the Budget and Finance Committee, Personnel Committee, Public Works/Community Services Committee, Public Safety/Emergency Services Committee, Long Range Traffic & Pedestrian Safety Planning Committee, Joint Meeting-Finance & Personnel Committee, Joint Recreation Advisory Committee, Board of Health, the Chatham Borough Recreation Advisory Committee and the 9/11 Memorial Advisory Committee; and

WHEREAS, as an educator and through his professional experience as an attorney/Assistant Prosecutor he often analyzed and tested information provided to him to ensure a judicious decision was made; and

WHEREAS, Council Member Weber carried out his duties as an elected official and as a citizen of Chatham Borough with enthusiasm and in a conscientious, thoughtful, and caring manner, and always dedicated himself to advancing the spirit of volunteerism that has helped make Chatham Borough the town we love; and

WHEREAS, Bob will always be remembered for his kindness, camaraderie and fairness when dealing with residents, businesses, and the Borough's workforce.

BE IT RESOLVED, by the Mayor and Council of the Borough of Chatham that they hereby recognize and commend Bob on his leadership, dedication and enthusiasm for our community as demonstrated throughout his tenure on the Borough Council; and

BE IT FURTHER RESOLVED, by the Mayor and Council, on behalf of the entire Chatham Borough community, that they hereby extend their grateful appreciation to Bob Weber for his three remarkable years of service on the Chatham Borough Council and commend him for all he has achieved during his tenure on the Borough Council. Council Member Resto made a motion to approve Resolution # 20-284. Council President Mathiasen seconded the motion. A vote was taken and Resolution # 20-284 was approved unanimously.

Once again, Mayor Kobylarz expressed his appreciation to Council Member Weber for his years of service on the Borough Council and spirit of volunteerism and presented him with the framed Resolution and an old Council captain's chair mounted with an engraved plaque commemorating his years of service on the Borough Council. Mayor Kobylarz further presented him with a customized word graphic piece of artwork that highlighted his service during his time on the Council. Mayor Kobylarz, Council Member Dempsey and Council Member Weber gathered safely for a photograph.

MAYOR'S REPORT I:

Mayor Kobylarz delivered a portion of his Mayor's Report as follows:

Statistical Update on the Coronavirus:

Mayor Kobylarz reported 224 COVID-19 cases in the Borough of Chatham. Recently, 27 new cases were reported. The Borough's Health Officer Megan Avallone explained that statistics show a high-level of cases statewide; however, a moderate level of positive cases, locally. On a positive note, clinics have begun to administer vaccinations to individuals who fall under the 1A Category. Summit Medical Group has begun vaccinating patients. In the state of New Jersey, positive COVID-19 cases reported are now above 4,000 per day. The transmission rate for the state is 0.96, a reduction from 1.3 two weeks ago. Health experts anticipate a dangerous surge in the number of cases in the month of January 2021. Due to the continuous surge in cases, Mayor Kobylarz urged the public to put forth more effort and to adhere to the protective measures of washing hands, maintaining social distancing, wearing masks, cooperating with contact tracing, and refraining from social gatherings.

Mayor Kobylarz proceeded to open the meeting to public comment and read the Notice of Public Comment Time Limit.

Council President Mathiasen – Council President Mathiasen reported on the 2021 online renewal process for both pet licenses and alarms. The online registration will allow the public to register or renew their dog/cat and alarm licenses online and to pay with a credit card or a bank account without physically entering Borough Hall. For pets, a picture of the dog and the rabies certification must be uploaded to the site. The license will be mailed to the registrant.

Council Member Weber – Council Member Weber thanked the volunteers of the Borough, especially the ones who serve on multiple advisory committees to which he is council liaison. The members are truly committed to their cause. He further expressed happiness with the members of the boards and commissions. They represent and serve the community with great dedication. He encouraged other residents to volunteer their services to continue to build our community.

Council Member Dempsey – Council Member Dempsey reported that over one hundred gift cards were purchased at local businesses in support of the Shop Small for a Big Impact initiative to support the Chatham Community Food Distribution program at the Chatham United Methodist Church. She further thanked Community Services and the Department of Public Works for the white lights and decorations of the downtown area.

Council Member Koronkiewicz – Council Member Koronkiewicz reported that the Shade Tree Commission will change its meeting time and date from the third Tuesday of the month to the fourth Thursday of the month.

Council Member Treloar – Council Member Treloar had nothing to new to report.

Council Member Resto – Council Member Resto thanked Council Member Dempsey for orchestrating and promoting Shop Small for a Big Impact. The initiative benefits businesses and residents of the Borough. He further thanked the Borough and Township for donating generously to keep the food pantry stocked.

RESOLUTION AUTHORIZING A SHARED SERVICES AGREEMENT FOR LOCAL PUBLIC HEALTH SERVICES WITH THE TOWN OF WESTFIELD

WHEREAS, the Uniform Shared Services and Consolidation Act, *N.J.S.A.* 40A:65-1 et seq., permits a local unit of the State to enter into an agreement with any other local unit to provide or receive any service that each local unit participating in the agreement is empowered to render within its own jurisdiction; and

WHEREAS, the Borough of Chatham and the Town of Westfield ("Westfield"), in consultation with their respective Boards of Health, desire to contract with one another, whereby the Westfield Regional Health Department shall provide shared local public health services to the Borough in accordance with *N.J.S.A.* 26:3A2-1 et seq. and in compliance with *N.J.A.C.* 8:52-1.1 et seq., Public Health Practice Standards for Local Boards of Health in New Jersey, for the period commencing January 1, 2021 and ending December 31, 2023; and

WHEREAS, the Borough Council of the Borough of Chatham has determined that a shared services arrangement for local public health services with Westfield offers a beneficial opportunity to improve the efficiency of public health services for the Borough while protecting the health, safety and welfare of Borough residents and reducing the costs of delivering these services.

BE IT RESOLVED, by the Council of the Borough of Chatham, in the County of Morris and the State of New Jersey, that the Mayor and Borough Clerk are authorized to enter into a shared services agreement for local public health services with Westfield for the period commencing January 1, 2021 and ending December 31, 2023 in the amount of \$92,008 for the year 2021; and

BE IT FURTHER RESOLVED, that all other Borough officials and employees are hereby authorized and directed to take all action necessary and appropriate to effectuate the terms of this Resolution.
