# MAYOR'S REPORT I:

Mayor Kobylarz delivered a portion of his Mayor's Report as follows:

Statistical Update on the Coronavirus:

Mayor Kobylarz reported 195 COVID-19 cases in the Borough of Chatham. Recently, 18 new cases were reported. The majority of residents contracting the virus are 60 years of age and under. Statistics reflect 83% of positive cases are among those 60 years of age and under, while a large percentage of cases are among those 20 years of age and under. The largest age group to contract the virus are among teenagers, 14 to 19 years of age. In the state of New Jersey, positive COVID-19 cases reported are under 5,000 per day. Due to the continuous surge in cases, Mayor Kobylarz urged the public to put forth more effort and to adhere to the protective measures of washing hands, maintaining social distancing, wearing masks, cooperating with contact tracing, and refraining from indoor gathering.

# COVID-19 Ambassador Program:

Mayor Kobylarz called for additional volunteers to participate in the COVID-19 Ambassador Program to gently remind the public to "Mask Up, Chatham". Governor Murphy acknowledged the Borough's program in his daily COVID-19 briefing on December 9, 2020. Chief Gibbons acknowledged Rick Jaremba and Brian Colatrella for implementing the program. The program is progressing ahead with 20 ambassadors, most of which are school guards. However, younger volunteers are being sought to facilitate in spreading the message.

# River Road Redevelopment Project:

The Borough will continue to proceed with the proposed River Road Redevelopment Project. Due to fair share housing obligations, the redevelopment project can no longer be delayed. The corner of Watchung Avenue and River Road is in need of improvement. The Borough will hold multiple town hall meetings to inform residents of the proposed changes to the area.

#### Statement of Gratitude:

Mayor Kobylarz read a letter composed by himself and Council President Mathiasen. Immense gratitude was expressed to the residents of the Borough and to the staff of the Borough who invested innumerable hours during challenging circumstances to maintain the continuous operation of the Borough.

Mr. Williams thanked the Mayor and Council on behalf of the Borough staff.

Mayor Kobylarz proceeded to open the meeting to public comment and read the Notice of Public Comment Time Limit.

# Rozella Clyde – 33 Carmine Street

Mrs. Clyde echoed the Mayor's statement of gratitude to the Borough staff for maintaining services during this pandemic. She thanked the Borough administration for facilitating in organizing the St. Patrick Church "Best of Videos Concert" and especially the tribute to Kenneth Chmura, which coordinated well with the show that followed by young adults sending the significant and powerful message of the importance to mask up. She further discussed Resolution # 20-273 and Resolution #20-274 for the lease and purchase of police vehicles. Mrs. Clyde does not object with the Borough engaging in a lease agreement; however, she is displeased with purchasing vehicles that are not environmentally friendly. She encouraged the Police Department to follow the lead of the Madison Police Department and purchase electric vehicles.

Chief Gibbons stated that he and his team are great supporters of electric or hybrid vehicles. However, his department is behind in its acquisition of vehicles and did not have sufficient time to conduct the proper research for electric vehicles. However, he has contacted the Madison Police Department as he is interested in moving forward with electric vehicles in the future.

# Lisa DeRosa – 11 Dellwood Avenue

Lisa DeRosa, the President of the Board of Health called to thank Council Member Weber for his dedicated service to the Borough and the Board of Health. She expressed that he has been an amazing liaison member for the Board of Health. She will miss his dedication, his ability to communicate effectively and to provide information. She will further miss how approachable he is, and how willing

he is to engage and participate. Bob, you will be missed!

# Michael Dean – 181 N. Passaic Avenue

Mr. Dean thanked Council Member Weber for his years of service on the Council and hopes he remains involved especially with respect to the Post Office Plaza Redevelopment Project. He also inquired whether the designation extension for Chatham River Road Partners can be extended. Mr. Lott responded yes. He further inquired the reason why one vehicle is being leased and not purchased. Chief Gibbons stated that it was more advantageous to lease the vehicle due to the low interest rate.

#### REPORTS COUNCIL MEMBERS

Council President Mathiasen – Council President Mathiasen had nothing new to report.

Council Member Weber – Council Member Weber had nothing new to report.

**Council Member Dempsey** – Council Member Dempsey reported that the HPC will meet on December 15<sup>th</sup> to narrow down nominations for the Flag Award for outstanding restoration. She also encouraged residents to "Shop Small for Big Impact" by purchasing local gift cards and dropping them off at the United Methodist Church for distribution to our neighbors.

**Council Member Koronkiewicz** – Council Member Koronkiewicz reminded residents to submit their applications to the Chatham Community Garden for a garden plot for the year 2021.

**Council Member Treloar** – Council Member Treloar reported that the Joint Court Committee met to discuss preliminary numbers and the decline in court revenue. She reported that the Borough's contributions will be \$50,000 less for the year 2021. Council Member Treloar was congratulated for her appointment as Chairperson to the Joint Court Committee for the year 2021.

**Council Member Resto** – Council Member Resto reported that the Personnel Committee met to discuss employee salaries for the coming year. He thanked the Borough staff for their outstanding work performance and congratulated those who celebrated a milestone. He acknowledged the names of those employees and informed them that the Borough will acknowledge their dedication with a gift of appreciation. It was also reported that the food drive will be postponed to Friday, December 18, 2020 due to the possible inclement weather. Residents were encouraged to support local businesses during this challenging time. Council Member Resto acknowledged the 8<sup>th</sup> year anniversary of the unfortunate massacre that occurred at the Sandy Hook Elementary School.

Council Member Resto read a letter written by Robert Penn concerning those who may have been embarrassed from benefitting from the food pantry. In his letter, he informed residents that "there is a light at the end of the tunnel, and we are going to cross that finish line TOGETHER – NOBODY GETS LEFT BEHIND! Whatever it takes for as long as it takes!"

An anonymous letter was read aloud from someone who benefited from the program. The person expressed gratitude and appreciation for the program.

# **MAYOR'S REPORT II**

Mayor Kobylarz acknowledged the 8<sup>th</sup> year anniversary of the massacre of 26 people who died at the Sandy Hook Elementary School on December 14, 2012, in Newtown, Connecticut. He asked for a renewed determination that this tragedy will never happen again.

# **ADMINISTRATOR'S REPORT**

Mr. Williams reported on the following:

- The Borough finalized the grant request to receive\$71,000 as reimbursement for unanticipated expenses related to COVID-19.
- It was reported that underage drinking was taking place at Kelley's Pond. The Police Department will be monitoring this area. He reminded residents that the park is closed from dusk till dawn.
- He informed residents that a new textile recycling bin was installed at the Recycling Center for those interested in donating used clothing.
- The Borough calendar will be finalized this week. It is expected to be delivered between the week of Christmas and New Year.

- It was reported that the County of Morris will be providing rapid COVID-19 tests at no cost to the residents of Morris County upon request. The test will be mailed to the homes of Morris County residents.
- Due to the snowstorm on Wednesday and Thursday, DPW requested that all basketball hoops be removed to allow the roads to be properly plowed.
- The Fire Department announced that the annual Santa Claus visit will be canceled. However, on December 19<sup>th</sup>, Santa will be making his way around town to greet residents. Mayor Kobylarz acknowledged a young man by the name of Decker to whom he credited for this idea.

# **RESOLUTION EXTENDING DESIGNATION OF CHATHAM RIVER ROAD PARTNERS,** LLC AS THE REDEVELOPER FOR THE RIVER ROAD NORTH REDEVELOPMENT AREA

WHEREAS, the Local Redevelopment and Housing Law, N.J.S.A. 40A:12A-1, et seq., as amended and supplemented ("LRHL"), provides a process for municipalities to participate in the redevelopment and improvement of areas in need of redevelopment; and

**WHEREAS,** in accordance with the LRHL, the Council for the Borough of Chatham (the "Council") designated properties located at River Road and shown on the Borough's Tax Map as Block 135, Lots 9, 10 and 11, as an area in need of redevelopment (the "Redevelopment Area"); and

**WHEREAS,** the Council adopted a Redevelopment Plan by Ordinance No. 19-11, adopted on June 10, 2019 for the Redevelopment Area (the "Redevelopment Plan") which sets forth, <u>inter alia</u>, the plan for the redevelopment of the Redevelopment Area; and

**WHEREAS,** Chatham River Road Partners, LLC (the "Redeveloper"), an affiliate of BNE Real Estate Group of Livingston, New Jersey, was designated as the redeveloper for the Redevelopment Area by Resolution 2019-229 on June 24, 2019; and

WHEREAS, the designation of Redeveloper was initially set to expire on December 26, 2019; and

**WHEREAS**, the developer and the Borough of Chatham entered into an Interim Cost Agreement on June 26, 2019, which was also set to expire on December 26, 2019; and

**WHEREAS,** both the Redeveloper designation and Interim Cost Agreement were further extended from December 26, 2019 to June 26, 2020 by Resolution # 19-354 adopted on December 19, 2019; and

**WHEREAS**, both the Redeveloper designation and Interim Cost Agreement were further extended from June 26, 2020 to December 26, 2020 by Resolution # 20-184 adopted on June 22, 2020; and

**WHEREAS**, the Council continues to desire that the Redevelopment Area be redeveloped by the Redeveloper in accordance with the Redevelopment Plan; and

**WHEREAS**, the Council desires that the designation of Redeveloper and the Interim Cost Agreement be extended for an additional six (6) months; and

**WHEREAS**, the Council is authorized to exercise all powers under the LRHL, pursuant to *N.J.S.A. 40A:12A-8*, including but not limited to the ability to negotiate with developers to undertake redevelopment projects; and

WHEREAS, the Council and the Redeveloper shall have an additional period of six months to agree on a specific development proposal and enter into a Redevelopment Agreement.

**NOW, THEREFORE, BE IT RESOLVED,** by the Council for the Borough of Chatham as follows: (i) the designation of Chatham River Road Partners, LLC as the Redeveloper of the Redevelopment Area shall continue; (ii) the Mayor, and Borough Council's authorization to negotiate a Redevelopment Agreement with the Redeveloper shall continue; and (iii) authorizes the extension of the Interim Cost Agreement; and (iv) staff and consultants to the Borough are hereby authorized and directed to continue to take all other administrative actions to implement this Resolution as may be necessary and appropriate to accomplish its goals and intent; and

**BE IT FURTHER RESOLVED,** that this Resolution shall be effective for a period of six months from December 26, 2020 through June 26, 2021, after which time it shall be of no further force and effect unless the Redeveloper shall have entered into a Redevelopment Agreement with the Borough of Chatham.

**WHEREAS**, the Borough Administrator solicited competitive quotes from two (2) qualified contractors for animal control services for the 2021 and 2022 calendar years; and

**WHEREAS**, only one (1) quote was received from Animal Control Solutions, LLC, 2 Marshall Drive, Flemington, NJ 08822; and

**WHEREAS**, upon the recommendation of the Borough Administrator, the Mayor and Borough Council wish to authorize the award of contract to Animal Control Solutions, LLC, 2 Marshall Drive, Flemington, NJ 08822 for animal control services effective January 1, 2021 through December 31, 2022; and

**WHEREAS,** the Chief Financial Officer has certified that the maximum dollar amount of the contract per year shall not exceed \$10,000.00 and that funds are currently available for the purpose of awarding the contract to Animal Control Solutions, LLC from trust fund account #T-20-56-501-010.

**BE IT RESOLVED,** by the Council of the Borough of Chatham that the Mayor is hereby authorized to execute a contract with Animal Control Solutions, LLC for animal control services in accordance with the terms and conditions set forth in the proposal; and

# RESOLUTION AWARDING A CONTRACT TO AMERICAN ALARM SYSTEMS, INC. FOR THE MAINTENANCE OF FIRE DETECTION EQUIPMENT AND SYSTEMS AND MONITORING OF SYSTEM SIGNALS

**WHEREAS,** the Borough of Chatham is required to comply with the Uniform Fire Code as promulgated by the New Jersey Uniform Fire Safety Act to ensure the proper monitoring and inspection of Borough Hall, the Firehouse, and the Department of Public Works; and

WHEREAS, Tony Torello, Director of the Department of Public Works, has reviewed the proposal submitted by American Alarm Systems, Inc. for the maintenance of fire detection equipment and systems and monitoring of system signals (the "Agreement") and has confirmed that it meets all requirements as set forth by the New Jersey Uniform Fire Safety Act; and

**WHEREAS**, the Borough Administrator and the Director of Public Works recommends that a contract be awarded to American Alarm Systems, Inc. for one-year period, effective January 1, 2021 to December 31, 2021, in the amount not to exceed \$9,150.00; and

**WHEREAS**, the Chief Financial Officer, has certified that sufficient funds are available in Current Fund Account #0-01-26-310-240 for the award of this contract, and that this certification is contingent upon, and will be subject to, appropriations in the 2021 Municipal Budget.

**BE IT RESOLVED,** by the Council of the Borough of Chatham that it concurs with the recommendation of the Borough Administrator and the Director of Public Works and hereby authorizes the Mayor to execute the renewal Agreement with American Alarm Systems, Inc., effective January 1, 2021 to December 31, 2021.
