RESOLUTION ACKNOWLEDGING THE MONTH OF NOVEMBER AS FAMILY COURT AWARENESS MONTH

WHEREAS, the mission at One Mom's Battle (OMB) and the Family Court Awareness Month Committee (FCAMC) is to increase awareness on the importance of a family court system that prioritizes child safety and acts in the best interest of children; and

WHEREAS, the mission at the FCAMC is to increase awareness of the importance of education and training on domestic violence, childhood trauma and post separation abuse for all professionals working within the family court system; and

WHEREAS, the mission at the FCAMC is to educate judges and other family court professionals on the empirical data and research that is currently available. Such research is a critical component to making decisions that are truly in the best interest of children. This research includes The Adverse Childhood Experiences (ACE) Study (CDC-Kaiser Permanente), Saunder's Study (Us Department of Justice), The Meier Study: Child Custody Outcomes in Cases Involving Abuse Allegations, and the Santa Clara Law Study (Confronting the Challenge of High-Conflict Personality in Family Court); and

WHEREAS, the mission at the FCAMC is fueled by the desire for awareness and change in the family court system while honoring the 100(+) children in the United States who have been murdered by a parent after a custody court rejected the other parent's plea for protection (Source: Center for Judicial Excellence).

RESOLUTION OBSERVING THE FESTIVAL OF DIWALI ON NOVEMBER 4, 2021 IN THE BOROUGH OF CHATHAM

- **WHEREAS**, the Hindu American Foundation and over one billion celebrants worldwide reverently observe the festival of Diwali, the "Festival of Lights" symbolizing the victory of dharma, and good over evil; and
- **WHEREAS**, Diwali is one of the most celebrated festivals of great significance to Hindus, Sikhs, Jains, and Buddhists; and
- WHEREAS, Diwali falls on Thursday, November 4, 2021, this year in accordance with the lunar calendar, and brings together families, friends, and communities here in the United States and around the globe in goodwill, peace, and a shared sense of renewal; and
- **WHEREAS**, the U.S. Congress officially passed unanimous resolutions since 2007 recognizing the religious and historical significance of Diwali; and
- **WHEREAS**, celebrants renew their commitment to upholding values of truth, non-harming, and restraint through their thoughts, words, and actions; and
- **WHEREAS**, Diwali is a time for dana (charitable giving) and seva (selfless service) by bringing light in the form of wisdom, knowledge, nourishment, and shelter in order to alleviate the tangible forms of suffering, such as hunger, disease, and poverty; and
- **WHEREAS**, the shared Indian holiday of Diwali signifies a special time of peace and serenity with the hope of building bridges of understanding and tearing down barriers of intolerance; and
- **WHEREAS**, Diwali is celebrated by many Hindus as a day of thanksgiving for the homecoming of Lord Rama and the beginning of the new year for many Hindus; and
- **WHEREAS**, Diwali is a festival of lights during which celebrants light diyas, small oil lamps, place them around the home, and pray for knowledge, peace, and universal well-being; and
- **WHEREAS**, for Sikhs, Diwali is celebrated as the day that the sixth founding Sikh Guru, or revered teacher, Guru Hargobind, was released from captivity by the Mughal Emperor Jahangir; and
- **WHEREAS**, for Jains, Diwali marks the anniversary of the attainment of moksha, or liberation, by Mahavira, the last of the Tirthankaras (the great teachers of Jain dharma), at the end of his life in 527 B.C.; and
- **WHEREAS**, for Buddhists, especially Newar Buddhists, Diwali is commemorated as Ashok Vijayadashami, the day the great Emperor Ashoka embraced Buddhism as his faith.

DISCUSSION ITEMS

Best Practices Inventory By: Karen Fornaro, CFO

Mrs. Fornaro reviewed the Chatham Borough 2021 Best Practices Inventory. She explained how the state scores municipalities during the survey process and announced that the Borough of Chatham scored 20.5 points out of 23 total points.

The Borough received a reduction in points on the following:

- 1. Failure for a legal counsel to review boilerplate language for bid documents;
- 2. Not having public charging stations for electric vehicles in the Borough; and
- 3. Repeat audit findings.

The Borough scored well on its Best Practices Inventory and will not have any interruptions in receiving state aid. However, municipalities that score less than 15 points risk losing state aid.

Mayor Kobylarz read a few questions from the survey to give the public better perspective of the types of questions asked.

MAYOR'S REPORT I:

Mayor Kobylarz delivered a portion of his Mayor's Report as follows:

Statistical Update on the Coronavirus:

Mayor Kobylarz reported that 660 residents of the Borough have contracted COVID-19 since the start of the pandemic. There were fifteen (15) reported new cases in the last two weeks, and 38 reported infections in the month of October. The Borough's Health Officer, Megan Avallone, reported that the Borough remains an area of "moderate risk". Morris County and the State of New Jersey are also categorized as "moderate risk", with the exceptions of Middlesex County, Monmouth County, and Ocean County.

The state of New Jersey's current 7-day rolling average was reduced from 1,161 to 1,058 confirmed positive cases. Despite the gradual improvements in the transmission of the virus, the current 7-day rolling average is significant compared to the July 12, 2021, Mayor's Report, where the 7-day rolling average was 260. The statewide transmission rate has increased to 1.02.

According to public health officials, the high degree of the contagious Delta variant is fueling a resurgence of new cases in New Jersey as of July 2021. The number of cases is expected to increase as the weather cools and people begin to return to indoor social activities. The state anticipates a plateau effect or an increase in cases due to the upcoming Thanksgiving Holiday.

To mitigate the spread of the virus and breakthrough cases, the public was advised to take sensible precautions, wear a mask when indoors, avoid large gatherings, and limit travel via public transportation until the pandemic improves significantly or come to its demise.

Pediatric Vaccination:

On Friday, November 5, 2021, the Lafayette School hosted its first free pediatric COVID-19 clinic in which 150 Pfizer vaccines were administered to children 5 to 11 years of age. The Chatham Health Department will continue to offer more pediatric vaccination clinics through the end of the year. Additional information will be announced in the coming weeks.

Hearing of citizens during the Public Comment section of the Agenda is an opportunity for any member of the public to be heard about issues which are/are not topics scheduled for Public Hearing tonight. To help facilitate an orderly meeting, and to permit all to be heard, speakers are asked to limit their comments to a reasonable length of time.

Frances Drew - 32 Inwood Road

Mrs. Drew explained the cause of the continuous traffic congestion in the Borough. Chatham Borough provides the only entrance and exit to Route 24 within a certain radius. She requested that Madison Mayor Conley permit an entrance from one of its five bridges onto Route 24, to filter traffic congestion.

Mrs. Drew further stated that she provided the Mayor and Council a resolution to save the Glimmer Glass Bridge in Manasquan, Monmouth County. The bridge is listed on the National Register of Historic Places and the New Jersey Register of Historic Places. It is the only bridge of its kind in the world today. She asked the Borough to write a resolution to preserve and protect the bridge.

Council Member Resto added that New Jersey Preservation categorized the bridge as endangered. He stated that the bridge is a historic treasure worth saving. However, due to its infrastructure, Monmouth County is seeking to demolish the existing structure in place of a wider bridge.

Valerie Clark – 21 Fern Avenue

The Planning Board met on August 18, 2021 and heard the investigation report for areas in need of redevelopment. The Board voted affirmatively to accept the report for areas in need of redevelopment, although it did not qualify Block 136 Lots 1-4. However, a comment was made by the redevelopment planner and the redevelopment attorney to include Block 136 Lots 1-4 to make the redevelopment more effective. She voiced feeling perplexed by the decision. The areas consist either of green space or hightension wires, and, therefore, does not seem efficient nor effective to include in the redevelopment plan. She further stated that some lots on the east side of River Road qualify for redevelopment due to poorly placed downspouts.

Bill Heap – 108 Hillside Avenue

He commented that he admired the enthusiasm and effort of mothers working towards rebuilding a new skatepark. Anecdotally, he stated that skateboarding as a sport has decreased in popularity. The scarcity of lighting at the area may attract more crowds. With respect to financing, the Borough may not have sufficient revenue to facilitate funding the project.

Seeing no one else wishing to be heard, Mayor Kobylarz closed the meeting to the public.

Mayor Kobylarz stated that he shares Mrs. Drew frustration with respect to traffic conditions in the Borough. He reminded her of the meeting she attended with Mayor Conley to discuss this matter. The Borough has been lobbying the NJDOT aggressively to address this issue, but with little progress. Council Member Resto mentioned his suggestion to the NJDOT for a fly-over ramp onto JFK Parkway to shunt traffic to Columbia Turnpike which moves at the speed limit during peak hours.

The delineation of certain blocks and lots on River Road as "Areas in Need of Redevelopment" is a protective, defensive measure to preserve the historic, traditional character of the designated area. The Borough does not intend to promote additional residential units. The aim is to maintain the status quo but make it better.

WHEREAS, the Local Redevelopment and Housing Law, N.J.S.A. 40A:12A-1, et seq. (the "Redevelopment Law") empowers local governments to promote the advancement of the community's interest through programs of redevelopment for the expansion and improvement of commercial, industrial, residential, and civic facilities; and

WHEREAS, the Redevelopment Law empowers the Chatham Borough Mayor and Council to delineate an area or areas within the Borough as an area in need of redevelopment if the area qualifies under the criteria enumerated under N.J.S.A. 40A:12-3 and N.J.SA. 40A:12A-5; and

WHEREAS, through the direction of the Mayor and Council by Resolution # 20-214, the Planning Board was directed to conduct an investigation to determine whether the following areas qualify as areas in need of redevelopment under the criteria set forth in the Redevelopment Law:

WHEREAS, Professional Planners Francis Reiner and Daniel Hauben of DMR Architects were directed by the Chatham Borough Planning Board to conduct an investigation of certain areas in the Borough of Chatham, (the Study Area) as qualified areas in need of redevelopment pursuant to the Redevelopment Law; and

WHEREAS, DMR Architects conducted such investigations and prepared a report entitled "Preliminary Investigation for Determination of an Area in Need of Redevelopment and Rehabilitation" (the "Report"); and

WHEREAS, the Report concludes that the River Road Study Areas exhibits conditions which conform with various redevelopment criteria under Sections 3 and 5 of the Redevelopment Law as specially set forth in the Report; and

WHEREAS, on August 18, 2021, the Planning Board conducted a duly noticed public hearing, pursuant to N.J.S.A. 40A:12A-6, at which time it heard a presentation of the Report prepared by Francis Reiner and Daniel Hauben, as well as comments from members of the public in attendance; and

WHEREAS, based upon the Report, the testimony concerning the Redevelopment Investigation Report by Mr. Reiner and Mr. Hauben, and the comments made by the public on August 18, 2021, the Planning Board concluded that the following Blocks and Lots in the "Study Area" meet the criteria to be designated as an area in need of redevelopment (non-condemnation) under the Redevelopment Law, and recommend by Resolution adopted August 18, 2021 that the Mayor and Council designate the following areas as shown in the Report, as an area in need of redevelopment (non-condemnation), pursuant to the Redevelopment Law:

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Borough Council of the Borough of Chatham, County of Morris, State of New Jersey, as follows:

- 1. Based upon the facts reported in the Report and the recommendation of the Planning Board, the Mayor and Council accepts the conclusion of the Report and the Planning Board's recommendation and wish to designate the Study Area, as referenced above, as an area in need of redevelopment (non-condemnation) to promote an overall development of the Study Area in accordance with the requirements of N.J.S.A. 40A:12A-8.
- 2. The Mayor and Council hereby delineate the Study Area and all the properties therein as an area in need of redevelopment (non-condemnation), in which such delineation allows the Mayor and Council to adopt a redevelopment plan for the redevelopment area, enter into a redevelopment agreement with the developer, and adopt an ordinance pursuant to N.J.S.A. 40A:12A-7, 8, and 9.
- 3. A copy of this Resolution shall be submitted to the Commission of the Department of Community Affairs in accordance with the Redevelopment Law.
- 4. All Borough officials and employees are hereby authorized and directed to take all action necessary and appropriate to effectuate the terms of this Resolution.

REPORTS

COUNCIL MEMBERS

Council President Dempsey – Council President Dempsey reported that a member of the Board of Education for the township has resigned effective immediately. The Board is now taking applications to appoint someone to fill the seat.

The pediatric vaccination clinic at Lafayette School was a success. The school district was very pleased with the turnout and how well the vaccination clinic was conducted. Health Officer, Megan Avallone, was acknowledged and thanked for her work.

The final Joint Recreation Advisory Committee will meet tomorrow, November 9, 2021.

Council Member Mathiasen – Council Member Mathiasen reported that she attended the Bluegrass band Mile Twelve concert at the newly refurbished Stanley Center, formerly Stanley Congregational Church, on Sunday, October 31, 2021. The event was well-attended. The concert was the first public event held since the building was donated to the Borough. The Department of Public Works was recognized for cleaning and restoring the property before and after the event. More research and outreach are underway on how best to utilize the building. Members of the Governing Body will meet with various groups, including the library, to discuss other ways to utilize the building. A survey for residents is 90% complete.

Council Member Koronkiewicz – Council Member Koronkiewicz reported that the Shade Tree Commission has been planting 50 trees around the community to increase the tree canopy throughout the Borough.

Council Member Treloar – Council Member Treloar reported that she attended the pediatric vaccination clinic at the Lafayette School and was impressed by the turnout. She attended with her two children, ages 6 and 11. The event was very successful and convenient. She thanked the School District and the Department of Health for organizing the event.

The Mayor's Wellness Committee invites the public to attend a luncheon at the Madison YMCA on November 19, 2021, from 11:30 a.m. to 1:00 p.m. The purpose of the luncheon is to educate the public on advance care planning and its significance.

Council Member Resto – Council Member Resto reported on behalf of the Undergrounding Advisory Committee. The committee has not met, but he wants to schedule a meeting in December to assess where the committee stands.

The Senior Citizen Advisory Committee will meet virtually on November 18, 2021.

The Economic Development Advisory Committee (EDAC) will meet on November 18, 2021. The committee will discuss its mission going forward now that the pandemic appears to be improving. The committee's focus is to continue to help businesses stay in business and facilitate in their growth and success.

The Chatham Health Department in Westfield is offering booster shots to senior citizens. To ensure convenience, someone will visit the homes of each senior citizen to administer the booster shot. He asked any senior resident who is homebound to make themselves known so the Health Department can get them placed on the waiting list.

Council Member Resto informed the public that there is no shame in attending the weekly Food Distribution. The Food Distribution completed its 78th week last week. On average, there are 30 to 45 vehicles that visit the Food Distribution each week. A box of produce contains fresh fruit, vegetables, a

gallon of milk, and a dozen eggs. Fleur de Sel has also been providing milk and butter. Panera has been providing bread. Each box costs \$40. The public can order a box of food for donation by visiting the Chatham United Methodist Church website. There has been an increase in senior citizens visiting the Food Distribution. Additionally, there are people without vehicles who walk to the center with carts for assistance. The Food Distribution is funded by donations and will continue to be available so long as the public continues to assist financially. For this coming Thanksgiving, the public was asked to provide donations, if possible. The Food Distribution will collect food donations this Saturday, added Council President Dempsey.

Council Member Truilo – Council Member Truilo reported that the Historic Preservation Commission (HPC) awarded its Flag Award to the Perry family, for their beautiful 1800 home, located at 120 Washington Avenue. This has been the first Flag Award issued in several years. He encouraged residents to nominate any residential or commercial property that has been restored by visiting the Commission's website. Any nominations will be considered for the Flag Award in 2022 by the Historic Preservation Commission.

MAYOR 'S REPORT II

Mayor Kobylarz congratulated Council President Dempsey and Council Member Mathiasen on their reelection.

ADMINISTRATOR'S REPORT

Borough Administrator Stephen Williams reported on the following:

The Borough is working on hosting its second COVID-19 pediatric clinic. Residents may also make an appointment at CVS and Walgreens Pharmacy. The Cherry Creek School District in the City of Summit will host several vaccine clinics for families who choose to vaccinate their children, ages 5-11.

Sustainable Jersey has notified the Borough of its silver-level certification. The award will be issued at the League of Municipalities Convention next week. Janice Piccolo and Margie Lowe of Community Services were acknowledged and thanked for their efforts in working with the Green Team, chaired by Dr. Rozella Clyde, and the Environmental Commission on maintaining the Borough's silver-level certification.

PSE&G continues to work on high tension wires. The crew began drilling through bedrock this afternoon. The drilling has caused some vibration, which many residents found to be concerning. Vibration monitoring equipment is on-site during the drilling process. The vibration monitoring equipment did not detect any concerning levels of vibration caused by drilling. PSE&G will limit its drilling until tomorrow morning. PSE&G encourages residents to call its hot line to report any issues or concerns.

The New Jersey Department of Transportation (NJDOT) upgraded and resynchronized the traffic light left turn arrows on Passaic Avenue and Lafayette Avenue. The length of time to cross was increased from 7 seconds to between 12 and 15 seconds, at each intersection.

There have been manufacturing delays of large greens bags. Large supplies of bags in all sizes should be available by early next week. Residents may also obtain green bags from ShopRite and Dreyer's Lumber and Hardware.

Council President Dempsey and Mr. Williams informed residents not to rake leaves into the street to avoid clogging the sewer system. Leaves should be placed on the curb line on the right-of-way. The DPW collects leaves once a week.
