REGULAR MEETING OF THE MAYOR AND BOROUGH COUNCIL

March 8, 2021 MINUTES

Mayor Thaddeus J. Kobylarz called the March 8, 2021 virtual Regular Meeting of the Borough of Chatham to order on Monday, March 8, 2021 at 6:02 p.m. in the Council Chambers in Borough Hall, 54 Fairmount Avenue, Chatham, New Jersey.

SALUTE TO FLAG

Mayor Kobylarz and the Borough Council led the assembled in the Pledge of Allegiance.

Mayor Kobylarz asked for a moment of silence for those who have given their lives for our country. He also gave recognition to those protecting our lives during the current health pandemic caused by coronavirus, COVID-19. He acknowledged the 29 million Americans who contracted COVID-19, and the more than 525,000 people who have died from the disease. He further acknowledged the ten (10) Chatham Borough residents who died since the pandemic. Lastly, he acknowledged the loss of a lifelong resident of Chatham Borough and a volunteer member of the Chatham Fire Department, Bill "Tut" Weichert.

WHEREAS, in New Jersey, the American Red Cross New Jersey Region has a long history of helping our neighbors in need and last year the organization responded to 902 local disasters; and

WHEREAS, each year the American Red Cross New Jersey Region also provides, on average, 5,100 military family case services and collects an average of 95,000 units of blood from our generous blood donors; and

WHEREAS, the month of March is American Red Cross Month, a special time to recognize and thank the Red Cross volunteers and donors who give of their time and resources to help others in need in our communities. The Red Cross depends on local volunteers to deliver help and hope during a disaster and to assist their neighbors when they need a helping hand.

WHEREAS, despite the advancement women have made in the United States, much remains to be done to achieve true equality and respect for the ones who have carried, labored, birthed and raised humanity into its existence, to be future leaders of this phenomenal nation; working laboriously, sacrificing themselves, while loving unconditionally; and

WHEREAS, women are beautiful, strong, smart, amazing in their own right, and powerful in ways they could never imagine; and

WHEREAS, Nancy Pelosi once said "Women are leaders everywhere you look, from the CEO who runs a Fortune 500 company to the housewife who raises her children and heads her household. Our country was built on strong women, and we will continue to break down walls and defy stereotypes;" and

WHEREAS, Maya Angelou states, "I am a woman/Phenomenally/Phenomenal woman/ That's me."

NOW THEREFORE, BE IT RESOLVED, by the Mayor and Council of the Borough of Chatham, in support of all women in every aspect, declares the month of March to be National Women's Month.

RESOLUTION #21-128

RESOLUTION ACKNOWLEDGING THE THIRD WEEK OF MARCH AS NATIONAL POISON PREVENTION WEEK

WHEREAS, Congress designated the third full week in March to be National Poison Prevention Week (NPPW) in 1961 and, since then, this week has helped to raise national awareness of the dangers of potentially dangerous medicines, household products and chemicals, environmental contaminants, and other substances; and

WHEREAS, poison centers across the country will focus the public's attention on the free, lifesaving services provided by poison centers, as well as, educating the public on ways to prevent poisoning exposures; and

WHEREAS, the New Jersey Poison Control Center, a division of the Department of Emergency Medicine at Rutgers New Jersey Medical School provides 24/7 expert poisoning treatment advice, drug information, and prevention education at no cost to the public accessing center services through the Poison Help number at 1-800-222-1222, chat (www.nipies.org), or text 973-339-0712; and

WHEREAS, specialized medical professionals (doctors, pharmacists, and nurses) provide accessible, free, and confidential healthcare to all; and

WHEREAS, poison center services save healthcare dollars by eliminating thousands of unnecessary emergency department/room visits and decreasing the lengths of stays for patients hospitalized for poisoning through telemedicine services/capabilities; and

WHEREAS, the poison center is instrumental in the surveillance and management of poisoning exposures across the state, including the use, misuse, and abuse of medications, legal and illicit drugs, environmental contaminants, bioterrorism agents, and common household products and chemicals; and

WHEREAS, the state's poison control center is involved in New Jersey's efforts in homeland defense, counterterrorism, emergency preparedness and response, and biosurveillance; and

WHEREAS, unintentional poisoning is the leading cause of unintentional injury and death in New Jersey outnumbering deaths by motor vehicles and firearms; and

WHEREAS, a poison is defined as anything that can cause harm if taken in the wrong amount, in the wrong way, or by the wrong person; and

WHEREAS, although most reported poison exposures involve children five (5) years old and younger; most poisoning deaths occur in adults aged 20 to 59; and

WHEREAS, overdose deaths from prescription opioids, over-the-counter medications, and illegal drugs remain at epidemic proportions for both New Jersey and the United States; and

WHEREAS, lead exposure and carbon monoxide (CO) poisoning remains major public health concerns; and

WHEREAS, vaping and e-cigarette devices pose a serious risk of nicotine poisoning, as well as serious potentially deadly vaping associated lung illnesses, also referred to as EVALI; and

WHEREAS, poison center experts encourage the public not to guess, wait for symptoms, or waste time looking up medical information online when potential poisoning exposures occur; and

WHEREAS, all residents should save the Poison Control Center's number, 1-800-222-1222, in their cell, home, and office phones because a fast response can make all the difference in preventing serious injury and saving lives.

BE IT RESOLVED, that the Mayor and Council of the Borough of Chatham do hereby proclaim the week of March 21-27, 2021 as National Poison Prevention Week in Chatham Borough and encourage all citizens to pledge their commitment to ensuring the safety of themselves, their families, and their community.

DISCUSSION ITEMS

Granicus

Council Member Mathiasen presented on Granicus. Granicus is a meeting management system and is one of the leading management software companies in the country. It provides services to many municipalities, utility boards, and private entities. Granicus was implemented to provide greater transparency to Borough residents. She demonstrated the interesting features the video aspect provides and answered questions from the Governing Body.

Chatham Community Food Distribution Update

Council Member Resto and Council President Dempsey provided an update on the food distribution program in Chatham Borough. Chatham United Methodist Church created a "Pop-Up" pantry with non-perishable items available 24/7 at the beginning of the coronavirus pandemic. The Chatham Community Food Distribution was shortly created thereafter to accommodate the increasing need of residents. The distribution is held every Wednesday from 3:00 p.m. to 4:00 p.m. at the Chatham United Methodist Church. Residents are provided fresh produce, milk, eggs, bread, shelf-stable lunches, and other necessities. The relief has been organized by many volunteers, including Boxcar, through which donations of milk and eggs may be made. Donations from vendors like Panera Bread and Chatham Bagel have been a great help.

There has been an increase of people in need since December 2020 due to the delay in unemployment benefits and the loss of jobs in the past year. The Chatham Food Distribution program assisted during Thanksgiving and Christmas of 2020, by providing families with turkeys, hams, and candy canes. During the week of Valentine's Day, each vehicle that came to the food distribution line also received flowers from Sunnywoods Florist. Shop Small for a Big Impact was established to assist both residents and businesses within the Borough by purchasing gift cards from local businesses and giving them to those in need.

Any donation of household goods, hair products, non-perishable foods, and baby products are appreciated. Donations in goods can be dropped off at the Chatham United Methodist Church. Cash or check donations are also accepted. Residents can log onto boxcarapp.com/Chatham-donations to donate.

Mayor's Wellness Advisory Committee

Brian George, Chair of the Mayor's Wellness Committee of the Chathams presented on the Mayor's Wellness Campaign for 2021. The campaign is a statewide health initiative to encourage and improve overall health and wellness in the community. In the Chathams, the Mayor's Wellness Advisory Committee started in 2010 and established numerous initiatives such as a fitness contest and blood pressure tests among other initiatives to motivate good health and wellness in the community.

This year's initiative is to promote a dialogue between adults and children concerning advanced care planning and end of life care. National Healthcare Decision Day is recognized on April 16, 2021. A webinar will be held to provide information on how to handle the discussions and how to manage lifelong care.

MAYOR'S REPORT I:

Statistical Update on the Coronavirus:

Mayor Kobylarz reported that 419 residents of the Borough contracted COVID-19 since the start of the pandemic. Last week the Borough had seventeen (17) new cases. The daily infection rate has plateaued, but the fluctuation has been considerable. New Jersey is trending in a gradual downslope direction, with the current 7-day rolling average of 2,717 positive cases. Last week, it was 2,830. The transmission rate is 1.06 which is concerning. Health Officer Megan Avallone explained that the number of COVID-19 cases state-wide is increasing. However, Chatham Borough's infection level is moderate.

Ms. Avallone also noted that New Jersey had the nation's highest number of new COVID-19 cases per capita, and the nation's second-highest number of deaths due to the virus. It is vital to remain vigilant. To mitigate the spread of the virus, we must adhere to the protective measures of washing hands, maintaining social distancing, wearing masks, cooperating with contact tracing, and getting vaccinated.

COVID-19 Vaccine Information Webinar

Dr. Janice Baker and Dr. Brittney Alexander, both from the Chatham Medicine Practice on Main Street will host a vaccination webinar to inform residents on how to register for a vaccine, the different types of vaccines available, contact tracing, side effects, and local plans to distribute the vaccine. For more information, residents were encouraged to register for the webinar (scheduled on March 9, 2021 at 7:00 pm) via zoom or by calling 908-789-4070.

Recreation Survey

The Recreation Department has created and posted a survey pertaining to the recreation facilities in Chatham Borough and how they are currently being utilized. The survey will be available on the Borough's website and Facebook. Residents were asked to participate and to provide their input on improvements needed in the Borough.

The passing of Bill "Tut" Weichert

The Mayor announced the sudden loss of Chatham Borough resident Billy "Tut" Weichert, a lifelong resident of the Borough, and an active member of the Chatham Borough Fire Department since December 1989. He was the Hook and Ladder Company Captain as well as the Chairman of the Venison Dinner. He also served on the Fishing Derby Committee for many years. He was known for his can-do attitude, and charitable nature of helping those in need. Professionally, Tut was the owner of Chatham Main Contractors. He leaves behind his beloved wife Mary Weichert and three children. Billy "Tut" Weichert will be missed by everyone!

Mr. Weber inquired about the resolution to increase the solid waste fees and the dollar amount of the increase. He also asked if the Borough would risk a second increase once the new contract is negotiated.

Chief Financial Officer, Karen Fornaro and Council Member Mathiasen informed Mr. Weber that the fee increase is necessary to ensure that the Borough has the financial ability to afford the cost for solid waste under the current contract terms and conditions. As for a second increase, that information is premature until the new contract is complete, and all the options currently available for the Borough are considered.

Dr. Rozella Clyde- 33 Carmine St.:

Sustainable Green Team is in need of new volunteers. Residents interested in volunteering their services should submit a volunteer application. As a result of COVID-19, and the change in season, the Sustainable Green Team events will begin in April.

Which Ordinance was introduced and passed on first reading at a regular Council meeting held on February 22, 2021.

Mayor Kobylarz asked the Borough Clerk to give a summary of the legal notice.

The Borough Clerk stated that legal notices were submitted via regular mail and certified mail to all entities in accordance with N.J.S.A. 40:55D-15 and also published indicating that Ordinance # 21-05 was introduced and passed on first reading at the February 22, 2021 meeting and indicated the second reading and public hearing would be held at 6:00 p.m. on March 8, 2021 for consideration of final adoption. Copies of this Ordinance were made available to the general public and posted in accordance with the law.

Mayor Kobylarz proceeded to the reports from the Borough Council Members.

REPORTS

COUNCIL MEMBERS

Council President Dempsey – Council President Dempsey reported that the Board of Education welcomed its newest member, Chris Delsandro, who replaced Michael Valente.

The School District of the Chathams is currently working on creating the framework to educate children during the pandemic focusing on middle school and high school in-person learning. As

per Dr. Michael LaSusa, the district hopes to increase in-person learning by the end of the year.

Council Member Mathiasen created a survey for residents pertaining to the recreational facilities in the Borough. The goal is to receive feedback on what residents would like to see and improved upon in the community. The survey is now available on the Borough's website and Facebook.

Council President Dempsey reported that the Mayor and Council will have virtual office meetings for residents. The schedule for each Council Member and the Mayor is available on the Borough's website and Facebook.

Council Member Mathiasen – Council Member Mathiasen reported on the Environmental Commission. The Commission is working on an ordinance to ensure Borough residents residing in apartment buildings have access to electric vehicle charging stations. The Commission will present the ordinance at an upcoming Council Meeting.

Composting events will be held to educate residents. The events will be held in conjunction with Chatham Township, Madison Borough and Morris Township. The date of the events are: April 16th and March 22nd, with additional dates to follow.

The multi-town yard sale will be held on April 17, 2021. The application fee of \$ 3.00 to participate in the event will be waived.

Council Member Treloar – Council Member Treloar had nothing new to report.

Council Member Koronkiewicz – Council Member Koronkiewicz reported on the Shade Tree Commission. She stated the Commission received 177 application requests last year to remove trees and the Department of Public Works assisted in planting new trees around the Borough. She reminded residents that a permit is required for the removal of trees.

Council Member Resto – Council Member Resto reported that the Board of Health will meet on Thursday, March 11, 2021 at 4:30 pm.

The Economic Development Advisory Committee will host a webinar to inform business owners on how to apply for federal/state assistance, the latest round of PPE loans, and other programs available.

Council Member Resto is working with Michelle Lease on posting historic images of the downtown businesses in celebration of Founder's Month in March.
