REPORTS

- 1. Nursing Report: Public Health Nurse Bridget Colendenski, RN Discussion on church attendance, upcoming holiday visits to churches and protocols for contact tracing. Bridget has been speaking to the schools and school nurses daily along with Megan.
- 2. R.E.H.S. Report: Beau Preston, REHS said a restaurant with previous issue had rectified and is now in compliance. There was a noise complaint regarding a dumpster behind a store which he was able to confirm and discussed with store personnel the issue. He had nothing further to report.
- 3. Financial Reports reviewed
- 4. Vital Statistics Report reviewed
- 5. Animal Control Report Animal bite on dog owner was reviewed and discussed.
- 6. Pest Control Report none
- 7. Health Officer Monthly Update: Health Officer, Megan Avallone read her report.
 - Chatham CVS will be administering vaccines; 19,000 vaccines have been shipped to CVS throughout the state.
 - The state is no longer considered in the high range, however Morris County is still in that category.
 - Bad weather may be keeping people from getting tested recently but there was a significant increase in December and January, approximately 70%.
 - Half of those interviewed do not know how they contracted it.
 - When the vaccine is more readily available, the Johnson & Johnson vaccine will be easier to administer to homebound residents as the temperature during transportwill be easier to maintain.
 - A Zoom call in conjunction with the Library was introduced, also including the Township's Health Officer Michael Fitzpatrick in the vaccine information discussion.

DISCUSSION ITEM(S)

- 1. Coronavirus update: Increase in CB resident infection; middle age group had highest number of infections. Options were discussed for effective messaging to this group.
- 2. Flu activity update: Lower flu infection most likely due to coronavirus precautions being implemented

- 3. Vaccine Information: Assisting Seniors in their registration process and working with the Senior Center to help register if needed. Accessibility will increase as vaccine availability occurs.
- 4. Dog & Cat License Renewals, and Yearly Health Department License Renewals: New online renewals and fee ordinance which just passed with the council were reviewed. New payments are available online as well. Bob Weber presented a summary (attached) of the history and timeline for previous dog and cat licensing fees and ordinance changes.
- 5. BOH Goals & Objectives for 2021: will revisit next meeting.
