REPORTS:

- Nursing Report: *Bridget reviewed the Nursing Report including recommendations and guidelines for preschools and public schools. They also provided second boosters to the Garden Terrace Nursing Home residents.*
- R.E.H.S. Report:
 - a) A local restaurant was determined to be conditional after inspection; they had a significant mouse issue as well as not maintaining proper handwashing and cleanliness at the bar.
 - b) There was an investigation of a potential foodborne illness, which was determined to be unfounded. There was a rat complaint, a poison ivy complaint, and a new Mexican restaurant will be opening on Main Street.
 - c) A dumpster complaint has been continual, but the property owner has been compliant. Pools were approved to open, Fishawack is this weekend and the Farmer's Market vendors are approved.
- Animal Control Report – None
- Health Officer Monthly Update:
 - a) There has been a decline in infection rate: 174 reported cases for May, since June 1 we have had 13 reported so on the decline.
 - b) Pee Wee shots will be received the week of June 20; Moderna will have a vaccine 6mo to 5yrs. Pfizer will be 6mo to 4yrs with 3 shot injection.
 - c) Still providing boosters and walk in visits, and during August they will begin clinic for the Pee Wees.
 - d) The National Association of County and City Health Officials has invited Megan and their vulnerable population coordinator, Dr. Shelly to attend their conference in Atlanta in July.
 - e) The CDC asked Westfield to write up a blurb about the success of their vaccination program and some of the goals that they reached.
 - f) The Quality Healthcare Institute approached them about their collaboration with Summit Medical Group and Overlook for their child health clinic and work Chatham Family Medicine. Dr. Reedy and Megan wrote an op-ed about the pandemic response and the benefit of partnerships.

- Rabies Clinic Date – They will reach out to Murray Hill Vet in New Providence
 - November at the Firehouse is proposed (date TBD)
 - Bob Weber and others hung up 85 posters in local stores to remind the public about rabies vaccination and licensing their pets.
